Report of the Conference Committee on HB 151

The Capital Budget Bill

March 29, 2017

Mr. President,

Mr. Speaker,

Ladies and Gentlemen of the General Assembly of Maryland:

The report of the Conference Committee on HB 151 – the Maryland Consolidated Capital Bond Loan of 2017 is submitted for your review.

The House adopted 70 amendments to the original bill. The Senate adopted 44 committee amendments to the bill as amended by the House. The House rejected all of the Senate amendments and called for a Conference Committee. The Senate refused to recede and agreed to a Conference Committee. The Conference Committee worked to reconcile the differences between the House and Senate versions of the bill.

Action of the Conference Committee:

The Conference Committee recommends the authorization of \$1.065 billion in new State debt. Moreover, the Conference Committee recommends:

Conference Committee Amendment No. 1

On page 1, strike beginning with "<u>One</u>" in line 8 down through "<u>(\$1,083,138,121)</u>," in line 9, and substitute "<u>One Billion, Eighty-Nine Million, Three Hundred and Eighty-Three</u> Thousand, and One Hundred and Twenty-One Dollars (\$1,089,383,121)".

On page 2, in line 17, after "Loan;" insert: "; authorizing a certain grant recipient to be reimbursed for certain expenditures under certain circumstances; providing for the application of a certain section of this Act; restricting a certain authorization for the purpose of increasing certain funding; requiring that, notwithstanding certain provisions of law, a certain percentage of certain funds be allocated in a certain fiscal year; exempting certain allocations from Board of Public Works approval; providing that certain allocations shall be deemed approved under a certain provision of law; providing that a certain authorization be reduced by a certain amount and allocated only from certain funding defining a certain term;".

On page 3, after line 6, insert:

and in line 24, strike "\$1,083,138,121" and substitute "\$1,089,383,121".

On page 67, in line 6, strike "\$1,047,510,782" and substitute "\$1,046,265,782".

On page 78, in line 13, strike "\$993,030,199" and substitute "\$988,030,199"

On page 95, in line 11, strike "\$323,962,000" and substitute "\$335,787,000".

On page 100, in line 35, strike "\$157,813,000" and substitute "\$162,563,000". On page 103, after line 28, insert:

"SECTION 15. AND BE IT FURTHER ENACTED, That Section 14 of this Act is applicable to any law that authorizes the creation of a general obligation debt of the State and the sale of State bonds to evidence that debt that was enacted on or before the effective date of this Act.".

On page 104, in lines 2, 5, 7, and 9, strike "<u>18,138,121</u>", "15.", "16.", and "17.", respectively, and substitute "<u>24,383,121</u>", "<u>17.</u>", "<u>18.</u>", and "<u>19.</u>", respectively; and in line 10 strike "15" and "16", respectively, and substitute "<u>17</u>" And "<u>18</u>", respectively.

Conference Committee Amendment No. 2

On page 6, in line 27, strike "17,769,121" and substitute "15,014,121".

Conference Committee Amendment No. 3

On page 7, in line 23, before "in" insert "<u>including providing grants to local boards of education for federal E-rate-eligible special construction such as fiber and broadband infrastructure projects for E-rate eligible applicants"</u>; in line 24, after "Article" insert: "<u>provided that \$5,000,000 of this authorization is restricted for the purpose of increasing State funding for Baltimore County Public Schools to replace funds withheld by the Board of Public Works in fiscal 2017.</u>

Further provided that, notwithstanding § 5-302(e) of the Education Article or any other provision of law, the Interagency Committee on School Construction shall allocate 100% of the funds available for public school construction projects in fiscal 2018, including available contingency funds. The allocations made by the Interagency Committee on School Construction for fiscal 2018 shall not be subject to approval by the Board of Public Works and shall be deemed approved under § 5-301(c) of the Education Article

House Bill 151

Amendment Descriptions

Conference Committee Amendment No. 22: The Conference Committee partially de-authorized the 2016 session authorization for Public School Construction, which must be from the amount withheld from the Baltimore County Public Schools by the Board of Public Works.

Conference Committee Amendment No. 23: The Conference Committee increased a 2018 session pre-authorization for the New Student Services Support Building at Morgan State University due to the cost of construction.

Conference Committee Amendment No. 24: The Conference Committee added a 2018 session pre-authorization for the Sheppard Pratt at Elkridge project of approximately \$5.13 million.

Conference Committee Amendment No. 25: The Conference Committee added a 2019 session pre-authorization for the Sheppard Pratt at Elkridge project of approximately \$4.75 million.

Conference Committee Amendment No. 26: The Conference Committee added language amending Section 8-303 of the State Finance and Procurement Article to allow the State to reimburse grantees for expenditures incurred for an authorized project prior to the effective date of the authorization.
