(10) In your own words, please describe in detail the project's background and your need for a prior authorization.

Martin Luther King Jr. Recreational Park is over 95 acres of parkland with many facilities including various athletic fields and courts, picnic shelters, a lake, a playground, and more than 2 miles of trails. This heavily-used park is in need of safety improvements and accessibility updates in order to continue serving Montgomery County residents and the more than 30,000 people that take advantage of this resource every year. This project will provide necessary improvements such as ADA accessibility and features that promote exercise and heart health. Specifically, this project will: 1) replace existing metal bleachers on the baseball field with new, safe, ADA compliant bleachers; 2) replace the non-accessible baseball players bench areas with new ADA accessible benches; 3) modify a portion of the parking lot areas to provide ADA accessible parking spaces; 4) create accessible walkways from the parking lot to the existing trail and baseball field; and 5) install exercise equipment/stations, trail upgrades, and parking improvements at several locations along the existing loop trail around the lake. A prior authorization is needed to remove the County Executive and County Council of Montgomery

County as co-grantees.

A prior authorization is needed to remove the County Executive and County Council of Montgomery County as co-grantees.

The County Executive and the County Council of Montgomery County were added as co-grantees by the Legislation because the County is the landowner on record. However, while the County is the landowner on record, according to the 1972 Agreement between Montgomery County and the Maryland-National Capital Park and Planning Commission (M-NCPPC), "M-NCPPC has the authority to plan, develop, maintain, operate, regulate, and control all park land acquired and held in the record title ownership of the County." The County, therefore, has no interest in this grant and can be removed as a grantee. A copy of the 1972 MOU can be provided.
