**HB 1407** Chair, Appropriations Committee

### BUDGET RECONCILIATION AND FINANCING ACT OF 2019

Authorizing or altering the distribution of certain revenue; altering or repealing certain required appropriations; altering the cap for fiscal 2020 from 0.5% to 0.25% on a certain adjustment to a certain revenue estimate relating to nonwithholding income tax revenues; altering, for fiscal year 2020, a certain budgeted Medicaid Deficit Assessment; authorizing the transfer of certain funds; authorizing the use of \$2,000,000 from the Maryland Trauma Physician Services Fund for Medicaid provider reimbursements; etc.

**HOUSE BILLS INTRODUCED MARCH 1, 2019****HB 1408 Harford County Delegation**

HARFORD COUNTY – ALCOHOLIC BEVERAGES – APPLICATIONS FOR CLASS B AND CLASS BNR LICENSES

Altering application requirements for Class B hotel or restaurant beer, wine, and liquor licenses and Class BNR beer, wine, and liquor licenses in Harford County; requiring that three officers or authorized persons hold a financial interest of at least 10% of a certain corporation or limited liability company; establishing a State residency requirement for a license applicant; requiring that the individuals who apply for a license appoint a resident manager under certain circumstances; etc.

HOWARD COUNTY – SCHOOL FACILITIES SURCHARGE – RATES  
HO. CO. 03–19

Altering the amount of the school facilities surcharge in Howard County for certain types of residential construction; authorizing the County Council of Howard County to enact a local law providing for the annual alteration of the amount of the school facilities surcharge based on consideration of certain issues; prohibiting the County Council from imposing a school facilities surcharge on residential new construction that is classified as senior housing and an affordable housing unit under certain provisions of the County Code; etc.

**HB 1410 Delegate Beitzel****UPPER POTOMAC RIVER COMMISSION – PENSION PLANS**

Authorizing certain trustees or officers of the Upper Potomac River Commission to invest and reinvest certain money in their custody or control in accordance with rules or procedures established by the Commission; requiring any pension plan controlled by the Commission on or after July 1, 2019, to adhere to the principles incorporated in the Uniform Management of Public Employee Retirement Systems Act that address the investment and management of funds for a public pension system; and applying the Act prospectively.
