HB 91 Delegates Carr and Korman

PUBLIC–PRIVATE PARTNERSHIPS – PRESOLICITATION REPORTS – ENVIRONMENTAL IMPACT STATEMENT REQUIREMENT

Prohibiting a reporting agency for certain proposed public–private partnerships from submitting a certain presolicitation report before a draft environmental impact statement that complies with the National Environmental Policy Act is available; requiring the Department of Transportation and the Maryland Transportation Authority to withdraw a certain presolicitation report; prohibiting the resubmission of the report until a certain draft environmental impact statement is adopted and a certain alternative is selected; etc. EMERGENCY BILL SF, § 10A-201(a) - amended

PUBLIC SAFETY – HANDGUN PERMITS – PAYMENT OF FEES

Altering the manner in which an applicant for a handgun permit is required to pay a certain fee to allow any method of payment approved by the Secretary of State Police.

WALTER SONDHEIM JR. PUBLIC SERVICE INTERNSHIP SCHOLARSHIP PROGRAM – REPEAL OF AWARD CAP

Repealing the \$3,000 cap on the amount that will be awarded for a scholarship under the Walter Sondheim Jr. Public Service Internship Scholarship Program. EFFECTIVE JULY 1, 2019 ED, § 18-1702 - amended Assigned to: Appropriations

STATE RETIREMENT AND PENSION SYSTEM – ACCIDENTAL DISABILITY RETIREMENT APPLICATION

Authorizing the Board of Trustees for the State Retirement and Pension System to accept an application for an accidental disability retirement allowance from certain individuals within 3 years after the individuals' retirement; requiring that the accidental disability retirement allowance begin on a certain day under certain circumstances; and terminating the Act after June 30, 2020. EFFECTIVE JULY 1, 2019 Assigned to: Appropriations

PUBLIC SAFETY – FIREARMS DISQUALIFICATIONS – ANTIQUE FIREARM (SHADÉ'S LAW)

Applying certain provisions disqualifying a person from possessing a rifle or shotgun to an antique firearm. EFFECTIVE OCTOBER 1, 2019 PS, §§ 5-133.3(b) and (d) and 5-205 - amended Assigned to: Judiciary

PUBLIC SAFETY – REGULATED FIREARMS – TRANSFER

Providing that, for certain purposes, the term "transfer" includes a loan other than a temporary gratuitous exchange of a regulated firearm between two individuals who remain in the same location for the duration of the exchange. EFFECTIVE OCTOBER 1, 2019

CRIMINAL LAW – SALE OR DISPLAY OF OBSCENE ITEM TO MINOR – VIDEO IMAGE

Altering the definition of "item" as it relates to a certain prohibition against selling or displaying a certain obscene item to a minor by including a motion picture, an image, a visual representation, a video file, a video image, or a video recording.

STATE EMPLOYEE AND RETIREE HEALTH AND WELFARE BENEFITS PROGRAM – RETIREE PARTICIPATION IN THE STATE PRESCRIPTION DRUG BENEFIT PLAN

Requiring the State to continue providing a certain prescription drug benefit plan to certain retirees by repealing the January 1, 2019, termination of a certain State prescription drug benefit plan for certain retirees, spouses, and dependent children under certain circumstances; authorizing certain retirees who participate in a certain prescription drug benefit plan with a spouse or dependent child to elect to have the spouse or dependent child covered under a certain State prescription drug benefit plan; etc.

ESTATES AND TRUSTS – ELECTIVE SHARE OF SURVIVING SPOUSE

Repealing certain provisions of law relating to a surviving spouse making an election to take a certain share of the net estate of the decedent, instead of that designated under the will, to ensure the surviving spouse is reasonably provided for during the surviving spouse's lifetime; providing that a surviving spouse may take a certain elective share amount of a certain estate subject to election; establishing the priority to be used in determining the sources from which a certain elective share amount is payable; etc.

BUDGET BILL (FISCAL YEAR 2020)

Making the proposed appropriations contained in the State Budget for the fiscal year ending June 30, 2020, in accordance with Article III, Section 52 of the Maryland Constitution; etc. Assigned to: Appropriations

HB 102 Delegate Lierman, et al

TOLL ROADS, HIGHWAYS, AND BRIDGES – COUNTY GOVERNMENT CONSENT REQUIREMENT – EXPANSION

Expanding to all counties in the State a prohibition on State agencies constructing within the nine Eastern Shore counties a toll road, toll highway, or toll bridge without the consent of a majority of the affected counties; etc. EFFECTIVE OCTOBER 1, 2019 TR, § 4-407 - amended Assigned to: Environment and Transportation

LAW ENFORCEMENT OFFICERS' PENSION SYSTEM – BENEFITS

Altering the accrual rate to 2.5% for service earned on or after July 1, 2019, for calculating the retirement allowance for certain retirees of the Law Enforcement Officers' Pension System; and altering from 65% to 70% the maximum benefit that certain retirees of the Law Enforcement Officers' Pension System may receive.

INCOME TAX – SUBTRACTION MODIFICATION FOR QUALIFIED HIGHER EDUCATION EXPENSES – ANNUAL LIMITATION

Increasing, from \$2,500 to \$5,000, the maximum amount allowed in a taxable year as a subtraction modification under the Maryland income tax for advance payments of certain qualified higher education expenses made by an account holder or a contributor under a Maryland Senator Edward J. Kasemeyer Prepaid College Trust contract; and applying the Act to taxable years beginning after December 31, 2018.

MARYLAND TRANSPORTATION AUTHORITY FACILITIES – VIDEO TOLLS – COLLECTION

Prohibiting the Central Collection Unit from collecting certain unpaid video tolls and associated civil penalties incurred by a person residing outside the State, except under certain circumstances.

ENVIRONMENTAL TRUST FUND - SURCHARGE EXTENSION

Extending from June 30, 2020, to June 30, 2025, the termination date of a certain environmental surcharge on electrical energy distributed to retail electric customers in the State. EFFECTIVE JUNE 1, 2019

REAL PROPERTY – RESIDENTIAL PROPERTY FORECLOSURE PROCEDURES

Substituting the Commissioner of Financial Regulation for the Department of Labor, Licensing, and Regulation in certain provisions of law relating to the Foreclosed Property Registry.

VEHICLE LAWS – INTERSECTIONS – PROHIBITED ACTS

Prohibiting a vehicle from entering certain intersections when facing certain traffic signals if the vehicle is unable to safely and completely proceed through the intersection; establishing certain exceptions to the prohibition; prohibiting a police officer from issuing a citation for a violation of the Act unless certain conditions are met; establishing a \$90 fine for a violation of the Act; providing that a violation of the Act is not a moving violation for purposes of assessing points; etc.

ENVIRONMENT – EXPANDED POLYSTYRENE FOOD SERVICE PRODUCTS – PROHIBITION

Prohibiting a person from selling in the State a certain expanded polystyrene food service product on or after January 1, 2020; prohibiting certain food service businesses and certain schools from selling or providing food in certain expanded polystyrene food service products on or after January 1, 2020; requiring a county health department to impose penalties of up to \$250 for certain violations; requiring a county health department to notify the Department of the Environment of certain violations; providing a certain waiver; etc.

ELEMENTARY SCHOOL STUDENTS – DAILY PHYSICAL ACTIVITY (STUDENT HEALTH AND FITNESS ACT)

Requiring a public school student in elementary school to be provided a daily program of physical activity totaling 150 minutes each week to include physical education and developmentally appropriate, moderate-to-vigorous activity, including recess; requiring that the program of physical activity for a certain category of student be consistent with the student's Individualized Education Program; requiring public elementary schools to designate a physical activity leadership team to plan and coordinate certain activities; etc.

INCOME TAX CREDIT – AGENCY SHOP FEES AND UNION DUES

Allowing an individual to claim a credit against the State income tax for certain allowable union dues paid by the individual during the taxable year if the union dues would have been allowed as a deduction under the Internal Revenue Code for a taxable year beginning after December 31, 2016, but before January 1, 2018; providing for the calculation of the credit; making the credit refundable; defining "allowable union dues"; applying the Act to taxable years beginning after December 31, 2018, but before January 1, 2026; etc. EFFECTIVE JULY 1, 2019 TG, § 10-749 - added

VEHICLE LAWS – INJURY OR DEATH OF VULNERABLE INDIVIDUAL – PENALTIES

Prohibiting a person from causing the serious physical injury or death of a vulnerable individual as a result of the person operating a vehicle in a careless or distracted manner or in violation of any other rules of the road provisions of the Maryland Vehicle Law; establishing that a person convicted of a violation of the Act may be fined up to \$2,000 and must appear in court and may not prepay the fine; establishing additional penalties of participation in a motor vehicle safety course and up to 150 hours of community service; etc.

CRIMINAL LAW - GAMING - CIVIL OFFENSE

Altering the penalty for certain conduct relating to betting, wagering, or gambling; making certain conduct relating to betting, wagering, or gambling a civil offense; establishing that adjudication of a violation under a certain provision of the Act is not a criminal conviction for any purpose and does not impose any of the civil disabilities that may result from a criminal conviction; altering certain penalties; authorizing a certain police officer to issue a certain citation under certain circumstances; etc. EFFECTIVE OCTOBER 1, 2019

HB 114 Delegates Reilly and Cassilly

INCOME TAX SUBTRACTION MODIFICATION – RETIREMENT INCOME OF CORRECTIONAL SERVICES, LAW ENFORCEMENT, OR FIRE, RESCUE, OR EMERGENCY SERVICES PERSONNEL

Increasing from \$15,000 to \$30,000 the maximum amount of a subtraction modification under the State income tax of certain individuals for retirement income attributable to employment as a correctional officer, a law enforcement officer, or fire, rescue, or emergency services personnel; and applying the Act to taxable years beginning after December 31, 2018.

MARYLAND INCOME TAX REFUND – WARRANT INTERCEPT PROGRAM – TERMINATION REPEAL

Repealing the termination of a program authorizing certain warrant officers to request the Comptroller to withhold the income tax refund of certain individuals with certain outstanding warrants; etc.

PUBLIC HEALTH – CORRECTIONAL SERVICES – OPIOID USE DISORDER EXAMINATIONS AND TREATMENT

Repealing the requirement for a certain inmate to be placed on a program of methadone detoxification under certain circumstances; requiring State and local correctional facilities to conduct a certain assessment of each inmate within 24 hours of incarceration to determine whether opioid treatment or medication–assisted treatment for opioid addiction is appropriate; requiring State and local correctional facilities to provide certain treatments to inmates suffering from opioid use disorder under certain circumstances; etc. EFFECTIVE OCTOBER 1, 2019

MARYLAND SMART GROWTH INVESTMENT FUND

Authorizing the Department of Commerce to create, own, control, or be a member of a corporation, a limited liability company, a partnership, or any other entity, whether operated for profit or not for profit, for certain purposes; requiring the Department to issue a request for proposals to select a management entity to establish the Maryland Smart Growth Investment Fund; requiring the Governor to include in the annual budget bill for fiscal year 2021 an appropriation of \$7,000,000 for the Fund; etc.

This bill requires a mandated appropriation in the annual budget bill.

STUDENT DEBT RELIEF ACT OF 2019

Establishing a Maryland Promise Plus Scholarship program to provide tuition assistance to certain students attending eligible State institutions; establishing eligibility requirements to include limitations on gross income levels under certain circumstances; providing for an annual scholarship award of no more than \$10,000 per recipient; providing the scholarship be converted to a loan under certain circumstances; allowing a subtraction modification for a certain amount of interest paid on student loans; etc.
