SENATE BILL INTRODUCED January 30, 2020

SB 558 The President (By Request – Administration)

UNIVERSAL SCHOOL START ACT OF 2020

Requiring, beginning in the 2020–2021 school year, a county board of education to set the start date of the school year for schools in the county not earlier than the first Tuesday after Labor Day; authorizing a county board to grant a school a certain waiver from a certain requirement for good cause as established by the State Board of Education in regulations; requiring the State Board to adopt certain regulations; etc.

SENATE BILLS INTRODUCED January 31, 2020

FREDERICK COUNTY – SOLAR ENERGY – MUNICIPAL ELECTRIC UTILITIES

Altering to 2.5% the percentage of the renewable energy portfolio standard that must be derived from solar energy for a municipal electric utility in Frederick County.

RENEWABLE ENERGY PORTFOLIO STANDARD – ELIGIBLE SOURCES

Altering the eligibility of certain sources of energy for the creation of credits under the renewable energy portfolio standard; removing certain sources from the definition of a "Tier 1 renewable source"; providing that existing obligations or contract rights may not be impaired by the Act; and applying the Act to all renewable energy portfolio standard compliance years beginning after December 31, 2020.

DEPARTMENT OF GENERAL SERVICES – JURISDICTION AND MARYLAND CAPITOL POLICE

Altering the jurisdiction of the Department of General Services to include State—owned or State—leased buildings and grounds and extending to the surrounding area that encompasses 1,000 feet in any direction from the boundary of those buildings and grounds; altering the jurisdiction of the Maryland Capitol Police of the Department; requiring the Secretary of General Services to appoint the Chief of the Maryland Capitol Police; providing that the Chief serves at the pleasure of the Secretary; etc.

PUBLIC SCHOOLS – FLEXIBLE INSTRUCTIONAL DAYS – POLICY REQUIREMENTS

Authorizing a county board of education to apply to the State Board of Education to implement a policy for the use up to 5 flexible instructional days during the school year; defining "flexible instructional day" as one in which a public school provides remote academic instruction because a natural or civil disaster or severe weather conditions prevented schools from opening; requiring the State Board to adopt certain guidelines and a certain model policy and to approve or deny a certain application; etc.

MARYLAND POLICE TRAINING AND STANDARDS COMMISSION – USE OF HANDCUFFS – BODY ATTACHMENTS POLICY

Requiring the Maryland Police Training and Standards Commission, by October 1, 2020, to develop written policies to provide guidance to law enforcement agencies on the appropriate use of handcuffs when taking a person into custody on a body attachment; and requiring each law enforcement agency, by January 1, 2021, to adopt and implement the written policy developed by the Commission.

EDUCATION – HIGH SCHOOL GRADUATION REQUIREMENTS – STUDENTS IN FOSTER CARE OR HOMELESS YOUTH

Requiring a county board of education to waive high school graduation requirements established by the county board that are in addition to high school graduation requirements established by the State Board of Education for a student in foster care or who is a homeless youth if while in grade 11 or 12 the youth transfers into the local school system from a different system in the State or transfers between high schools in the local school system; prohibiting a county board from waiving certain requirements; etc.

POLICE OFFICERS – MENTAL HEALTH – EMPLOYEE ASSISTANCE PROGRAMS

Requiring each law enforcement agency to develop and implement an employee assistance program to protect the mental health of police officers and provide police officers access to confidential low— or no—cost mental health services; establishing certain requirements for a certain program; requiring each law enforcement agency to develop standards for annual assessments of the employee assistance program to identify deficiencies and areas for improvement; etc.

VEHICLE LAWS – REGISTRATION RENEWAL – INSPECTION REQUIREMENT

Requiring the Motor Vehicle Administration to require the submission of a valid registration renewal inspection certificate before renewing a motor vehicle registration for a vehicle at least 5 model years old; requiring an inspection to include a certain examination of certain vehicle equipment; requiring an inspection certificate to remain valid for 90 days; requiring an inspection certificate to include the name of the inspection station and mechanic; prohibiting an inspection station from charging more than \$45 for an inspection; etc.

SALES AND USE TAX – EXEMPTION – OUT–OF–STATE NONPROFIT ORGANIZATIONS

Providing an exemption from the sales and use tax for sales to out—of—state nonprofit organizations for sales made in connection with and solely for use at conferences or conventions held in the State by the nonprofit organizations, related to the mission or work of the nonprofit organizations, and attended by at least 25 individuals; and requiring a nonprofit organization to file an application for an exemption certificate with the Comptroller in order to qualify for the exemption.

WORKGROUP ON FUNDING FOR A LOW- OR NO-INTEREST MORTGAGE PROGRAM

Establishing the Workgroup on Funding for a Low- or No-Interest Mortgage Program within the Joint Committee on Ending Homelessness; providing for the composition of the Workgroup; requiring the Workgroup to explore options for providing State funding to provide low- or no-interest mortgages for families that spend not less than 30% of income on housing and that do not make more than a set amount of income, and to explore similar low- or no-interest mortgage programs in other jurisdictions; etc.

INTERCEPTED COMMUNICATIONS – PENALTIES AND ADMISSIBILITY OF EVIDENCE

Repealing certain penalties relating to the prohibition against intercepting and disclosing certain communications; providing that a certain communication that was intercepted in violation of certain provisions of law may be admissible in certain proceedings under certain circumstances; and prohibiting the admissibility of the contents of an intercepted communication or information derived from an intercepted electronic communication as evidence unless certain conditions are met.

REAL PROPERTY – NOTICE OF EASEMENTS, COVENANTS, RESTRICTIONS, AND CONDITIONS – RECORDATION

Authorizing notice of certain easements, covenants, restrictions, and conditions to be recorded in the land records of the county in which the property interest is located; specifying the information required to be provided in the notice; requiring that the notice be indexed for recording in a certain manner; and providing that failure to record a notice in accordance with the Act does not impair the rights or interests of the holder of an easement, a covenant, a restriction, or a condition.

BALTIMORE CITY – ALCOHOLIC BEVERAGES – LICENSES – HOURS OF SALE

Specifying 9 a.m. to 10 p.m. as the hours of sale for a holder of a Class B–D–7 beer, wine, and liquor license in a certain area of Baltimore City; prohibiting the hours of sale for a license holder in a certain area from beginning before or ending after certain times; and prohibiting the hours of sale from being extended under certain conditions.

EDUCATION – HOME AND HOSPITAL TEACHING PROGRAM FOR STUDENTS – REPORT

Requiring the State Department of Education to study certain matters relating to the Home and Hospital Teaching Program for Students and make recommendations regarding any statutory or regulatory changes to the program; requiring, by December 31, 2020, the Department to submit its findings and recommendations to the Governor, the State Board of Education, and the General Assembly; etc.

SALES AND USE TAX – SHORT–TERM RENTAL VEHICLES AND PEER–TO–PEER CAR SHARING – RATE ALTERATION AND SUNSET REPEAL

Repealing the termination of certain provisions of law making sales and charges related to peer—to—peer car sharing subject to a certain sales and use tax rate; requiring the Comptroller to distribute revenue from the sales and use tax imposed on peer—to—peer car sharing to the Transportation Trust Fund and to the Chesapeake and Atlantic Coastal Bays 2010 Trust Fund; altering the sales and use tax rate imposed on certain short—term vehicle rentals and shared motor vehicles used for peer—to—peer car sharing; etc.

DISTRICT COURT - JOBS COURT PILOT PROGRAM

Establishing the Jobs Court Pilot Program in the District Court to reduce recidivism by offering defendants an opportunity to participate in full—time job training and job placement programs as a condition of probation or as an alternative to incarceration; requiring the Administrative Office of the Courts to take certain actions to accomplish the purpose of the program; requiring the Administrative Office of the Courts to provide a certain report to the Governor and the General Assembly on or before June 30, 2025; etc.

This bill requires a mandated appropriation in the annual budget bill.

STATE DEPARTMENT OF EDUCATION – EARLY LITERACY AND DYSLEXIA PRACTICES – GUIDANCE AND ASSISTANCE

Requiring the State Department of Education to establish a certain stakeholder advisory group to develop a certain reading and dyslexia handbook; requiring the Department and the advisory stakeholder group to make a completed handbook available to the public by June 1, 2021, and to develop a list of recommended programs and materials that address certain needs; requiring the Department to update the handbook every 3 years; requiring the handbook and updates to be published and disseminated in a certain manner; etc.

HEALTH OCCUPATIONS – NURSE PRACTITIONERS – CERTIFICATIONS OF COMPETENCY AND INCAPACITY

Altering a requirement that a petition for guardianship of a disabled person include certain signed and verified certificates of competency by providing that the certificates may be signed and verified by a nurse practitioner and certain other health care practitioners; altering the requirements for the certification of a patient's incapacity to make an informed decision regarding treatment to allow the second individual making the certification to be a nurse practitioner, rather than a second physician; etc.

INCOME TAX – THEATRICAL PRODUCTION TAX CREDIT

Allowing certain theatrical production entities to claim a credit against the State income tax for certain costs incurred for certain theatrical productions in the State; making the credit refundable under certain circumstances; requiring an entity to apply to the Department of Commerce to be a qualified theatrical production entity; requiring that to qualify for the credit certain estimated costs incurred in the State must exceed \$100,000; applying the Act to taxable years beginning after December 31, 2019; etc.

ELECTRICITY – CONSIDERATIONS FOR CERTIFICATE OF PUBLIC CONVENIENCE AND NECESSITY AND OVERHEAD TRANSMISSION LINES

Requiring the Public Service Commission to take final action on an application for a certificate of public convenience and necessity only after due consideration certain factors including whether the applicant's design prioritizes the use or upgrading of existing infrastructure; prohibiting the construction of an overhead transmission line that is aligned with and within 1 mile of a conservation easement unless there is a certain showing of good cause; and providing for the prospective application of the Act.

CHILD SUPPORT – SHARED PHYSICAL CUSTODY

Establishing a certain formula for the calculation of a certain child support obligation under the child support guidelines when a parent with shared physical custody keeps the child or children overnight for more than 25%, at least 92 overnights, but less than 30%, not more than 109 overnights, of the year; applying the Act only to cases filed on or after October 1, 2020; etc.

Establishing the Empowering Communities to Counter Racially Motivated Violent Extremism Program Fund to provide grants to local governments to train individuals to recognize signs of racially motivated violent extremism and best practices for reporting and preventing racially motivated violent extremism; requiring the Executive Director of the Governor's Office of Crime Control and Prevention to establish certain procedures for local governments to apply for grants from the Fund; etc.

CRIMINAL PROCEDURE – FAMILY LAW SERVICES FOR SUSTAINED SAFETY FUND

Establishing the Family Law Services for Sustained Safety Fund to increase legal services in family law cases for victims in order to help ensure safety and long—term stability after victimization; requiring the Governor's Office of Crime Control and Prevention to administer the Fund; requiring each grantee from the Fund to receive training on the effects of domestic violence, sexual assault, child abuse, and elder abuse; prohibiting a grantee from requesting an individual to waive certain rights in order to receive services; etc.

This bill requires a mandated appropriation in the annual budget bill.

NATURAL RESOURCES – STATE LAKES PROTECTION AND RESTORATION PROGRAM AND FUND

Altering the purpose and authorized uses of the State Lakes Protection and Restoration Fund to include protection and restoration of State-owned and State—managed lakes by removing sediment, treating contaminated sediment, preventing invasive species, and improving ecological and recreational value; and requiring the Secretary of Natural Resources to spend at least \$3,000,000 from the Secretary's budget on the Program in fiscal year 2022 and each fiscal vear thereafter.

MARYLAND SMALL BUSINESS INNOVATION RESEARCH TECHNICAL ASSISTANCE PROGRAM – ESTABLISHMENT

Establishing the Maryland Small Business Innovation Research Technical Assistance Program in the Maryland Technology Development Corporation; providing the purpose of the Program is to provide technical assistance to small businesses in the State; requiring small businesses to meet certain qualifications for participation in the Program; requiring the Corporation, in accordance with certain provisions of law, to procure a nonprofit organization located in the State to provide services under the Program; etc.

Repealing the limit on the number of call centers that may be approved by 2–1–1 Maryland to provide certain services; repealing certain provisions of law establishing and governing the Health and Human Services Referral Board in the Maryland Department of Health; requiring the Department, rather than the Board, in consultation with 2–1–1 Maryland, as appropriate, to take certain actions related to 2–1–1 Maryland; etc.

Requiring, rather than authorizing, reasonable efforts to place a child for adoption or with a legal guardian to be made concurrently with reasonable efforts to preserve and reunify families under certain circumstances.

FOSTER PARENTS, PREADOPTIVE PARENTS, AND CAREGIVERS – RIGHT TO INTERVENE

Requiring the circuit court to provide notice to a child's foster parent, preadoptive parent, or caregiver of the right to intervene as a party in a certain proceeding except under certain circumstances; granting certain rights to certain individuals in certain proceedings; granting the right to intervene in certain proceedings and the right to obtain all nonprivileged information in documents pertaining to the placement of a child; requiring a party who asserts that information in a document is privileged is required to meet certain criteria; etc.

Providing that members of the State Police Retirement System no longer make member contributions after 28 years of service credit is earned; and providing that certain members of the Law Enforcement Officers' Pension System no longer make member contributions after 32 years and 6 months of service credit is earned.

Excluding the University System of Maryland from certain provisions of law governing protection of information by government agencies; requiring the University System of Maryland to review and designate certain systems as systems of record based on certain criteria and to develop and adopt a certain privacy governance program to govern each system of record; requiring the University to develop and adopt a certain information security and risk management program for the protection of personally identifiable information; etc.

Authorizing a person to file a petition for a partial expungement of certain criminal records under certain circumstances; requiring a court to order that certain records may not be included on the public website maintained by the Maryland Judiciary or within records submitted to the Central Repository; repealing a provision of law establishing that, if a person is not entitled to expungement of one charge or conviction in a certain unit, the person is not entitled to expungement of any other charge or conviction in the unit; etc.

PUBLIC INFORMATION ACT – REVISIONS

Requiring each official custodian to adopt a certain policy of proactive disclosure; requiring each official custodian to publish a certain annual report on a certain website, to the extent practicable; requiring the Public Information Act Compliance Board to receive, review, and resolve certain complaints from applicants and applicants' designated representatives; requiring the Board to receive and review complaints from any custodian alleging that an applicant's request or pattern of requests is frivolous or vexatious; etc.

Authorizing a person who is serving a term of confinement to petition a court to modify or reduce the sentence under certain circumstances; requiring a person to file a petition under the Act in a certain court; requiring a court to hold a hearing under certain circumstances; providing for a hearing held under the Act; requiring a State's Attorney to provide certain notice to a victim and a victim's representative under certain circumstances; etc.

STATE–FUNDED CONSTRUCTION AND MAJOR RENOVATION PROJECTS – SOLAR PANELS – REQUIREMENT

Requiring the State, for certain construction projects and major renovation projects proposed after December 31, 2020, to require that the project be designed, engineered, and constructed in a manner that allows the roof to withstand the weight of solar panels; requiring certain construction projects and major renovation projects to include the placement of the maximum number of solar panels for which the project was designed; requiring the Maryland Green Building Council to provide certain recommendations; etc.

Requiring a law enforcement officer who takes a child into custody to provide notice to the child's parents, guardian, or custodian in a manner reasonably calculated to give actual notice; specifying the required contents of a notice; prohibiting the interrogation of a child by a law enforcement officer until the child has consulted with a certain attorney and a notice has been provided to the child's parent, guardian, or custodian; requiring that a consultation between a child and an attorney under the Act be confidential; etc.

Requiring a court, in a custody or visitation proceeding, to deny custody or visitation rights to a certain party under certain circumstances, unless the court states the reasons for a finding that there is no likelihood of further child abuse or neglect by a certain party; and altering the conditions of a certain supervised visitation arrangement that a court is authorized to approve to include neutral and physically present supervision.

Opposing certain inspection rules promulgated by the U.S. Department of Agriculture that have drastically impeded the harvest and sale of blue catfish and thus rendered the State unable to adequately use the commercial harvest as a form of control over the invasive blue catfish species; urging the U.S. Congress to amend 21 U.S.C. § 601(w) to exempt the wild catch of domestic catfish from certain inspection requirements; and requiring a copy of the Resolution to be forwarded to certain elected officials.
