SENATE BILLS INTRODUCED January 15, 2020

SB 183 Senator Lam

HEALTH INSURANCE – HEALTH BENEFIT PLANS – SPECIAL ENROLLMENT PERIOD FOR PREGNANCY

Altering, to remove a requirement that a health care practitioner confirms a pregnancy and to add a requirement that the eligible employee or the employee's spouse or dependent attests to the pregnancy, the circumstances under which certain individuals who become pregnant are eligible for a certain special enrollment period; altering the date on which the special enrollment period for certain individuals who become pregnant begins; etc.

SB 184 Senator Lam, et al

UNIVERSITY OF MARYLAND, BALTIMORE – STUDY ON THE HEALTH EFFECTS OF AIR TRAFFIC NOISE

Requiring the University of Maryland, Baltimore to study the health effects of air traffic noise on communities near Baltimore/Washington International Thurgood Marshall Airport since the implementation of the Next Generation Air Transportation System; requiring the study to evaluate certain health outcomes, costs, and cost savings; requiring the Governor to provide in the 2022 budget bill an appropriation of at least \$130,000 for the purpose of carrying out study; etc.

This bill requires a mandated appropriation in the annual budget bill.

SB 185 Senator Jennings

BALTIMORE COUNTY – SALES AND USE TAX EXEMPTION – QUALIFIED OPPORTUNITY ZONES

Providing an exemption from the sales and use tax for certain construction material or warehousing equipment purchased solely for use in a qualified opportunity zone in Baltimore County under certain circumstances; requiring a buyer claiming the exemption to provide a vendor evidence of eligibility issued by the Comptroller; etc.

LIFE AND HEALTH INSURANCE GUARANTY CORPORATION ACT – REVISIONS

Revising the Life and Health Insurance Guaranty Corporation Act; altering the persons to whom and circumstances under which the Life and Health Insurance Guaranty Corporation is required to provide certain coverage; providing that the Act does not provide coverage to persons who acquire the right to receive certain payments; altering the policies and contracts issued by member insurers that may not be provided coverage under the Act; etc.

CIVIL ACTIONS – HEALTH CARE MALPRACTICE CLAIMS (LIFE CARE ACT)

Authorizing an expert witness in a certain health care malpractice claim, suit, or action to testify in the form of an opinion or otherwise under certain circumstances; requiring an expert witness testifying on a certain issue under certain circumstances in a certain health care malpractice claim, suit, or action to meet certain qualifications; etc.

SB 188 Senator Gallion, et al

PUBLIC HEALTH – MISBRANDED FOOD – MEAT PRODUCTS

Providing that a food is misbranded if it is offered for sale in the State with a label that identifies the product as a meat or a meat product and the product contains animal tissue cultured from animal cells outside the animal from which the tissue is derived or is made from plants or insects.

SB 189 Senators Gallion and Bailey

STATE BOARD OF VETERINARY MEDICAL EXAMINERS – PRACTICING VETERINARY MEDICINE WITHOUT A LICENSE – CEASE AND DESIST ORDER AND CIVIL PENALTY

Authorizing, on review and approval of the Secretary of Agriculture or the Secretary's designee, the State Board of Veterinary Medical Examiners to issue a cease and desist order and impose a certain civil penalty against a person who practices, attempts to practice, or offers to practice veterinary medicine without a license; specifying that a civil penalty imposed under the Act may not exceed \$5,000 for each violation; requiring the Board to consider certain factors in setting the amount of a civil penalty; etc.

BUDGET BILL (FISCAL YEAR 2021)

Making the proposed appropriations contained in the State Budget for the fiscal year ending June 30, 2021, in accordance with Article III, Section 52 of the Maryland Constitution; etc.

SB 191 The President (By Request – Administration)

CREATION OF A STATE DEBT – MARYLAND CONSOLIDATED CAPITAL BOND LOAN OF 2020, AND THE MARYLAND CONSOLIDATED CAPITAL BOND LOANS OF 2013, 2014, 2016, 2017, AND 2019

Authorizing the creation of a State Debt in the amount of One Billion, One Hundred and Four Million, One Hundred Fourteen Thousand Dollars (\$1,104,114,000), the proceeds to be used for certain necessary building, construction, demolition, planning, renovation, conversion, replacement, and capital equipment purchases of the State, for acquiring certain real estate in connection therewith, and for grants to certain subdivisions and other organizations for certain development and improvement purposes; etc.

SB 192 The President (By Request – Administration)

BUDGET RECONCILIATION AND FINANCING ACT OF 2020

Authorizing, altering, or requiring the distribution and payment of certain revenue in certain fiscal years; altering the requirement that the Comptroller provide notice of abandoned property in a certain manner; altering the manner in which the Governor is required to provide certain budget books; repealing and altering certain programs; increasing the amount local governments are required to reimburse the State for certain services; repealing a requirement that the State appropriate money for certain purposes; etc.

Preliminary analysis: local government mandate

This bill requires a mandated appropriation in the annual budget bill.

PUBLIC INFORMATION ACT – DENIAL OF PART OF A PUBLIC RECORD – INVESTIGATIONS BY INSPECTORS GENERAL

Authorizing a custodian to deny inspection of records of investigations conducted by or investigatory files compiled by an inspector general whose office is created by State law or the laws of a political subdivision of the State. EFFECTIVE OCTOBER 1, 2020

ANNE ARUNDEL COUNTY – LIQUOR LICENSES – TRANSFER OF LICENSE

Authorizing the Board of License Commissioners for Anne Arundel County to allow a license holder to transfer an alcoholic beverages license to other premises within the same tax assessment district as the premises for which the license was issued if the premises were substantially destroyed by fire, explosion, or catastrophe, taken by condemnation, or taken by the exercise of the power of eminent domain.

SB 195 Senators Feldman and Hershey

AUTOMOBILE INSURANCE – USAGE–BASED INSURANCE – APPLICATION AND NOTICE

Establishing that the application of a certain insurance program on vehicle operation during the current policy period is not a violation of certain restrictions on classification for private passenger motor vehicle insurance; excluding the application of certain provisions on exclusion of drivers to an insurance program that measures the operation of an insured vehicle during the current policy period; and requiring that a certain notice include certain information for a premium increase due to a certain insurance program.

ANNE ARUNDEL COUNTY - BOARD OF EDUCATION - VOTING

Requiring the affirmative vote of at least six, rather than five, members of the Anne Arundel County Board of Education for the approval of any action by the county board; etc.
