BILL:SB 329 – Public Institutions of Higher Education – Outbreak Response PlanCOMMITTEE:Education, Health, and Environmental Affairs CommitteePOSITION:Letter of Support with AmendmentsBILL ANALYSIS:SB 329 would require a public institution of higher education to submit an outbreak
response plan to the Maryland Department of Health on or before August 1 of each
year; requiring a public institution of higher education to implement the outbreak
response plan under certain circumstances; requiring the outbreak response plan to include
certain protocols and processes and the provision of certain staff; among other
activities.

POSITION RATIONALE: The Maryland Association of County Health Officers (MACHO) **supports** SB 329, **with amendments**. We agree with the sponsors that this bill will ensure better preparation on the part of colleges and universities prior to potential serious disease outbreaks. It also accomplishes two important goals: 1) increases communication between colleges/universities and their surrounding healthcare resources and 2) requires notification to medically vulnerable students and campus employees so they can take proper precautions until an infectious disease threat has been resolved.

MACHO recommends two amendments as follows:

 Delete "life-threatening" from page 2- lines 5, 19, 22, and 31, and page 3- line 3. Regardless of whether the contagious disease is given a descriptor of "life-threatening" or anything else, a clinician will have to make a decision as to whether a given infection is serious enough to activate the response plan. The designation of "life-threatening" may result in unnecessary confusion.

2) On page 3- line 6, replace:

(II) FEDERAL AND STATE SURVEILLANCE NETWORKS with:

(II) THE LOCAL HEALTH DEPARTMENT

Having colleges and universities try to directly contact the CDC may result in an uncoordinated response between MDH and federal health investigators. It is MDH's responsibility to consult the CDC and any other partnering federal agencies. Notification of the local health department will begin the proper notification process to MDH, and if necessary, the CDC, and expedite the mobilization of regional resources and facilitate communication amongst healthcare providers, EMS, and other entities at the local level.

MACHO notes that the HB 187 cross file bill sponsor indicated approval for both amendments in the bill's hearing on January 28th. For these reasons, the Maryland Association of County Health Officers submits this letter of support with amendments for SB 329.
