SB 37

Anne Arundel County - Alcoholic Beverages - Class B and Class H Licenses - Renewals

Chairman Pinsky, Vice Chair Kagan and Members of Education, Health and Environmental Affairs:

Thank you for allowing me the opportunity to introduce SB 37, Anne Arundel County - Alcoholic Beverages - Class B and Class H Licenses - Renewals. SB 37 requires the license holder of a Class B or Class H alcoholic beverages license in Anne Arundel County to attest, in a sworn statement, that the gross receipts from food sales for the 12-month period immediately preceding the application for renewal were equal to at least 51% of the gross receipts from the sale of food and alcoholic beverages. This provision provides an important enforcement tool for the Board.

There is a friendly amendment being offered to clarify the sale is for on-premise consumption.

This bill and the amendment has the support of the Anne Arundel County Senate Delegation and the Anne Arundel County Board of License Commissioners.

I respectfully request a favorable report on SB 32.
