SENATE BILL # 194 Anne Arundel County – Liquor Licenses – Transfer of License

DATE: February 28, 2020

COMMITTEE: Education, Health and Environmental Affairs

SUMMARY OF BILL: Authorizes Board of License Commissioners in AA County, to transfer an approved applicants license to within ½ mile of the approved premises, if certain circumstances exist.

EXPLANATION: An applicant who has been approved a liquor license, may, within 1 year of that approval, request to have a change in the location address if the new premises is within ½ mile of the approved and the reason for the request falls within the listed circumstances.

This will apply retroactively to license application submitted on or after January 2013.
