




What is the LONGEST amount of time it has taken you to receive a PQE for a newly hired employee after you submitted all of the required paperwork?


What is the AVERAGE amount of time it usually takes you to receive a PQE on a newly hired employee after you submitted all of the required paperwork?




How often have you had a new licensing specialist or supervisor go back and review a previously issued PQE and reduce or increase the level for which a staff member is qualified?

I've never received any PQEs!






