HB 1385 Town of Mount Airy (Carroll County and Frederick County)

- Urban Renewal Authority

Dear Chair Barve, Vice-Chair Stein and Environment and Transportation Committee members:

I am representing the Frederick County Delegation with the endorsement of the Carroll County Delegation to present the request for Urban Renewal Authority for Mounty Airy, while Mount Airy spans both counties it is entirely in Legislative District 4. This authority request is routine and if passed Mount Airy will become the 68<sup>st</sup> of Maryland's 157 municipalities to be granted such authority.

Specifically, this bill authorizes the Town of Mount Airy to undertake urban renewal projects for slum clearance by exercising the power of eminent domain to acquire properties in blighted areas. The town may not initiate an urban renewal project unless its legislative body adopts a resolution that defines the area and finds that rehabilitation or redevelopment is necessary and in the public's interest. Condemnation of land or property under the bill must be in accordance with the procedure set forth in State law. Further, the bill sets forth procedures for taking the property, funds which may be used to do so, and disposition of the property, including authorization to dispose of it to private persons. Property may not be taken without just compensation, either as agreed upon by the parties or awarded by a jury.

Today I have with me David Warrington, the town administrator of Mount Airy, who in a previous town administrator position worked with the Prince George's delegation to grant Cheverly the same Urban Renewal Authority.

Since this is a simple request that has been granted by the state legislature on numerous occasions, I would request that a timely favorable report will be granted so that this bill can cross over to the Senate for due consideration.
