#### Written Testimony from The Hertz Company Senate Bill 898

#### Vehicle Laws – Rental Vehicles – Driver's License Verification and Records

**Position: Support** 

Dear Chairman Smith and the Members of the Senate Judicial Proceedings Committee,

We appreciate the opportunity to submit testimony in support of Senate Bill 898.

The Hertz Corporation ("Hertz"), a subsidiary of Hertz Global Holdings, Inc., operates the Hertz, Dollar and Thrifty vehicle rental brands in approximately 10,200 corporate and franchisee locations throughout North America, Europe, The Caribbean, Latin America, Africa, the Middle East, Asia, Australia and New Zealand. The Hertz Corporation is one of the largest worldwide rental companies, and the Hertz brand is one of the most recognized in the world. Product and service initiatives such as Hertz Gold Plus Rewards, Ultimate Choice, Carfirmations, Mobile Wi-Fi and unique vehicles offered through the Adrenaline, Dream, Green and Prestige Collections set Hertz apart from the competition.

Hertz has entered into an exclusive arrangement with CLEAR, the company whose technology is presently being used at BWI-Marshall Airport for processing airline passengers through security lines by means of its biometric screening. Hertz is offering the use of this technology as a value-added service to its Gold Club Members who want to reserve their rental cars in advance of getting to the airport so they can avoid any delays.

In advance of a trip, Hertz simply performs an electronic scan of a Gold Club Member's license which they will check for authenticity. Hertz would check valid licensure (suspension and expiration status) with issuing DMVs, and in the meantime performs an expiration check based on the date listed on the face of a given license. This is done electronically, and the expiration date is stored in Hertz's systems. Rentals will not be permitted if the license is expired.

Biometric scans are performed at the airport facility to (1) match the individual renting with an approved comparison between an individual and license performed at time of registration; and/or (2) match the individual renting to the authenticated and validated driver's license in their possession at the time of rent.

Maryland law currently prohibits anyone from renting a motor vehicle to another person without inspecting the renter's driver's license; comparing and verifying that (1) the signature on the license with the signature of the individual, as written in the presence of the lessor or agent, and (2) the physical description on the license with the physical appearance of the individual.

This legislation seeks to allow for these activities to be done through electronic or digital means to allow for this program to be implemented at BWI-Marshall Airport. Additionally, it allows for such records to be kept in an electronic or digital format. Finally, it provides that if a lessor rents a motor vehicle to an individual in a manner that allows the other person to obtain possession of the vehicle without making direct contact with the lessor, the lessor is deemed to be in compliance with the law if the lessor requires the person who will operate the vehicle to enter into a membership or master program agreement.



#### **Activity Across the Country**

In 2019, there were nine states that required a human confirmation that the person leaving with the rental car was the same person whose photo is on the provided driver's license. The other 41 states had no such restriction.

Since then, Florida, Colorado, and Illinois have amended their statute along the lines of what Hertz has proposed in Maryland. All three passed without controversy. Bill are presently pending in Utah, Texas, Nevada as well. Utah and Maryland are being addressed this year while Texas and Nevada do not reconvene their legislatures until January 2021.

### SB898 Vehicle Laws – Rental Vehicles – Driver's License Verification and Records

Chairman Smith, Vice Chair Waldstreicher and Members of the Judicial Proceedings Committee:

Thank you for the opportunity to discuss Senate Bill 898, Vehicle Laws – Rental Vehicles – Driver's License Verification and Records. Current Maryland Law requires the lessor of a rented vehicle or their agent to inspect the renter's license to be certain it is valid and appropriate for the vehicle being leased; SB 898 allows a rental company, under certain circumstances, to use electronic or digital means to complete the inspection.

BWI-Marshall Airport currently uses CLEAR, to process airline passengers through security lines by means of biometric screening. SB 898 would allow a rental car company to enter into an agreement with such a company allowing their clients to reserve a rental car online and avoid lines when getting the car at the airport. Membership into the rental car master program would required.

Hertz has entered into an exclusive arrangement with CLEAR, the company whose technology is presently being used at BWI to screen passengers. Hertz is offering the use of this technology to its Gold Club members as a convenience by allowing them to reserve a rental car online and avoid lines at the airport. The customer presents a picture of his/her license to Hertz online and the company verifies that the license is the person's and that it is not expired. Hertz checks with the MVA in the State where the license was issued initially and annually thereafter to ensure the license remains valid. When the person arrives at their destination, they uses the CLEAR technology which verifies that it is indeed the person and pick up their rental car.

SB898 will streamline the process for car rentals by allowing the inspection to be done by electronic or digital means and for the person to obtain the rental without making direct contact with the renter.

I respectfully request a favorable report for SB898.
