The evening before the accident, the four of them set out for a beautiful summer ride to have dinner. They never made it to their destination because they were hit head by a car that crossed the yellow line. Uncle Brian was hit causing the handlebars to crush into his neck and chest. His larynx was crushed and had multiple facial injuries among others including terrible road rash. Will he ever be able to regain his voice back? Courtney was thrown 50 feet in the air landing on her head and neck. She is missing a piece of her skull and has brain damage that may potentially be permanent for the rest of her life. Tom was injured so bad that in order to save his life they had to remove his left arm and leg. He has had multiple surgeries and most of all he lost his beloved wife due to this accident. Sherry was in such bad shape that they had to remove her leg in attempt to save her life unfortunately she succumbed to her injuries and lost her life. Our beloved Sherry was a mother, daughter, sister, wife and a wonderful friend. She had so much more life to live. Will their lives ever be same the same?

The person at fault must be held accountable. If a person causes harm to another then they deserve to be punished regardless if it negligent, malicious intent or simply an accident. Our worlds have been forever changed. Our hearts are forever broken and lives have been forever changed. We can not get back what we have lost.
