(Public Resources Organizing to End Crime Together) Program, target collaborative law enforcement and community resources on ten state "micro-zones," and ensure continued collaboration among the Department of State Police, the Division of Parole and Probation, and the Department of Juvenile Services to establish and operate a warrant apprehension task force partnership.

LifeBridge Health is a regional health system comprising Sinai Hospital, Levindale Geriatric Center and Hospital, and Grace Medical Center (formerly Bon Secours) in Baltimore; Northwest Hospital in Reisterstown; and Carroll Hospital. It also now proudly houses a comprehensive violence program that addresses violence through the lifespan, and includes the Baltimore Child Abuse Center, two domestic violence programs, and elder justice program, and two street violence interruption programs, including Kujichagulia Center (Swahili for "self-determination), a hospital-based violence intervention program, and a new SafeStreets program in Park Heights.
