AMENDMENT NO. 1

On page 1, in line 26, after "unit" insert "<u>or, under certain circumstances, an</u> <u>electric generating unit permanently retired on or after a certain date</u>".

AMENDMENT NO. 2

On page 3, in line 8, strike "**2024**" and substitute "**2027**"; in line 21, after "**BY**" insert "<u>:</u>

<u>(I)</u>";

and in line 22, after "UNIT" insert "<u>; OR</u>

(II) <u>A PERMANENT CHANGE IN THE OPERATION OF AN</u> <u>ELECTRIC GENERATING UNIT THAT REDUCES THE UNIT'S CARBON DIOXIDE</u> <u>EMISSIONS RATE TO LESS THAN 180 POUNDS PER MILLION BRITISH THERMAL</u> <u>UNITS</u>".

On page 4, in line 6, after "OF" insert ":

in line 7, after "UNIT" insert "<u>; OR</u>

in line 12, strike "A **RESIDENT OF THE STATE**" and substitute "<u>AN INDIVIDUAL</u>"; in line 14, after "**TO**" insert "<u>:</u>

in lines 15 and 16, strike "THAT RESULTED IN THE DISPLACEMENT OF AT LEAST 20 WORKERS" and substitute "<u>; OR</u>

(II) <u>A PERMANENT CHANGE IN THE OPERATION OF AN</u> <u>ELECTRIC GENERATING UNIT THAT REDUCES THE UNIT'S CARBON DIOXIDE</u> <u>EMISSIONS RATE TO LESS THAN 180 POUNDS PER MILLION BRITISH THERMAL</u> <u>UNITS</u>";

in line 17, strike "**RESIDENT'S**" and substitute "<u>INDIVIDUAL'S</u>"; in line 19, after "(I)" insert "<u>OVER A 2–MONTH PERIOD</u>,"; in the same line, after "**FROM**" insert "<u>:</u>

<u>1.</u>";

after line 20, insert:

"2. <u>A PERMANENT CHANGE IN THE OPERATION OF AN</u> ELECTRIC GENERATING UNIT THAT REDUCES THE UNIT'S CARBON DIOXIDE EMISSIONS RATE TO LESS THAN 180 POUNDS PER MILLION BRITISH THERMAL UNITS; OR"; in line 21, after "WAGES" insert "<u>OR IS RECEIVING UNEMPLOYMENT BENEFITS</u>"; and in line 22, after "OPERATING" insert "<u>WITH A CARBON DIOXIDE EMISSIONS RATE</u> <u>GREATER THAN 180 POUNDS PER MILLION BRITISH THERMAL UNITS</u>".

On page 5 in line 15, and on page 8 in line 10, in each instance, after "UNIT" insert "OR A PERMANENT CHANGE IN THE OPERATION OF AN ELECTRIC GENERATING UNIT THAT REDUCES THE UNIT'S CARBON DIOXIDE EMISSIONS RATE TO LESS THAN 180 POUNDS PER MILLION BRITISH THERMAL UNITS".

On page 6, strike beginning with "YOUTH" in line 18 down through "**3**." in line 21; in line 23, strike "**4**." and substitute "<u>**3**.</u>"; and in line 24, strike "AND".

On page 7, in line 18, after the semicolon insert "AND

(VI) <u>AS DETERMINED BY THE DEPARTMENT IN</u> <u>CONSULTATION WITH THE COUNCIL, OTHER FINANCIAL ASSISTANCE TO</u> <u>DISPLACED WORKERS;</u>".

On page 10, in line 22, strike "ON" and substitute "(1) EXCEPT AS <u>PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, ON</u>"; in line 23, after "UNIT" insert "<u>OR AN ELECTRIC GENERATING UNIT PERMANENTLY RETIRED ON OR</u> <u>AFTER MAY 15, 2020,</u>"; and after line 24, insert:

"(2) <u>AN ELECTRIC GENERATING UNIT PERMANENTLY RETIRED ON</u> OR AFTER MAY 15, 2020, SHALL ANNUALLY REPORT TO THE COUNCIL UNDER PARAGRAPH (1) OF THIS SUBSECTION UNTIL NO EMPLOYEES ARE ASSIGNED TO WORK AT THE UNIT.".

On page 11, in line 10, after "CLOSURES" insert "<u>OR PERMANENT CHANGES</u> <u>IN OPERATIONS AT UNITS RESULTING IN CARBON DIOXIDE EMISSIONS EQUAL TO</u> <u>OR BELOW 180 POUNDS PER MILLION BRITISH THERMAL UNITS</u>".
