On behalf of Maryland's independent colleges and universities and the 65,600 students we serve, thank you for the opportunity to provide this written testimony in support of *House Bill 98* (Washington) – Maryland Higher Education Outreach and College Access Pilot Program – Alterations (Maryland College Access Act).

House Bill 98 would make permanent the college access pilot program that assists nonprofit organizations in facilitating low-income and minority students' college aspirations and provides annual appropriations through the State budget. Now more than ever, the outreach efforts to encourage students to enroll in a college or university is vital to their future aspirations and career goals. Every Maryland student should be provided support services to educate them on the various post-secondary educational opportunities that exist after high school. This program has been instrumental in increasing college access to low-income Maryland high school students and helping to complete a college education.

#### Testimony in Support of HB98 – Maryland College Access Act

HB98 repeals the sunset provisions of the Maryland Higher Education Outreach & College Access Program, and renames it as the Maryland College Access Act.

The Appropriations Committee established this program as a two-year pilot through legislation I proposed in 2015. It was then given an extension in 2018, and is now set to expire in 2021. This bill would simply extend the program permanently.

Following its establishment, the Governor funded the program with a \$250,000 appropriation that has been distributed to five non-profit agencies across the State. These agencies focus on outreach efforts to support and encourage low-income high school students to attend & complete college.

These grants have been used to fund workshops on college & career readiness, financial aid, college admissions and thousands of high school students across the State.

One of those non-profit organizations, First Generation College Bound, has aided 880 program participants in graduating with a college degree through this program:

Getting admitted to a higher education institution is difficult for any student in Maryland, but especially those who have grown up under difficult circumstances. These nonprofits play a crucial role in assisting our young people in achieving their academic and career goals.
