Dear Chair Pinsky and Members of the Education, Health, and Environmental Affairs Committee:

My name is Dr. Kimberly Sena Moore and I am the Regulatory Affairs Associate for the Certification Board for Music Therapists. Thank you for the opportunity to speak on behalf of the national government relations team of the Certification Board for Music Therapists and the American Music Therapy Association regarding Senate Bill 82. This bill creates a music therapy license, and as such helps remove barriers to music therapy services by qualified professionals in the state of Maryland.

Officially recognizing music therapy through state licensure, would protect consumers in Maryland by limiting the potential for harm to citizens through ensuring that only those who are *qualified* can call themselves "music therapists" or say they offer "music therapy." This would create channels for access while also allowing employers, potential employers, and private citizens to feel confident in the training and education of the music therapists they employ to work with their loved ones.

Despite the numerous health, economic, and social challenges of the previous year, music therapy remains an essential service for clients, family members, and healthcare providers as they navigate myriad challenges. Since the onset of the COVID-19 pandemic in March 2020, music therapists have adapted the delivery of their services and diversified service options to meet emerging needs of clients, family members, and healthcare providers. In addition, music therapy interventions are frequently considered when identifying potential pandemic-related treatment and support services for consumers and healthcare professionals.

In response to a national survey sent to music therapists in June 2020, almost two-thirds of respondents indicated they have added telepractice as a service delivery option, the vast majority of which are live virtual music therapy sessions. This has not only allowed for continuity of services, it has also enhanced therapeutic outcomes and improved family involvement in their loved ones' progress.

The majority of survey respondents (75%) agree that clients are responding positively to telepractice music therapy services; in fact, some report that certain clients are thriving in ways that did not happen when seen in person. Many respondents also noted that family members are more involved during sessions, so can witness the work and change that occurs when clients are engaged in music therapy.

Survey respondents also indicated benefits for healthcare providers. Music therapists are supporting their coworkers in in-patient and residential settings such as hospitals and long-term care facilities. These colleagues express joy and gratitude for the connections made through shared musical experiences during a period of increased isolation and stress.

Thank you for your consideration of this SB 82, which will create access to a beneficial therapeutic service for some of Maryland's most vulnerable citizens.

Mr. Chair and Members of the Committee,

My name is Niki Runge. I am a board-certified music therapist, Co-Chair of the Maryland Music Therapy State Task Force for Occupational Regulation and the Government Relations Chair for the Maryland Association for Music Therapy. I want to thank the committee for the opportunity to be heard again on behalf of our clients and the Maryland music therapists. Our goal has always been, and continues to be, to increase access to music therapy services and assure that these services are provided by qualified professionals who have completed the education, clinical training, and continuing education required of board-certified music therapists.

I wanted to take the time today to highlight the COVID-19 response from Maryland music therapists. A national COVID-19 survey was conducted in 2020 and found that in Maryland, 2/3 of music therapists who responded were considered essential workers. Music Therapists continued to serve Maryland's most vulnerable citizens through the continuation of in-person sessions and telehealth. Music therapists across the state were able to safely adapt, in the moment to continue to provide services based on clients' needs, and the current level of COVID restrictions. Sessions were conducted through telehealth via pre-recorded videos, live videos, and audio sessions, as well as continued in-person sessions, involving outdoor, and window visits. As we continue through the pandemic, without a state license these frontline workers are not eligible for the Phase 1A distribution of the COVID vaccine with related healthcare professionals. This puts clients, family members of clients, and colleagues at increased risk of contracting the virus. This is one more example of the inconsistencies in the ability to keep our clients safe when accessing services and how music therapists are recognized in the state without a license.

As we are working with the Board of Audiologists, Hearing-Aid Dispensers and Speech-Language Pathologists, we ask that the committee approve SB0082, with amendments suggested by the board.

The Licensed Clinical Professional Counselors of Maryland (LCPCM) is providing this letter of information for *Senate Bill 82 – State Board of Professional Counselors and Therapists – Maryland Music Therapists Act.* As introduced, this bill would create a new licensing category under the Board of Professional Counselors and Therapists for music therapists.

LCPCM does not support the inclusion of any new licensing categories under the Board of Professional Counselors and Therapists, including the licensing for music therapists. We would ask that there be serious consideration of the following key issues:

Resources of the Board of Professional Counselors: Over the past several years, the
Board has made great stride in addressing over 30 recommendations from its 2017
Sunset Review. While we are happy by this progress, the composition of the Board, by
design, was created through a piece-meal approach without assessing the functionality
of the Board as licensure categories were added.

To provide a practice example, LCPCM worked with the Board for over <u>5 years</u> to update the practice act regulations for LCPCs. One of the primary causes for the delay is the divergent needs of the Board in responding to new laws and requirements for other licensure categories, including Alcohol and Drug Counselors, Art Therapists, etc. While we are encouraged that the regulations were posted for public comment late last year, we are still waiting for them to be finalized.

• Expands the Scope of the Board Beyond Clinical Behavioral Health Services: It is our understanding that only a small percentage of music therapists work in behavioral

health settings, with the majority of music therapists working in other practice settings, including somatic care. In fact, the American Music Therapy Association describes the work of music therapists as assessing the "emotional well-being, physical health, social functioning, communication abilities and cognitive skills through music responses". Further, the Association references the work of music therapists to address physical disabilities and acute and chronic pain, including mothers during labor. Establishing a new licensure category under this board sets a precedent to expand the scope of the Board beyond its expertise of behavioral health.

For these reasons, we would ask that no additional licenses and/or certifications, including music therapists, be added under the Board of Professional Counselors and Therapists.
