## AMENDMENTS TO HOUSE BILL 77 (First Reading File Bill)

### AMENDMENT NO. 1

On page 1, in line 2, strike "Application of Coal Tar Pavement Products" and substitute "Driveway Sealers"; strike beginning with "applying" in line 4 down through "products" in line 5 and substitute "supplying, selling, offering for sale, or manufacturing a high–PAH driveway sealer for use in the State; prohibiting, on or after a certain date, a person from applying or soliciting the application of a high-PAH driveway sealer"; in line 5, after "surface" insert "in the State"; in the same line, before "establishing" insert "authorizing a person to submit an application to the Department of the Environment for a driveway sealer to be approved for authorized use in the State; requiring the Secretary of the Environment to compile and publish a qualified products list of driveway sealers authorized for use in the State; requiring a person submitting an application to include a driveway sealer on the qualified products list to include certain test results and data in the application; requiring the Secretary to issue an approval for use notice for approved driveway sealers;"; strike beginning with "application" in line 7 down through "products" in line 8 and substitute "sale and use of driveway sealers in the State"; in line 11, strike "9-2304" and substitute "9-2305"; and in lines 11 and 12, strike "Coal Tar Pavement Products" and substitute "Driveway Sealers".

#### AMENDMENT NO. 2

On page 1, in line 18, strike "COAL TAR PAVEMENT PRODUCTS" and substitute "DRIVEWAY SEALERS".

On page 2, strike in their entirety lines 7 through 10, inclusive; after line 10, insert:

"(C) "CUTBACK" MEANS A SOLIDS PORTION THAT HAS BEEN LIQUEFIED BY BLENDING WITH MORE THAN 0.5% BY VOLUME VOLATILE ORGANIC COMPOUNDS THAT EVAPORATE AT 260 DEGREES FAHRENHEIT OR LOWER AS DETERMINED BY:

(1) <u>THE ASTM INTERNATIONAL STANDARD TEST METHOD FOR</u> DISTILLATION OF CUTBACK ASPHALT; OR

(2) ANY OTHER TEST METHOD APPROVED BY THE SECRETARY.

(D) "DRIVEWAY SEALER" MEANS A COATING LABELED AND FORMULATED FOR APPLICATION TO WORN ASPHALT DRIVEWAY AND PARKING LOT SURFACES TO:

- (1) FILL CRACKS;
- (2) SEAL THE SURFACE TO PROVIDE PROTECTION; OR
- (3) **RESTORE OR PRESERVE APPEARANCE.**
- (E) "EMULSION" MEANS A SUSPENSION OF SOLIDS PORTION AND WATER.

(F) <u>"HIGH-PAH DRIVEWAY SEALER" MEANS A DRIVEWAY SEALER</u> <u>CONTAINING MORE THAN:</u>

(1) 0.000000% POLYCYCLIC AROMATIC HYDROCARBONS BY WEIGHT FOR EMULSIONS; OR

(2) 0.000800% POLYCYCLIC AROMATIC HYDROCARBONS BY WEIGHT FOR CUTBACKS.";

strike beginning with "APPLY" in line 16 down through "SURFACE" in line 18 and substitute "<u>SUPPLY, SELL, OFFER FOR SALE, OR MANUFACTURE A HIGH–PAH</u> <u>DRIVEWAY SEALER FOR USE IN THE STATE</u>"; strike beginning with "MORE" in line 19 down through "LESS" in line 21 and substitute "<u>OR SOLICIT THE APPLICATION OF</u> HB0077/473827/1 Amendments to HB 77 Page 3 of 4

<u>A HIGH-PAH DRIVEWAY SEALER</u>"; in line 21, after "SURFACE" insert "<u>IN THE</u> <u>STATE</u>"; after line 21, insert:

"<u>9–2304.</u>

(A) (1) A PERSON MAY SUBMIT AN APPLICATION TO THE DEPARTMENT FOR A DRIVEWAY SEALER TO BE APPROVED FOR AUTHORIZED USE IN THE STATE IN ACCORDANCE WITH THIS SUBTITLE.

(2) <u>THE SECRETARY SHALL COMPILE AND PUBLISH A QUALIFIED</u> PRODUCTS LIST OF DRIVEWAY SEALERS THAT MAY BE USED IN THE STATE.

(B) <u>A PERSON SUBMITTING AN APPLICATION TO INCLUDE A DRIVEWAY</u> SEALER ON THE QUALIFIED PRODUCTS LIST SHALL INCLUDE IN THE <u>APPLICATION:</u>

(1) THE RESULTS OF AN ISO/IEC 17025 ASSESSMENT CONDUCTED BY A TESTING FACILITY CERTIFIED UNDER THE AMERICAN ASSOCIATION OF STATE HIGHWAY AND TRANSPORTATION OFFICIALS ACCREDITATION PROGRAM;

(2) ANALYSIS RESULTS FROM A SAMPLE OF THE DRIVEWAY SEALER TESTED FOR SEMIVOLATILE ORGANIC COMPOUNDS UNDER THE U.S. ENVIRONMENTAL PROTECTION AGENCY'S TEST METHOD 8270;

(3) TEST RESULTS EXPRESSING THE COMPOSITION OF THE DRIVEWAY SEALER AS A PERCENTAGE OF POLYCYCLIC AROMATIC HYDROCARBONS BY WEIGHT; AND

 $(4) \qquad \underline{A \text{ SAFETY DATA SHEET.}}$ 

(C) THE SECRETARY SHALL ISSUE AN APPROVAL FOR USE NOTICE FOR DRIVEWAY SEALERS THAT MEET THE REQUIREMENTS FOR APPROVAL UNDER THIS SECTION.
