AMENDMENTS TO SENATE BILL 503 (First Reading File Bill)

AMENDMENT NO. 1

On page 1, in line 11, strike "approve, disapprove, or approve with modifications" and substitute "<u>issue a final order approving or disapproving</u>"; and in line 12, after "factors;" insert "<u>requiring an order approving a gas company's plan to relocate any gas service regulator to include certain conditions under certain circumstances; requiring a gas company to submit a new plan to the Commission within a certain number of days <u>under certain circumstances;</u>".</u>

AMENDMENT NO. 2

On page 3, in line 11, after "(4)" insert "(I)"; in line 12, strike "APPROVE, DISAPPROVE, OR APPROVE WITH MODIFICATIONS" and substitute "ISSUE A FINAL ORDER APPROVING OR DISAPPROVING"; in lines 15, 17, 19, 21, 23, and 26, strike "(I)", "(II)", "(III)", "(IV)", "(V)", and "(VI)", respectively, and substitute "<u>1</u>.", "<u>2</u>.", "<u>3</u>.", "<u>4</u>.", "<u>5</u>.", and "<u>6</u>.", respectively; in line 25, strike "AND"; in line 26, strike "COMMISSION" and substitute "<u>COMMISSION; AND</u>

7. WHETHER THE GAS COMPANY HAS:

<u>A. MADE EVERY REASONABLE EFFORT TO</u> EXPEDITIOUSLY ADDRESS ANY FACTORS THAT MAY CONTRIBUTE TO A DELAY IN RELOCATING GAS SERVICE REGULATORS; AND

B. <u>COMMITTED TO A REASONABLE IMPLEMENTATION</u> TIMELINE THAT DOES NOT UNDULY DELAY REGULATOR RELOCATION";

and after line 26, insert:

"(II) <u>1.</u> IF THE COMMISSION ISSUES AN ORDER <u>APPROVING A GAS COMPANY'S PLAN, THE ORDER SHALL INCLUDE ANY</u> CONDITIONS OF APPROVAL THAT THE COMMISSION REQUIRES.

2. IF THE COMMISSION ISSUES AN ORDER DISAPPROVING A GAS COMPANY'S PLAN, THE GAS COMPANY SHALL SUBMIT A NEW PLAN TO THE COMMISSION WITHIN 60 DAYS AFTER THE COMMISSION ISSUES THE DISAPPROVAL.".

On page 4, in line 2, strike "AND"; and in line 3, strike the period and substitute "<u>; AND</u>

(V) WHETHER THE GAS COMPANY HAS:

1. MADE EVERY REASONABLE EFFORT TO EXPEDITIOUSLY ADDRESS ANY FACTOR THAT MAY CONTRIBUTE TO A DELAY IN RELOCATING GAS SERVICE REGULATORS; AND

2. <u>COMMITTED TO A REASONABLE IMPLEMENTATION</u> <u>TIMELINE THAT DOES NOT UNDULY DELAY REGULATOR RELOCATION.</u>".
