The Maryland State Archives is an active member of the Maryland Lynching Truth and Reconciliation Commission and is submitting this letter of support on its behalf. HB 297 extends the term of the Commission by two years to complete the tasks outlined through legislation. The Commission is to hold hearings and conduct research to advance our knowledge about African American Marylanders who were the victims of mob violence in our State.

The Commission has identified over forty incidents of victims who were accused of a crime but were not afforded due process as a result of the violent actions of an extralegal mob and were lynched in Maryland. The COVID-19 pandemic effectively thwarted activities that are specifically mandated by the authorizing legislation. There is much work to be done in regards to research and outreach to communities who were impacted.

The Commission in its first year focused on developing policies, forming committees, and building relationships with key stakeholders. During that time the Commission has selected a Chair and Vice Chair to drive the work, drafted and submitted an interim report, and is now at the point of starting to conduct research and arranging public hearings. This huge undertaking will require additional time and dedicated resources. An extension for this work will allow time for the Commission to write and submit a thoughtful and informed final report. The Maryland State Archives fully supports House Bill 297 and urges a favorable report.

The Maryland Commission on Civil Rights ("MCCR"; "The Commission") is the State agency responsible for the enforcement of laws prohibiting discrimination in employment, housing, public accommodations, and state contracts based upon race, color, religion, sex, age, national origin, marital status, familial status, sexual orientation, gender identity, genetic information, physical and mental disability, and source of income.

House Bill 297 extends the reporting and sunsetting requirements for the Maryland Lynching Truth & Reconciliation Commission by two years to December 1, 2023, and June 30, 2024, respectively. SPONSOR TESTIMONY: Joseline Peña-Melnyk (Favorable)

Chairman Smith, Vice Chair Waldstreicher and members of Judicial Proceedings Committee, I seek a favorable vote for House Bill (HB) 297, which revises the date for submitting the final report and extends the Commission's cessation date.

In 2019, our legislature voted unanimously to create the Maryland Lynching Truth and Reconciliation Commission. In doing so, Maryland became the first state in the nation to launch this effort to heal the horrific wounds of racial injustice. Since then, Maryland's Commission has received national recognition for its work. On November 2, 2020, the Commission was awarded \$300,000 in federal funding to study unsolved lynching crimes in our state. This Commission is doing groundbreaking work, at a time not seen before in our history. The coronavirus pandemic created obstacles to conducting public meetings required of the Commission. Additionally, this past year has demonstrated the hunger for racial justice, through the lens of too numerous deaths of Black Americans at the hands of their local police. The Commission's work is so important and impactful that President Biden's team has reached out to the Commission for guidance in the development of a similar Federal Commission. This bill will enable the Commission to complete its vital work.

To address past injustices, we must fully understand them and acknowledge the lasting impact on these victims' families. The Commission has established themselves, with several Black Historians, as the premier entity to preserve oral history and receive documentation from families directly impacted by these heinous crimes.

Thank you for the opportunity to present HB 297. I respectfully request your favorable vote of support of this bill.
