13 I, Tanisha [REDACTED], Grandparent to minor child, [REDACTED], seeks to invoke my
14 GRANDPARENTS RIGHTS under §9–102 of the Family Law Code which states: An equity
15 court may:

17 (1) consider a petition for reasonable visitation of a grandchild by a grandparent; and
18 (2) if the court finds it to be in the best interests of the child, grant visitation rights to the
19 grandparent.

20 I seek to do this because:

- 21 (1) The plaintiff, [REDACTED], has alienated me from my granddaughter [REDACTED]

8 (1) Grandparents Rights were not mentioned in either order – December 22, 2016/ June 19,
9 2017/November 6, 2019 therefore I am petitioning the court to allow me my grandparents

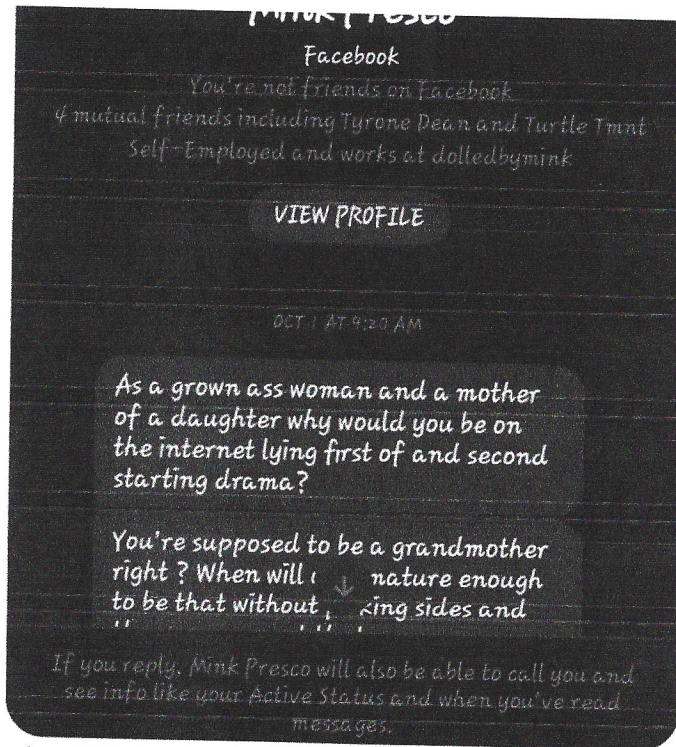
12 (2) Based on the social media and text messages the mother, [REDACTED], is not
13 allowing me to spend time with my granddaughter.

15 (3) Based on 921 A.2d 171 (2007), 398 Md. 404 Glen KOSHKO, et ux.
16 v. John HAINING, et ux. No. 35, Sept. Term, 2006. Court of Appeals of Maryland.
17 January 12, 2007. Reconsideration Denied March 9, 2007. This case requires us to
18 consider a constitutional challenge to Maryland's grandparental visitation statute
19 ("GVS"), Maryland Code (1984, 2004 Rep 1. Vol.), Family Law Article § 9-
20 102. Specifically, we are asked to decide whether the GVS is unconstitutional, under
21 substantive due process analysis, because it fails to recognize a rebuttable presumption
22 accorded the propriety of a parent's determination of what is in his or her child's best
23 interest with respect to visitation with a grandparent. We further shall consider whether
24 substantive due process requires a threshold finding of either parental unfitness or
25 exceptional circumstances counseling in favor of grandparent visitation before a court
26 may proceed to determine what is in a child's best interests.

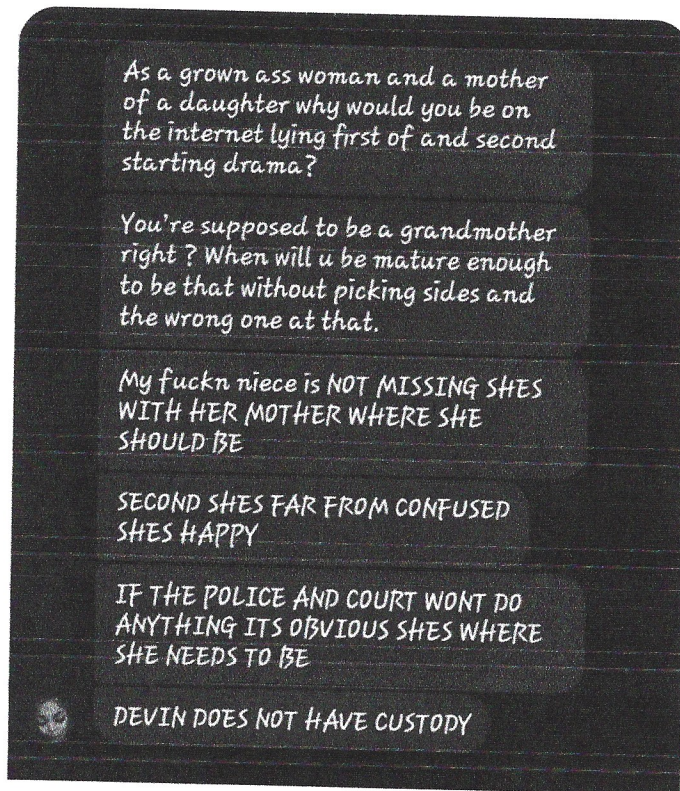
