Please accept this letter as our organization's support for the adoption of The International Swimming Pool and Spa Code (ISPSC) with the passing of HB 0303 . The ISPSC is a model code that regulates the minimum requirements for the design, construction, alteration, repair, and maintenance of new or substantially re-modeled swimming pools, spas, hot tubs and aquatic facilities. This includes public swimming pools, public spas, public exercise spas, aquatic recreation facilities, permanent in-ground residential spas and pools and permanent residential spas and pools among other water venues. Abbey's Hope Charitable Foundation and the National Drowning Prevention Alliance support the adoption of the ISPSC in States and local jurisdictions around the country. In fact, at least 13 states and hundreds of localities have adopted the safety code. We strongly encourage the Maryland Legislature to adopt this important safety code.

Developed in collaboration with the Pool & Hot Tub Alliance (PHTA; formerly the Association of Pool &Spa Professionals), ISPSC adoption provides many benefits supporting the safety and health of water. If adopted, the code requires pools and other water facilities to: meet the requirements of the Virginia Graeme Baker Pool & Spa Safety Act (VGB Act); meet the APSP-7 standard for suction entrapment avoidance; require layers of protection around pools and spas that help prevent the unfettered access by children, including fencing, covers and door and window alarms; and ensure that water quality is healthy and safe, among many other safety and health provisions.

In June of 2007, six-year old Abigail Taylor suffered a horrific injury while swimming in a public pool. That injury ultimately took her life. Abbey was playing in a wading pool when she unknowingly sat on a drain that was poorly maintained and unequipped with the appropriate safety devices. The powerful suction of the pool eviscerated Abbey. Her small intestine was ripped from her body. The serious injury was followed by 9 months of medical care, including 16 different surgeries, a triple organ transplant, several infections and most of her sixth year of life in a hospital bed. Despite the best medical care and attention and our constant vigilance and prayers, Abbey died March 20, 2008. Abbey's hope was that no child should ever suffer like she did as a result of an improperly maintained pool or from a preventable drowning. In her memory Abbey's Hope Charitable Foundation was formed.

One our greatest achievements was helping the United States Congress to pass The Virginia Graeme Baker Pool Safety Act (VGB Act) which requires entrapment safety devices on all <u>public</u> pools in Maryland and around the country. Significantly, since the effective date of this law, there has not been a single entrapment death at a public pool or spa, however, the passage of this measure alone is not enough in Maryland. Adoption of the ISPSC will help close that safety gap between public and residential pools and spas by requiring the same entrapment protection provided from the VGB Act to, at least, newly constructed pools/spas and substantially remodeled existing pools/spas. Please help fulfill Abbey's hope of 'safer pools, safer kids' by adopting the ISPSC code.

Testimony of Delegate Dana Stein in Support of HB 303 – Maryland Swimming Pool and Spa Standards Adoption

Mr. Chairman and Members of the Environment and Transportation Committee,

In this committee, we have adopted a number of building standards over the years. We approved the International Energy Conservation Code, authorized adoption of the International Green Construction Code, and have made changes to the International Residential Code. These codes are all developed and updated by the International Code Council (ICC), which is the recognized source for building codes and standards.

The Code Council, in collaboration with the Pool and Hot Tub Alliance (PHTA), has also developed the International Swimming Pool and Spa Code (ISPSC), which this bill would adopt for the State. This committee and the House passed this bill last year (as HB109), and it crossed over to the Senate. Unfortunately, it ran out of time in the Senate. HB 303 establishes minimum regulations for *newly constructed* public and residential pools, spas, and hot tubs using prescriptive and performance-related provisions. The bill is not retroactive, meaning you do not have to bring existing pools and spas up to this code.

This code is needed because while most Maryland jurisdictions have some form of pool and spa regulations, the State lacks a comprehensive code that addresses design, construction, and safety of pools and spas.

This need is fundamentally about safety, especially the safety of children. According to a 2015 Maryland Department of Health report, drowning was the 2nd leading cause of death for children aged 0-4 and the third leading cause of death for children aged 5-14.

This code will enhance pool safety in many ways, including stronger residential barrier requirements and the elimination of conditions that lead to entrapment incidents. These standards are best practices that are proven to reduce drowning fatalities.

By adopting a statewide code, the State will ensure that pools and spas are governed by a uniform, consistent code, which will foster compliance for businesses and additional safety for consumers.

Note that counties will be able to amend the code to fit their needs, but the critical point is that everyone in the state will work from the same code.

Fourteen other states have taken steps to adopt this code statewide, including most of our adjoining states. Seven Maryland jurisdictions have already adopted this code, most notably Anne Arundel County, Montgomery County, and Baltimore City. And most jurisdictions in Maryland have adopted "portions" of the International Swimming Pool and Spa Code via the International Building Code and International Residential Code.

HB 303 is nearly identical to HB 109 with the exception of several clarifying, non-substantive amendments. In addition, there are two sponsor amendments before you, which simply clarify that HB 303 "only" applies to newly constructed pools and spas and not to existing pools and spas. Additionally, the amendments clarify that the requirements for additions, alterations, and repairs shall be within the scope of the code.

We have met with the local environmental health directors to alleviate their concerns and ensure they will continue to have a role in the design and construction of pools and spas. They are no longer in opposition. The Maryland Chamber of Commerce also supports this legislation, noting that it will provide "numerous benefits to citizens and business owners in the State."

Dear Chair Barve, and Members of the Committee,

The International Code Council (Code Council) supports the passage HB 303, adopting the International Swimming Pool and Spa Code (ISPSC) for new construction, alteration, and remodeling of public, semi-public, and private pools and spas¹.

The Code Council is a member-focused nonprofit association with over 64,000 members (1,200 of whom call Maryland home) that develops model building codes, the I-Codes, used in the design, build and compliance process to construct safe, sustainable, affordable and resilient structures. Maryland chooses the International Codes (I-Codes) as its regulatory foundation for the built environment adopting and adapting the International Residential Code, the International Building Code, the International Plumbing Code, the International Mechanical Code, the International Fuel Gas Code, the International Green Construction Code, the International Property Maintenance Code, the International Existing Building Code, and the International Energy Conservation Code, all of which are updated every three years using a nationally recognized consensus-based process. The I-Codes, including the *International Swimming Pool and Spa Code* (ISPSC), are the most widely used and adopted set of building codes in the U.S. and around the world.

Several Maryland jurisdictions currently adopt and enforce the ISPSC² or use provisions from the code. Others require permits and inspections for pools and spas but reference out of date legacy regulations. This approach causes a patchwork of jurisdiction specific requirements across Maryland that do not take advantage of safer and more energy efficient construction practices that up-to-date codes and standards provide (e.g. solar thermal water heating). Passing HB 303 reduces industry confusion and promotes compliance through a consistent set of pool and spa regulations that are seamlessly designed to integrate with the building, plumbing, mechanical, residential and other construction codes used throughout Maryland. Additional advantages to adopting the ISPSC are listed on the attached document. The Code Council appreciates the Committee's consideration and urges a favorable vote.

According a 2015 Maryland Department of Health report, drowning was the 2nd leading cause of death for children 0-4 and the third leading cause of death for children aged 5-14. Most jurisdictions use outdated safety standards for pool and spa construction and many lack comprehensive codes that address design and construction of pools and spas. Unlike statewide adopted building codes, requirements for residential pools are vastly different creating a patchwork of regulations and requirements for public pools are severely outdated; some are over 20 years old. HB 303 and SB 319 remedies this by adopting the most recent edition of the International Swimming Pool and Spa Code (ISPSC) using the same recognized process Maryland employs for the adoption of the International Building Code, International Residential, and International Energy Conservation Code.

BENEFITS of adopting the ISPSC:

- Enhances residential pool barrier requirements, reducing drowning incidents and ensures compliance with Virginia Graeme Baker Act which is designed to eliminate entrapment incidents.
- Is based on scientifically proven best practices for drowning prevention and energy efficiency.
- Provides Maryland a consistent and uniform set of regulations reducing the cost of pool design and construction.
- Requires portable spas to be certified to the latest industry standards, eliminating the need to inspect inaccessible interior components.
- Is coordinated and corelated with the International Building Code (IBC), International Residential Code (IRC), International Plumbing Code (IPC), International Mechanical Code (IMC), and the other I-Codes adopted by Maryland and uses the same open and transparent development process.
- Eligibility for Consumer Product Safety Commission (CPSC) training grants.
- Statewide training on a code that is coordinated and correlated with Maryland's suite of codes.
- Requirements are easily accessible and free for public viewing.

Synopsis – HB 303 and SB 319 creates the Maryland Swimming Pool and Spa Standards and adopts the ISPSC by regulation with an initial implementation date of June 1, 2023. The proposed language follows 12-503, Maryland Building Performance Standards, which adopts, by regulation (COMAR 09.12.51), the International Building Code (IBC), International Energy Conservation Code (IECC), and permits the International Green Construction Code (IgCC) (COMAR 09.12.51 also adopts the International Residential Code). The Department of Labor shall consult with the Department of Health during review of the ISPSC. Local jurisdictions may adopt local amendments so long as the amendments do not weaken energy conservation and efficiency provisions. Also notable in the legislation:

- The Department of Labor shall maintain a central automated database that includes the Standards, local amendments to the Standards, make database information available to local jurisdictions, coordinate with code officials and the State Fire Marshal and local fire officials.
- Local jurisdictions can further amend the Standards so long as they do not weaken energy efficiency provisions.

In addition, most of these regulations are severely outdated with some being over 20 years old.

HB 303 seeks to bring conformity to Maryland swimming pool and spa standards by adopting the most recent edition of the International Swimming Pool and Spa Code (ISPSC). This code is based on scientifically proven practices for drowning prevention and energy efficiency and will follow the same process that Maryland employs for the adoption of the International Building Code, International Residential, and International Energy Conservation Code.

HB 303 provides numerous benefits to citizens and business owners in the State. Most importantly, the ISPSC enhances residential pool barrier requirements which dramatically reduce the risk of drowning. HB 303 also provides access to Consumer Product Safety Commission training grants, Statewide training on code compliance, and requires that provisions of this code be easily accessible and free for public viewing. HB 303 is a great example of government support for the modernization of regulations that impact Maryland citizens every day.

With these comments in mind, the Maryland Chamber of Commerce respectfully requests a <u>favorable report</u> on HB 303.
