The Arc Maryland is the largest statewide advocacy organization dedicated to protecting and advancing the rights and quality of life of people with intellectual and developmental disabilities. We support **SB003 – 9-8-8 Trust Fund – Funding** because we know that additional investment in this lifeline is necessary to support the continuance and anticipated growth of critical services for people in crisis; services that people with IDD who have co-occurring mental health conditions may need in crisis.

The goal of the 988 Lifeline is to provide **immediate crisis intervention and support**. Having this immediate help is surely life-saving, and, as this lifeline is on the continuum of crisis prevention and response, it alleviates strain on emergency rooms and First Responders. Trained crisis counselors are available 24 hours a day, 7 days a week to answer 988 calls or texts, respond/actively listen to the caller, provide immediate support, and provide needed resources.

Since last year, when Maryland established the 988 Trust Fund for the transition to, and expansion of, crisis services, the demand for services has grown. The increased call volume and visibility associated with the transition to 988 now requires continued and enhanced state investment to meet needs.

Maryland communities need mental health and emotional support now, perhaps more than ever^{1,2} and investing in the 988 Lifeline is a critical component of our community health system. SB003 would ensure Maryland's 988 system will be better suited to handle the rising call and text volume of people seeking crises services, as well as ensure individuals are connected to the services they desperately need to survive and thrive.

We respectfully ask for a favorable report from the committee on SB003.

Health Care for the Homeless supports SB 3, which requires \$12 million be allocated to the 988 Trust Fund in support of the 988 Lifeline's suicide prevention and behavioral health crisis services in Maryland.

Health Care for the Homeless sees clients with a range of needs, including clients with behavioral health crisis needs. For those clients, it is critical that we have an accessible system in place that providers and clients alike can rely upon to support their needs.

Congress designated 988 as the new phone number the National Suicide Prevention Lifeline. In July 2022, 988 went live, resulting in phone companies routing calls to local crisis call centers that are part of the Lifeline network. The local crisis call centers provide 24/7 free, confidential emotional support to people calling for help. Calls to the Lifeline have significantly increased and are expected to continue to grow.

We believe Maryland must provide funding to ensure the regional call centers have adequate staff, and to ensure crisis response services such as crisis stabilization centers and mobile response teams are available to meet people's needs.

The Maryland Coalition of Families: Maryland Coalition of Families (MCF) helps families who care for a loved one with behavioral health needs. Using personal experience, our staff provide one-to-one peer support and navigation services to family members with a child, youth or adult with a mental health, substance use or gambling issue.

MCF strongly supports SB 3.

SB 3 would provide much needed additional funding for the 988 Trust Fund to support reliable planning and capacity building for the Maryland 988 Suicide & Crisis Lifeline network.

Last year, Maryland established the 988 Trust Fund and dedicated funding for 988 Lifeline providers for essentially the first time. This funding was critical to support Maryland’s transition to 988, the first nationwide three-digit access code for suicidal and behavioral health crisis calls and texts. The helplines that make up Maryland’s Lifeline network provide free, 24/7 supportive counseling and safety planning to residents for decades, and the increased call volume and visibility associated with the transition to 988 demands new and continued state investment. Maryland communities need mental health and emotional support more than ever and investing in the 988 Suicide & Crisis Lifeline is a critical way to provide that support.

The need for 988 is greater than ever. The mental health of people has dramatically worsened in the wake of the COVID pandemic. Adults saw an increase in rates of depression from 6% to 25% from 2019 to 2021.¹ Emergency department visits for potential suicidality for youth aged 12-17 increased 39% from 2019 to 2021.² The United States and Maryland are experiencing a mental health crisis, and this is especially true of youth. The American Academy of Pediatrics (AAP), the American Academy of

Child and Adolescent Psychiatry (AACAP) and the Children’s Hospital Association (CHA) joined together to declare a National State of Emergency in Children’s Mental Health. Study after study has documented the worsened mental health of youth since the onset of the COVID pandemic.

Already 988 has been making a difference in people’s lives. When the increase in utilization of the suicide lifeline has been measured, significant increases have been found. The 988 Suicide and Crisis Lifeline received over 1.7 million calls, texts and chats in its first five months. That's nearly half a million more than the old 10-digit Suicide Prevention Lifeline fielded during the same period the year before.

Maryland has a strong foundation that can be built upon to create the robust 988 network that will keep residents safe and well, but continued investment is needed.

MCF urges a favorable report on SB 3.

Johns Hopkins University and Medicine is pleased to **support SB3** 9-8-8 Trust Fund – Funding. This bill provides much needed additional funding for the 988 Trust Fund to support reliable planning and capacity building for the Maryland 988 Suicide & Crisis Lifeline network.

This Fund is to provide reimbursement for the costs associated with maintaining 9-8-8 as the designated National Suicide Prevention Lifeline. Starting in July 2022, all phone companies started to route 988 calls to local crisis call centers that are part of the Lifeline network. The local crisis call centers provide 24/7 free, confidential emotional support to people calling for help. Since going live, call volume to 988 has increased 40% and Maryland needs to ensure that its existing eight local call centers are adequately resourced to support this influx of calls for help.

The need for expanded crisis services support is demonstrated by the volume of people brought to hospital emergency departments under emergency petition. Approximately 60% of people brought to a hospital ED are discharged. They do not need inpatient care, but they are in crisis and need assistance. Expanded crisis services like 988 can help address this need. For example 80% of calls to 988 are resolved over the phone.

Johns Hopkins Medicine provides behavioral health crisis services to Marylanders throughout the State. Services are provided through our emergency departments and communities services. Seventeen hospitals, along with three local behavioral authorities and community organizations across Baltimore City, Baltimore County, Carroll County and Howard County were awarded a grant as a part of the Greater Baltimore Regional Integrated Crisis System (GBRICS). GBRICS aims to address behavioral health crises through a robust crisis hotline and referral system and increased access to mobile crisis services, which helps to serve individuals in the community instead of through the criminal justice system or hospital emergency departments. 988 is a vital tool for achieving the goals of GBRICS.

Maryland should protect this valuable, lifesaving resource, by ensuring continued funding of the 9-8-8 Trust Fund. **Johns Hopkins urges the Senate Finance Committee to move favorably SB3.**

SB 3 988 Trust Fund – Funding

EveryMind, a nonprofit organization, strengthens communities and empowers individuals to reach optimal mental wellness. EveryMind has positively impacted the mental health and wellness of children, youth, adults, veterans, and families in Maryland for more than 65 years. Based in Rockville, EveryMind offers community education like the evidence-based Mental Health First Aid training and implements various programs and direct services for every stage of life from youth to older adults. This includes operation of the 24/7 hotline in Montgomery County. We are one of the centers that has answered the National Suicide Prevention Lifeline – now 988 Suicide and Crisis Lifeline - since 2005. We are staffed by trained Hotline counselors that provide supportive listening, information and resources, and crisis intervention (including suicide assessments) through phone, text, and chat services. Our hotline is one of eight 988 Lifeline centers in Maryland and one of only three that offer text and chat services.

EveryMind is pleased to support SB 3 988 Trust Fund – Funding. This bill provides much needed additional funding for the 988 Trust Fund to support reliable planning and capacity building for the Maryland members of the 988 Suicide & Crisis Lifeline network.

Last year, Maryland established the 988 Trust Fund and dedicated funding for 988 Lifeline centers for essentially the first time. This funding was critical to support Maryland’s transition to 988, the first nationwide three-digit access code for suicidal and behavioral health crisis calls and texts. The hotlines that make up Maryland’s 988 Suicide & Crisis Lifeline network have provided free, 24/7 support and safety planning to residents for decades. The increased call volume and visibility associated with the transition to 988 demands new and continued state investment. Maryland communities need mental health and emotional support more than ever and investing in the 988 Suicide & Crisis Lifeline is a critical way to provide that support.

We continue to see the need for 988 as demand for our services is now triple the calls, texts, and chats we saw during the same time last year. Much of that demand is from youth ages 24 and younger. To meet the increased need, our Crisis Hotline Counselors receive training in mental health, suicide prevention, intervention, and safety planning, as well as the needs of communities that are at higher risk of suicide such as the LGBTQIA+, older adults, and people of color. We are hiring new Hotline positions to help us meet the demand for suicide prevention services and to make sure we are there when someone reaches out. As a center accredited by the American Association of Suicidology, EveryMind understands how the services provided on the 988 Lifeline save lives and keep our friends and neighbors out of the hospital, jail, and even the morgue. Our support is not only vital – it is money saving to the County, the State, and constituents.

Maryland can build on its foundation to create the robust 988 Lifeline network that will keep residents safe and well, but continued investment is needed. **EveryMind urges the Senate Budget & Tax Committee to pass SB 3.**

SUPPORT

The Public Justice Center (PJC) is a not-for-profit civil rights and anti-poverty legal services organization which seeks to advance social justice, economic and racial equity, and fundamental human rights in Maryland. Our Health and Benefits Equity Project advocates for policies and practices that are designed to improve the overall health of Marylanders struggling to make ends meet, with the explicit goal to eliminate racial and ethnic disparities in health outcomes. **PJC strongly supports SB 3**, which would require the Governor to include in the annual budget for FY 2025 an appropriation of \$12,000,000 to the 9-8-8 Trust Fund.

We thank the Maryland General Assembly for passing SB 241 (2022) which established the 9-8-8 Trust Fund and helped ensure that when 9-8-8 went live as the designated official phone number for the National Suicide Prevention Lifeline, individuals experiencing a behavioral health crisis would have an easy pathway to local crisis services. The COVID-19 pandemic and resulting isolation and job loss created an increased need for on-demand behavioral health crisis services for children and adults in Maryland and a nationwide increase in calls to crisis hotlines. Although mental illness impacts all races, ethnicities and other identities, research supports that people of color and individuals identifying as LGBTQ are disproportionately impacted.¹ Similarly, substance use disorder is increasing among low-income individuals.

Maryland cannot effectively meet the needs of Maryland's adults and children in crisis without sustainable funding for crisis response services. If passed, SB 3 would create a steady funding source for much needed services, including crisis call centers, mobile crisis teams services and crisis stabilization centers. Increasing the

Mental Health Association of Maryland (MHAMD) is a nonprofit education and advocacy organization that brings together consumers, families, clinicians, advocates and concerned citizens for unified action in all aspects of mental health and substance use disorders (collectively referred to as behavioral health). We appreciate the opportunity to provide this testimony in support of Senate Bill 3.

SB 3 provides additional funding for Maryland’s 988 Trust Fund.

In 2022 the Maryland General Assembly established the 988 Trust Fund to reimburse for costs associated with designating and maintaining 988 as the new universal telephone number for the state’s suicide prevention and mental health crisis hotline and for developing and implementing a statewide continuum of behavioral health crisis response services.

Challenges in accessing quality mental health and substance use disorder services in the community results far too often in Marylanders calling police or going to hospital emergency departments when experiencing a behavioral health crisis. These options are rarely the most appropriate or effective way of deescalating a crisis.

Behavioral health crisis response services, on the other hand, are developed and designed specifically to address the unique needs of individuals experiencing a mental health or substance use emergency. They provide services and supports necessary to stabilize the immediate crisis and linkages to community resources that can help maintain that stability.

Maryland’s crisis call centers provide free, confidential, 24/7 support and referrals to care for Marylanders in crisis. These centers have seen increased call volumes over the past year as demand for behavioral health services has increased and public awareness about 988 has grown. This requires an additional investment to ensure our call centers have everything they need to effectively handle this influx of new calls.

For these reasons, MHAMD supports SB 3 and we urge a favorable report.

Behavioral Health System Baltimore (BHSB) is a nonprofit organization that serves as the local behavioral health authority (LBHA) for Baltimore City. BHSB works to increase access to a full range of quality behavioral health (mental health and substance use) services and advocates for innovative approaches to prevention, early intervention, treatment, crisis response, and recovery for individuals, families, and communities. Baltimore City represents nearly 35 percent of the public behavioral health system in Maryland, serving over 78,000 people with mental illness and substance use disorders (collectively referred to as “behavioral health”) annually.

Behavioral Health System Baltimore strongly supports SB3 9-8-8 Trust Fund – Funding. This bill will invest an additional \$12 million into the 988 Trust Fund in FY2025. This funding is needed to ensure the Maryland 988 Suicide & Crisis Lifeline network has dependable funding to increase capacity and strengthen 988 helpline services.

The 988 Suicide & Crisis Lifeline launched nationwide in July of 2022, establishing the first universal three-digit phone number for suicidal and behavioral health crisis helpline services. The new number uses the existing Lifeline network of helpline providers, representing a transition from the previous ten-digit 1-800 number and not an entirely new service. Maryland’s 988 Lifeline network is made up of eight experienced community-based organizations that cover the entire state. They have been providing free, confidential, 24/7 supportive counseling and community resources for over twenty years and three providers now offer text and chat in addition to call services.

The transition to 988 is an exciting opportunity to raise the profile of Lifeline services and invest in these life-saving interventions. Maryland has taken several important steps to invest in its 988 Lifeline network and is well-positioned to continue strengthening its helplines. Last year, the General Assembly allocated \$5 million to support the 988 Lifeline, representing essentially the first time Lifeline providers received state funding for these services. The Lifeline has been undervalued and underfunded for decades and these state dollars have proven invaluable in keeping up with demand. This body also passed [SB241](#), which established the 988 Trust Fund to provide longer-term funding and support. The legislation directed \$5.5 million to the 988 Trust Fund in FY24 and SB3 will build on this to provide an additional \$12 million to support the network through FY25.

This infusion of funding is critical to keep up with the anticipated increase in call volume. In Baltimore, calls to our Here2Help Lifeline doubled during the pandemic and call volume has only continued to increase. Across the state, Lifeline call volume was 50% higher in December 2022 than in December 2021, while chat doubled, and texts increased five-fold. Overall, 2022 call, chat, and text volume was about 35% higher than 2021, with significant and ongoing increases starting in July with the transition to 988. The increase in demand is understandable, as Maryland communities have shown significant increases in mental health challenges. Everyone has been affected by the trauma, uncertainty, and isolation wrought by the pandemic, and this has hit young people especially hard. Marylanders need

access to more mental health services today than ever before and the 988 Lifeline is helping to meet that need.

The increase in Lifeline call, chat, and text contacts is also in line with a 2021 SAMHSA-funded analysis of likely Maryland demand for services and required funding. This analysis found the state would need \$10-17 million in the first year to support adequate capacity in the 988 Lifeline network and increased funding in every subsequent year as familiarity with 988 increased. The \$12 million allocation in SB3 is likely a significant underestimation for FY25, the third full year after the 988 transition and two years after the \$10-17 million SAMHSA-funded estimate for the first year. This is especially true considering the rising business costs due to inflation and a shortage of behavioral health workers that was not anticipated in the 2021 analysis. The requested \$12 million will be put to good use and provide a safe harbor for the funds, allowing the state and its 988 Lifeline network the security to plan through the Summer of 2025.

Continued and increased investment in the Maryland 988 Lifeline network is needed, and it will provide valuable returns in strengthened services and saved lives. **BHSB urges the Senate Budget & Tax Committee to pass SB 3 and further its investment in the Maryland 988 Trust Fund.**

The Maryland Chapter of the American College of Emergency Physicians (MDACEP), which represents the interests of emergency physicians and their patients throughout the State of Maryland, **supports** Senate Bill 3. This bill requires the Governor to provide a mandatory appropriation of \$12 million for the operation of the 9-8-8 Trust Fund. During the 2022 Session, the General Assembly passed, and the State enacted the 9-8-8 Trust Fund for the purpose of: (1) designating and maintaining 9-8-8 as the universal telephone number for a national suicide prevention and mental health crisis hotline; and (2) developing and implementing a Statewide initiative for the coordination and delivery of the continuum of behavioral health crisis response services in the State.

In 2020, the federal government implemented the National Suicide Designation Act of 2020, which established 9-8-8 as a universal number for mental health crises and suicide prevention. In July 2022, 9-8-8 went live. All phone companies now route 9-8-8 calls to local crisis call centers that are part of the Lifeline network. The local crisis call centers provide 24/7 free, confidential, and emotional support to individuals calling for help. As the public learns of the presence and services of 9-8-8, it is expected that calls to the Lifeline will continue to significantly increase. The need for 9-8-8 and the access to a continuum of crisis services is greater than ever, especially in the wake of the COVID-19 pandemic. According to the Centers for Disease Control and Prevention, suicide has become a leading cause of death in the United States, with the rate the highest in ages 10-34 years old. Maryland needs to ensure that its existing eight local call centers are adequately resourced to support this influx of calls for help.

It is important to recognize that the services provided by 9-8-8 are not static but benefit other health care settings. Maryland emergency departments continue to be inundated with patients experiencing a mental health crisis. Too often, these patients, especially pediatric and geriatric patients, wait hours, days, or weeks in the emergency departments waiting for community-based services. Not only is this detrimental to the health of the patient, but it also limits capacity for individuals more appropriately cared for in the emergency department, such as stroke, heart attack, and car accidents.

Senate Bill 3 ensures that the 9-8-8 Trust Fund has the appropriate and necessary resources to operate effectively and efficiently. MDACEP urges a favorable vote.

The American Foundation for Suicide Prevention (AFSP) writes in strong support of SB 3 to provide much needed funding for the Maryland 988 Suicide & Crisis Lifeline network through the established 988 Trust Fund. AFSP is a nonprofit organization whose mission is to “save lives and bring hope to those affected by suicide” through research, education, and advocacy. AFSP is a thought leader in suicide prevention, the largest private funder of suicide prevention research, and a partner with other mental health organizations on public policy priorities.

State support for and investment in crisis support systems and call centers within the 988 Suicide & Crisis Lifeline network is critical. While the 988 Lifeline is a national program, federal funding is minimal for each center and largely goes toward managing call routing, best practice standards, public messaging, and technical assistance. Local crisis centers therefore rely on funding from state and local contributors to operate and grow.

While I am representing AFSP in providing this testimony, I also currently serve on the Maryland Governor’s Challenge to Prevent Suicide among Service Members, Veterans, and Families and as a Commissioner on the Maryland Governor’s Commission on Suicide Prevention in which I chair the newly created postvention (support to individuals and communities to mitigate grief, distress, and increased suicide risk in the aftermath of a completed suicide) task force. I have been a licensed independently practicing Psychologist in the State of Maryland since 1986 and was employed for a decade as a subject matter expert in military psychological health care and evidence-based psychological research and clinical practices.

Suicide is a mental health and public health issue nationwide and the 11th leading cause of death overall in Maryland (CDC; 2021). Tragically, suicide is the third leading cause of death in Marylanders ages 10 – 34. Young people involved in the child welfare and juvenile justice systems; LGBTQ individuals; Black, Indigenous, and other people of color; and military Service members and Veterans are at even greater risk for suicide. I lost my uncle, grandfather, and mother to suicide. As a suicide loss survivor and a volunteer facilitator with AFSP programs that support suicide loss survivors (Healing Conversations, International Survivors of Suicide Loss Day), I can attest to the devastating impact of suicide and suicide attempts on individuals, families, and communities.

In January 2022, the Journal of the Medical Association (JAMA) published the first study to use nationally representative population data to assess the prevalence and risk factors for suicide attempts. The findings demonstrate a substantial increase in suicide attempts from 2008 – 2019. A prior suicide attempt is the most significant risk factor for a completed suicide; this knowledge terrified me when my oldest daughter in her teenage and young adult years experienced a protracted course of a severe eating disorder accompanied by suicidal thoughts and suicide attempts.



Although suicide attempts have increased over the past decade, the use of mental health services among those who have attempted suicide has not increased. In addition to engaging in population-wide suicide prevention efforts, this data strongly suggests a need to expand service accessibility and acceptability for these at-risk individuals (Bommersbach, Rosenheck, & Rhee, 2022). Accompanied by public education campaigns to normalize help-seeking in a crisis, 988 has the potential to engage suicide attempters in accessing mental health services.

As a practicing clinical psychologist who has worked with individuals who struggle with mental health conditions accompanied by suicidal thoughts, a parent who was in despair and desperate to keep her child alive during a protracted course of a life-threatening mental illness, and a daughter who lost her beloved mother to suicide, I have experienced a fragmented system of crisis care that relies on law enforcement, jails, and hospital emergency departments. This inherently ineffective approach to urgent and emergent behavioral health yields poor outcomes. The establishment of 988 as a national mental health crisis care system is an important component of access to quality mental health and effective suicide prevention.

An appropriately resourced 988 system consists of immediate access to an effective and coordinated system of suicide prevention crisis services. Crisis call centers are the hub of this integrated system which also includes access to mobile crisis teams and crisis stabilization centers. Evaluations of the National Suicide Prevention Lifeline (NSPL) have established the effectiveness of crisis line services as suicide prevention tools while also identifying the need for continued development of a robust and integrated crisis response system to meet the needs of individuals in mental health crisis (Gould, 2021).

Utilization of crisis call centers reduces the burden on emergency rooms, police, emergency responders, and other mental health emergency services. Almost 98% of crisis calls to the NSPL were de-escalated averting costly, highly restrictive responses from law enforcement and emergency medical services (988 Suicide & Crisis Lifeline, 2023). In a study of high-risk callers to the NSPL, most recipients interviewed reported that this intervention stopped them from taking their lives (79.6%) and kept them safe (90.6%) (Gould et al., 2017).

To increase access to crisis services, Lifeline's services now also include chat and texting. The users of these formats tend to be younger and have higher rates of suicidal ideation than callers. A study assessing the effectiveness of the Lifeline's Crisis Chat found that 2/3 of suicidal chatters reported that the chat had been helpful while almost half reported being less suicidal by the end of the chat. For a single-session chat intervention to achieve a reduction in suicidality in nearly half of chatters is a significant accomplishment that affords the opportunity for further suicide risk reduction and mental health interventions (Gould, Chowdhury, Lake et al., 2021).

The NSPL received over 2.6 million calls, chats, and texts in 2020. The Veteran's Crisis Line which shares the Lifeline's national toll-free number received 35,000 calls during the recent Afghanistan evacuation in mid-August 2021 (Washington Examiner, 2021). On July 16, 2022, the three-digit 988 dialing code replaced the Lifeline phone number. With the introduction of the 988 number and campaigns to increase public awareness about 988, call, chat, and text volume has further increased. In just the first month of 988's launch, data confirmed that calls to the Lifeline increased nationally by 45%. One month after the launch, in August 2022, there were 928 more calls made by Maryland residents to the Lifeline compared to August 2021, a 30% increase (988 Suicide & Crisis Lifeline, 2023).



Crisis line users are a high-risk population that require reliable and timely response and culturally competent local responders trained in suicide-specific assessment and best practices for crisis care (Hoffberg, Stearns-Yoder, and Brenner, 2020). Maryland's crisis call centers need the additional funding as called for in SB 3 to ensure they have adequate staffing and resources to meet increases in demand resulting from the 988 transition. The 988 model of care for mental health crisis care is cost-effective as demonstrated by numerous studies showing that crisis services reduce spending on emergency department visits and inpatient hospitalizations. Cost-savings are also realized through reduced use of law enforcement for mental health emergencies (Vibrant Emotional Health, 2021).

In November 2021, AFSP along with the American Psychological Association, and 13 additional organizations authored a consensus report of recommendations for the development of a comprehensive crisis response system (AFSP, 2021). As the report concludes, our nation has been failing those in mental health crisis. 988 is more than a new number to call; it is an opportunity to rethink how we can more effectively approach mental health, substance use disorders, and suicide prevention in our communities. Thank you for the opportunity to submit testimony in support of SB 3. The AFSP Maryland Chapter is grateful for your consideration of this critical bill and strongly urges your support.

My name is Eileen Zeller and I retired from the federal government’s Substance Abuse and Mental Health Services Administration (SAMHSA) in 2018, where I was Lead Public Health Advisor in the Suicide Prevention Branch. In that role I managed a team of public health professionals responsible for national grant programs including the National Suicide Prevention Lifeline, Suicide Prevention Resource Center, and a range of state, tribal, and campus suicide prevention programs.

In retirement, I chair the Maryland Governor’s Commission on Suicide Prevention and serve on the board of directors of the Mental Health Association of Maryland. But today I am representing myself.

The Governor’s Commission on Suicide Prevention is dedicated to promoting comprehensive and coordinated programs and services designed to reduce the incidence of suicide and suicide attempts, and to promote resilience, hope, and healing. The Commission is charged with developing a state Suicide Prevention Plan every two years. In the 2022-2024 Plan that we submitted to the Governor this past fall, we called for strengthening Maryland’s crisis care system, including integrating 988 with crisis response services.

The 9-8-8 Trust Fund addresses this issue by implementing a statewide initiative to coordinate and deliver the continuum of behavioral health crisis response services, including crisis call centers, mobile crisis team services, crisis stabilization centers, and other acute behavioral health care services.

Communities with a continuum of behavioral health crisis services provide people in crisis with appropriate care: the right care in the right place at the right time. They divert people from emergency rooms and from criminal justice involvement, and prevent hospital readmissions, overuse of law enforcement, and suicide.¹ Maryland’s 9-8-8 crisis centers stand at the heart of that continuum.

As anticipated, Maryland’s launch of 988 in July 2022 resulted in significant increases in crisis calls and texts. SB3 would increase the allocation for the 9-8-8 Trust Fund and help ensure sustainable funding so that Marylanders in crisis are connected to the services they desperately need, when they need them.

I therefore urge a favorable report on SB3.

On behalf of the Maryland Hospital Association's (MHA) 60 member hospitals and health systems, we appreciate the opportunity to comment in support of Senate Bill 3.

Hospital emergency departments are often the first point of contact or the facility of last resort for individuals suffering from a behavioral health crisis. Patients and families turn to an emergency department for care when they cannot find treatment in the community or when the condition worsens to a point where an individual is at risk of dying by suicide.

Between 2013 and 2021, emergency department visits for behavioral health conditions climbed from 10.5% to 18.3%. Analysis also shows patient acuity increased—meaning, there are more patients turning to emergency departments in crisis, and they are sicker when they get there.¹

The federally mandated transition to 9-8-8 as the behavioral health crisis helpline presents Maryland with an opportunity to transform care for those with behavioral health needs with the goal to reduce suicide deaths and overall behavioral health harm.

Maryland transitioned to 9-8-8 this summer, and since then, call volume has continued to rise. Last year, this body passed [SB241](#), which established the 9-8-8 trust fund and appropriated funding for fiscal years 2023 and 2024. Senate Bill 3 ensures this life-saving funding continues in fiscal year 2025.

The need is great, and it is imperative Maryland have a robust crisis services system to serve patients before they need to turn to emergency departments. The 9-8-8 trust fund dedicates funding for call centers, crisis stabilization centers, mobile crisis teams, and other components of a crisis system of care.

For these reasons, MHA urges a favorable report on Senate Bill 3.





Mental health and substance use crisis services for anyone, anywhere, anytime

1. What is 988?

It is the new easy-to-remember phone number for the 988 & Crisis Lifeline. The 988 Lifeline is available around the clock, 365 days a year. Counselors at local crisis call centers answer the calls and provide free, confidential advice and emotional support for people in distress. It is not only about answering calls but also about providing connection to community mental health and substance use services at critical moments for people across Maryland.

2. When did 988 go live?

The new 988 number launched in July 2022. All phone companies will now route 988 calls to local call centers that are a part of the 988 Suicide & Crisis Lifeline network.

3. How will 988 help our communities?

Many people experiencing a mental health or substance use emergency call 911 or go to a hospital emergency room for help, which can cause delays in care, frustration, and potentially more harm than help for the person in distress. This is even more pronounced for people of color and other marginalized groups. Police are not well-equipped to deal with a mental health or substance use emergency, and their involvement too often leads to trauma, jail, or the inappropriate use of force – including the death of the person in need.

988 can serve as an alternative to calling 911 or going to the hospital emergency room for people facing a mental health or substance use emergency. Call center counselors are based locally and trained in crisis response, suicide prevention, and de-escalation. They can provide a range of support to resolve a situation over the phone. 988 counselors can ensure that people in crisis receive responsive, appropriate, and compassionate services, and reduce our reliance on law enforcement and hospitals.

4. What is the Fund MD988 Campaign?

The Fund MD988 Campaign is working to secure dedicated funding to support the continuum of behavioral health crisis services to meet Maryland's needs. Maryland currently does not provide 24/7 crisis services in all communities, and investments are needed to build out the 988 call centers and other crisis response services such as mobile crisis teams and crisis stabilization centers. The Campaign secured over \$10 million in funding during the 2022 Maryland legislative session and aims to build on that success to continue to strengthen and grow the Maryland behavioral health crisis response system.

5. Why does Maryland need to invest in 988 and other crisis services?

Without expanding staff and services, Marylanders in distress will continue to turn to hospital emergency rooms. Maryland's local 988 call centers need funding to hire and train the staff needed to meet the projected demand for 988. Calls have already increased by 30% compared to 2021 and call volume will only continue to rise as more people learn about 988. Timely and dependable 988 responses, as well as other community interventions, are critical to preventing suicides, resolving crises, and saving lives.

The National Alliance on Mental Illness, Maryland and our 11 local affiliates across the state represent a statewide network of more than 45,000 families, individuals, community-based organizations, and service providers. NAMI Maryland is a non-profit that is dedicated to providing education, support, and advocacy for persons with mental illnesses, their families and the wider community.

As you are likely aware July 16, 2022 marked the launch of the 988 Suicide & Crisis Lifeline, the first nationwide three-digit phone number for mental health and substance use crises. The new number builds off an existing Lifeline network of over 200 helplines across the country.

Maryland established a 988 Trust Fund with an initial funding level of \$5.5 million available starting in fiscal year 2024 for the purpose of developing and implementing a statewide initiative for the coordination and delivery of the continuum of behavioral health crisis response services in the State, including: (1) Crisis call centers; (2) Mobile crisis team services; (3) Crisis stabilization centers; and (4) Other acute behavioral health care services. SB 3 would require a state budget allocation of \$12 million for fiscal year 2025.

Many communities are committed to diverting people with mental illness away from the criminal justice system. However, in order to do so, communities need effective mental health services, such as outpatient, inpatient and crisis care and coordination. By more than doubling the allocation for the 9-8-8 Trust Fund, passage of **SB 3** will ensure Maryland's 9-8-8 system will be better suited to handle rising call/text volume of people seeking crises services, as well as ensure individuals are connected to the service they need.

Good afternoon, Chairman Guzzone and Members of the Senate Budget and Taxation Committee. I am Lois Meszaros, Ph.D. AARP member, and resident of Anne Arundel County. As you may know, AARP Maryland is one of the largest membership-based organizations in the Free State, encompassing almost 850,000 members. **AARP MD supports SB3 9-8-8 Trust Fund - Funding.** We thank Senator Augustine for sponsoring this legislation.

SB 3 provides that in fiscal year 2025, the Governor shall include in the annual budget bill an appropriation of \$12,000,000 to the 9–8–8 Trust Fund. This appropriation would support the Trust Funds’ efforts in developing and implementing a statewide initiative for the coordination and delivery of the continuum of behavioral health crisis response services in the State, including: (i) Crisis call centers; (ii) Mobile crisis team services; (iii) Crisis stabilization centers; and (iv) Other acute behavioral health care services.

At least one in five older Americans has a mental health condition. Among Medicare beneficiaries age 65 and older, the most common mental disorders are depression, anxiety, dementia, and other neurocognitive impairments. By 2030, the number of older people with such disorders is expected to double.

Mental disorders seldom occur in isolation and can often lead to serious physical health issues. However, they are frequently undiagnosed or misdiagnosed in older patients. Older adults are more likely than younger adults to receive inappropriate or inadequate mental health services. One reason is that primary care practitioners—who provide most mental health care under Medicare—have insufficient training in the assessment and treatment of mental disorders associated with aging. Perceived social stigma and denial can also impede accurate diagnosis and treatment.

While Medicare’s coverage of mental health and substance abuse services has improved over the years, restrictions that do not apply to other health services remain. These include a lifetime limit of 190 days for psychiatric care in freestanding psychiatric hospitals. Medicare covers some mental health-related preventive services with no cost-sharing, including annual screenings for depression and alcohol misuse screening. But coverage for subsequent services can be limited and should be increased.”

After retiring and returning to Severna Park, I began receiving calls from older adults saying that Novitas Solutions, Inc., which manages the insurance for Medicare patients, recommended they

contact me as I was new to the area and might be accepting new patients. These older adults had been unable to locate a therapist who was accepting new patients, as therapists are overwhelmed with referrals. These older adults were expressing feelings of isolation, anxiety, and depression resulting from events such as losing loved ones during Covid, experiencing residual effects from having Covid and being isolated due to many of their previous activities going virtual. Many older adults do not have the equipment, funds to purchase the equipment, or the knowledge to function in the virtual realm. For many older adults this has become a frightening new world that they are finding difficult to navigate. Having a phone number (988) to call is a quick and easy way for them to get help and is easy to remember. By calling 988 they receive immediate access to a trained mental health professional who is available 24/7 and able to listen and assist with current behavioral health problems.

The development, implementation and expansion of mobile crisis team services has greatly benefitted older adults as it brings crisis services to them. Some older adults are no longer able to drive and obtaining transportation is both difficult and costly. Having a trained team come to their home with needed assistance rather than trying to get to an emergency room or doctor's office is so much more effective and efficient. Helping older adults get appointments within 24 to 48 hours has prevented crisis situations from escalating.

During my years of work, I have seen a major expansion in the request for behavioral health services. This is true for older adults who are experiencing a way of life that is less human contact and more social media. Older adults enjoy socializing, having lunch at the senior center and sitting next to their neighbors in church. They want to hug their grandchildren and talk to them not communicate by text. Having stabilization centers available where older adults can feel safe and get support is adding a needed service. Often removing a person from a toxic environment even briefly, will improve the situation.


As a psychologist in Maryland, I am aware of the unmet need for services. People needing help are often waiting days and even months for services. The passage of this bill will help provide needed behavioral health services to thousands of people who are seeking crisis services.

Significant gaps remain in making emergency crisis services for people with mental health needs more accessible. In Howard County, we continue to see stark racial disparities in mental health, especially among Black and Latino residents. In 2014-2016, suicide was the leading cause of death for youth ages 15-19 in Howard County.ⁱ Among these youth, young Latina women are most at risk of depression and planning a suicide. Nearly 50% of Latina high schoolers and 42% of multiracial female high schoolers said they felt sad and hopeless in comparison to 23% of White students and 26% of Black students.ⁱⁱ Among adults, Black residents are most likely to say they have been “bothered” by “feeling down, depressed or hopeless” and by “having little interest or pleasure in doing things,” which are two indicators of risk for depression.ⁱⁱⁱ

These rates are startling and reflect larger systemic issues and the need for expanded mental health and behavioral health crisis services – including and beyond 988. Ensuring sustainable funding to support local crisis call centers and other crisis services is critical to meeting the needs of our community members and saving lives.

Maryland has a strong foundation that can be built upon to create the robust 988 network that will keep residents safe and well, but continued investment is needed. The Horizon Foundation urges the Senate Budget and Taxation Committee to pass SB 3. Thank you for your consideration.

I am writing in SUPPORT of SB3. LifeBridge Health is a regional health system comprising Sinai Hospital of Baltimore, an independent academic medical center; Levindale Geriatric Center and Hospital in Baltimore; Northwest Hospital, a community hospital in Baltimore County; Carroll Hospital, a sole community hospital in Carroll County, and; Grace Medical Center in Baltimore (formerly Bon Secours Hospital).

Behavioral health crisis services and the suicide prevention lifeline are effective interventions that reduce the likelihood of inpatient hospitalization and help prevent tragic deaths due to suicide or overdose. The 988 national suicide prevention and behavioral health crisis hotline provides a once in a generation opportunity to strengthen Maryland’s behavioral health system, and adequate funding such as the proposed \$12M mandated appropriation will ensure the needed services are provided.

We have consistently seen increased numbers of individuals in mental health or suicidal crisis present to our emergency rooms. Whether brought by EMS in an ambulance, or by law enforcement, or even by family members, these capable and well-meaning responders simply do not have the capacity to provide the care people need when in crisis. Like all providers, LifeBridge has seen an increase in behavioral health needs during the pandemic, but the problem predates the pandemic. This steady increase drove a redesign of our Emergency Room to provide more capacity for behavioral health patients. While this additional capacity will enhance care for these patients, it does not guarantee the type of response individuals need when in crisis. Hospital emergency rooms are not optimal sites for addressing the needs of people experiencing suicidal or other behavioral health crisis, as hospitals must also triage life-threatening medical emergencies, resulting in delays of hours or even days for behavioral crisis patients.

LifeBridge and our hospital partners are committed to supporting crisis services through regional catalyst programs like the Greater Baltimore Regional Integrated Crisis System (GBRICS). Strengthening our local network of crisis call centers through a fully funded 988 Trust Fund will help ensure these system enhancements are successful.

For all the above stated reasons, we request a **FAVORABLE** report for SB3.

RE: Senate Bill 3 – 9–8–8 Trust Fund – Funding – Letter of Support

Dear Chair Guzzone and Committee Members:

The Health Services Cost Review Commission (HSCRC) requests that the Committee favorably report Senate Bill 3, the 9–8–8 Trust Fund. HSCRC, through the hospital rate-setting system, has invested \$79.1 million seed funding over five years to develop sustainable, evidence-based crisis services in Maryland through the HSCRC’s Regional Partnership Catalyst Program. A high functioning 988 system is crucial to support these investments. 988 functions as a gateway, connecting individuals in crisis to the resources developed by the Regional Partnerships, including mobile crisis teams, crisis stabilization centers, and same-day referrals to behavioral health providers. Without a well-funded 988 system, the Regional Partnerships would not reach as many patients, reducing the impact of the money that hospitals and health care payers have invested in the Regional Partnerships.

The Regional Partnership Catalyst Program provides funding to hospital-led projects that work across statewide geographic regions to build infrastructure for interventions that align with goals of the Total Cost of Care (TCOC) Model and support population health goals in the Statewide Integrated Health Improvement Strategy (SIHIS). One of the three population health priority focus areas in SIHIS is opioid overdose mortality. Opioid use is directly connected to broader behavioral health issues, as many people who use opioids also have other behavioral health concerns. To support this SIHIS goal, HSCRC used the Regional Partnership Catalyst Program to support the implementation and expansion of the evidence-based “CrisisNow” behavioral health crisis management model in Maryland.¹ Funding recipients are implementing and expanding at least one of the three main elements of the CrisisNow Model:

1. Crisis call centers and “Air Traffic Control” services, which help connect individuals in crisis to needed services;
2. Community-based mobile crisis teams, and
3. Short-term, “sub-acute” residential stabilization programs.

Through a competitive process, HSCRC awarded funds to three regional partnerships. A core goal of the Regional Partnership Catalyst Program is to foster widespread collaboration between hospitals and community partners. Under this program, hospitals are partnering with neighboring hospitals and diverse community organizations including local health departments (LHDs), local behavioral health authorities (LBHAs), provider organizations, and non-profits to expand behavioral health crisis services infrastructure. In 2021, Regional Partnerships worked with a total of 136 community partners to expand crisis services.

The second funded year of these programs has just ended. In the first year (2021) Regional Partnerships prioritized putting business agreements in place, finalizing memorandums of understanding, and procuring contracts necessary for implementing activities in CY 2022. TRIBE focused on preparing to open two crisis stabilization centers. Both of these centers opened in 2022 and are serving individuals in crisis on the lower eastern shore. G-BRICS and TLC focused efforts on procuring software to implement “air traffic control” systems and expanding mobile crisis teams in their service area in CY 2022. GBRICS has also continued to expand access to same-day care through its Open Access Pilot and TLC plans to open its stabilization center in Prince George’s County this year.

The Commission urges a favorable report on SB 3 to fund vital 988 services throughout Maryland. WRITTEN TESTIMONY IN SUPPORT OF SB 3: 988 Trust Fund - Funding

Thank you Chair Guzzone, Vice Chair Rosapepe, and committee members for improving the quality and accessibility of healthcare services for Marylanders. On Our Own of Maryland (OOOMD) is a statewide behavioral health (BH) education and advocacy organization, operating for 30 years by and for people with lived experience of mental health and substance use challenges. Our network of 20+ affiliated peer-operated Wellness & Recovery Centers throughout the state offer free, voluntary recovery support services to nearly 6,500 community members with mental health and substance use challenges.

We strongly support Senate Bill 3, which provides necessary funding to make the national 988 hotline and associated services the more effective, less traumatizing alternative to dialing 911 for behavioral health crises.

Delivering crisis response services in a timely and trauma-informed manner requires adequate resources to maintain strong infrastructure. This bill provides necessary funding for 988-responsive services to maintain staffing levels, training standards, and functional technology for real-time coordination and effective intervention.

988 creates opportunities to resolve BH crisis situations through voluntary, supportive, and cost-effective options such as phone counseling, mobile response teams, and walk-in clinics. However, 988 call centers cannot offer or connect individuals in distress with community services that don't exist or aren't available 24/7 due to a lack of stable or adequate funding. This bill bolsters both the 988 call centers as well as a continuum of crisis support services: Mobile Crisis Teams, Crisis Stabilization Centers, and other acute behavioral healthcare services.

Dedicating funding to support these community-based services decreases reliance on law enforcement as the default available responder for BH crisis scenarios, with important immediate and long-term positive impact for individuals and families. Too often, we hear people report frightening, unhelpful, and stigmatizing experiences due to non-specialty emergency responders' lack of understanding or skill. These bad experiences not only hurt or harm in the moment, but they create lasting mistrust and resistance to engaging with crisis services in the future.

On Our Own of Maryland strongly urges you to support SB 3's critical investment in our crisis response system, to make sure all Marylanders receive quality, effective, respectful, and real-time support when seeking help in their most vulnerable and difficult times. Thank you.

Senate Bill 03 will require the Governor to include in the fiscal 2025 annual budget bill an appropriation of \$12.0 million to the 9-8-8 Trust Fund.

Behavioral health issues, including depression and suicide, are public health challenges that cause immeasurable pain among individuals, families, and communities across the country. This is an urgent issue that the Maryland General Assembly and citizens of Maryland must address. Senate Bill 03 is a crucial step for Maryland to meet the needs of individuals facing a serious behavioral health crisis.

NCADD-Maryland supports support Senate Bill 3 – 9-8-8 Trust Fund – Funding. This bill requires the Governor to include in the budget bill for fiscal year 2025 an appropriation of \$12,000,000 to the 988 Trust Fund established by the legislature last year.

The new Lifeline 988 Lifeline went into effect last July and existing funding has already helped Lifeline providers around the state hire new staff and respond to a 20% increase in call volume. It is expected that calls will significantly increase as word about the Lifeline continues to spread. Maryland must ensure that its eight regional call centers are adequately resourced to support an increase of calls for help.

The state will also need to build out other related crisis response services such as crisis stabilization centers and mobile response teams that go into the community in order to support 988 callers who need a higher level of care. Senate Bill 3 will ensure funding will be available.

We urge a favorable report on Senate Bill 3.

The Maryland Affiliate of the National Council on Alcoholism and Drug Dependence (NCADD-Maryland) is a statewide organization that works to influence public and private policies on addiction, treatment, and recovery, reduce the stigma associated with the disease, and improve the understanding of addictions and the recovery process. Inspired by the Gospel to love, serve and teach, Catholic Charities provides care and services to improve the lives of Marylanders in need. For 100 years, Catholic Charities has accompanied Marylanders as they age with dignity, obtain empowering careers, heal from trauma and addiction, achieve economic independence, prepare for educational success and feel welcome as immigrant neighbors. We recognize the need for crisis behavioral health services in our communities.

Crisis call centers are often the first interaction that people have with the local mental health system. It is critical that it be fully funded and sustainable to connect individuals and families who call with the immediate assistance that they need. They serve as safe places where people seeking support can call 24/7, regardless of their ability to pay for the service or their enrollment in specific programs. They make critical connections for individuals and families to local mental health providers to provide assessments and ongoing services to try and mitigate the need for a law enforcement response.

We have seen the benefit of having a call center through Baltimore City's Health Crisis Hotline which among other duties triages calls for our BCARS program, a crisis program for children and adolescents in Baltimore City. By operating in this way there is an immediate referral for youth and families so that they are not either stuck in the emergency room seeking services outside of the scope of what the hospitals provide or languishing on a wait list for an opening at a local Outpatient Mental Health Clinic (OMHC).

While this hotline served an important service for the local area, Maryland is aligning with national efforts to improve access to crisis care by designating 988 as the number for the entire state and ensure adequate funding to support local crisis call centers. We must continue to invest in 988 to ensure the system has the capacity to serve all Marylanders.

For the reasons listed above, Catholic Charities of Baltimore appreciates your consideration, and urges the committee to issue a favorable report for SB3.

The Licensed Clinical Professional Counselors of Maryland (LCPCM) supports *Senate Bill 3 – 988 Trust Fund - Funding*. This bill requires \$12 million in state funding for fiscal 2025.

The Maryland Community Health System (MCHS) supports *Senate Bill 3 – 988 Trust Fund - Funding*. This bill requires \$12 million in state funding for the 988 Trust Fund fiscal 2025.

MCHS is a network of federally qualified health centers focused on providing somatic, behavioral, and oral health care services to underserved communities. Many of our patients are Medicaid enrollees. In a report just released this month, the Kaiser Family Foundation estimated that 39% of Medicaid enrollees face behavioral health issues.ⁱ It has always been difficult for people to identify behavioral health resources; and with the recent health care professional shortage crisis, access to care has become more complicated to navigate.

We support this legislation because Maryland consumers need the support of the 988 Program to find services in their community. If we ensure that the program has sufficient resources, we can help Marylanders manage their behavioral health needs and avoid crisis situations.

Marian House is a holistic, healing community for women and their children who are in need of housing and support services. Marian House provides comprehensive support services to assist women with experiences of trauma, including poverty, substance abuse, and chronic mental health issues. **I write to urge you to support Senate Bill 3 – 9-8-8 Trust Fund – Funding.**

Over forty years ago, Marian House was opened to provide reentry supports for women leaving incarceration as Sisters and laywomen recognized that lack of support contributed to recidivism rates. Today, we have also expanded to serve women with histories of trauma including homelessness, incarceration, neglect, substance abuse and mental health needs. Since our opening, we have assisted women in reinventing and rebuilding themselves through services such as: counseling, substance abuse treatment, job training and providing both long and short-term housing. All the women we have served have overcome obstacles on their journeys to become contributing members of society in the Baltimore area.

In FY22 Marian House served sixty-six women in our transitional housing program. Of those sixty-six, 86% had a chronic mental illness and 83% had a substance abuse disorder. The 9-8-8 initiative for a national suicide prevention and mental health crisis hotline is crucial to supporting Marylanders like our clients who are in need of mental health support services. By allotting \$12 million to the 9-8-8 Trust Fund, the services that are run under the initiative will be able function to their greatest ability and provide exceptional service to vulnerable populations in their time of need.

By supporting SB 3, Maryland's most vulnerable populations will have greater access to these support services that have the funding they need to function. On behalf of the women we serve at Marian House, I respectfully urge you to take the call to action in **SUPPORT of SB3.**

The work of our organization is to support the emotional wellness in our community through preparing resilient children, securing vulnerable families, and standing with those in crisis. MHA of Frederick County is the home of the 988 call center for Western Maryland. We have answered the National Suicide line since 2001.

As a provider of this service, we know adequate funding is crucial. We received a \$7,500 annual stipend from the National Suicide Lifeline to provide 24/7 availability for persons in crisis and with thoughts of suicide. The call centers are the foundation of the crisis system structure and provide access to well-trained staff. 90% of calls are handled without additional intervention from more expensive services such as law enforcement or hospital admission. Funding of centers that attracts a quality workforce and highlights the life-saving work that occurs every day is critical.

Maryland has the unique opportunity to align with national efforts to improve access to crisis care by designating 988 as the number for our state's behavioral health crisis hotline and ensuring adequate funding to support local crisis call centers. **Mental Health Association of Frederick County urges the Senate Budget and Tax Committee to pass SB 3.**

Good morning - My name is Tim Jansen I am the Chief Executive Officer of Community Crisis Services in Hyattsville, Maryland. I come to you today in support of Senate Bill three funding the 988 suicide and crisis line bill. My organization has been providing 988 services for the last 52 years – 988 began a little over 20 years ago as the National Hopeline Network. It became national suicide prevention lifeline in early 2005. The movement to three digit dialing from 10 digit dialing as you well know happened last year in July 2022.

Calling 988 is often the first entry an individual has into the mental health system. This can be frightening, overwhelming, and strange. Facing one's mental health struggles or thoughtful suicide is not easy – there is a lot of stigma surrounding mental health and suicide. 988 provides an anonymous opportunity for individuals to seek care, to speak with an informed, counselor, And take the first steps towards safety and wellness.

This resource is available 24 hours every day, 365 days every year. It is imperative that individuals have the opportunity to get care during their time of crisis. Often times, in fact about 90% of the time, the interaction is completed in a phone call. That phone call may just be helping someone to safety plan, to receive a referral for ongoing care, or to just simply work through the difficulties an individual may be facing. If more is needed nine in and counselors are uniquely positioned to connect callers and chatters to urgent care appointments, mobile response teams, and emergency personnel if needed.

In order to ensure ongoing care, the 988 Network needs to ensure that it has resources to provide this life-saving service. That includes ensuring a counselor is available at all times with little to no wait time, it includes ensuring that everyone answering the phone as proper training, it includes ensuring that there is a quality assurance process that shows that we are Following best practices, and it includes ensuring the counselors answering 988 have access to appropriate supervision and self-care.

Three years ago, I lost my mother to suicide. My wonderful 76-year-old mother didn't believe in mental health services. She was brought up in a time when it wasn't talked about – when it was hidden behind closed doors. Even with her son running one of the largest crisis hotline's in the country, she wouldn't reach out. I want to work to ensure that no one else's mom feels that way. I want to make sure that we make 988 is easy to call as it is to call 411 for information or 911 in emergency. No one should succumb to suicide because of the stigma surrounding mental health.

I I heard she does support Senate Bill three to ensure that the 988 network is funded properly so that there are fewer and fewer losses to suicide. Thank you for the opportunity to share this with you.

X-Itcare Specializes in crisis services ie; an online- life-line to help those who are experiencing substance use or mental health crisis and those who are experiencing emotional distress.



Currently, people call 988 expecting confidentiality and privacy. Some callers are surprised when cops break down the door, handcuff them, and haul them off to involuntary psychiatric hospitalization.

988 refers less than two percent of calls to 911. However, because of the huge call volume, that means hundreds of thousands of nonconsensual interventions. Some researchers believe that this humiliating and disempowering experience causes trauma that actually increases the person's chance of committing suicide later on.

What's the alternative? It's crisis lines such as BlackLine, Trans Lifeline, and Samaritans, who have a policy of zero nonconsensual intervention, never forwarding the call to 911.

Fordham University suicidology professor Emily Krebs says, QUOTE While this approach may indeed result in some callers' deaths, I believe that it will allow many more people to call without fear—and will ultimately save more lives while honoring people's autonomy. UNQUOTE

Some people are especially unsafe in an encounter with the authorities, being a trans person, queer person, person of color, undocumented immigrant, or disabled person. But no matter who you are, when you feel blue and want someone to talk to, you don't want to risk getting locked up.

Journalist Rob Wipond reports that the government contractor administering 988, an organization called Vibrant, demands that its participating call centers covertly trace many calls. Vibrant's guidelines, revised on December 27, 2022, state that dispatching emergency services is always an option for the call center workers. Furthermore, Vibrant has made clear its desire to prevent all other crisis lines from receiving calls or related state funding—endangering the survival of any community-based crisis lines that are truly confidential.

Instead of more funding for the coercive framework of 988, please allocate this money to crisis lines that respect the callers' privacy and ultimately help more people survive their emotional crisis.

Dear Chairman Guzzone and Committee Members:

The Maryland Department of Health (MDH) respectfully submits this letter of information for Senate Bill (SB) 3 – 9–8–8 Trust Fund – Funding. The 9–8–8 Trust Fund (Fund) is a non-lapsing fund, established in 2022, to provide funds for the reimbursement of costs associated with designating and maintaining 988 as the universal number for the national suicide prevention and mental health crisis hotline. The Fund also supports the development and implementation of a statewide initiative for the coordination and delivery of the continuum of behavioral health crisis response services.

Maryland successfully launched the 988 Suicide and Crisis Lifeline on July 18, 2022 using funds from the Federal Government. The 988 Suicide and Crisis Lifeline offers free, confidential, 24/7 call, text and chat access to trained crisis counselors who can help people experiencing suicidal, substance use, and/or mental health crisis, or any other kind of emotional distress. The goal of 988 is to provide immediate crisis intervention and support. According to the most recent data from the U.S. Substance Abuse and Mental Health Services Administration (SAMSHA), in November 2022 the 988 Lifeline routed 402,798 contacts.¹

SB 3 requires the Governor to include in the annual budget bill for fiscal year 2025 an appropriation of \$12,000,000 to the Fund. MDH respectfully recommends that the mandated appropriation language be removed. Please see the attached proposed funding sources (page 4). We will continue to work with SAMHSA, other federal agencies, and other stakeholders to identify additional sources of funding.

If the Committee does decide to move forward with this legislation, MDH respectfully recommends that the Committee confer with the appropriate budget committee and the Department of Budget and Management for further discussion as part of the budget process.

Coming soon: The 988 Suicide & Crisis Lifeline

Maryland will soon have a new way to connect to a local behavioral health crisis call specialist. Calling 988 will connect callers directly to the National Suicide & Crisis Lifeline which can provide assistance with substance use or mental health crises.

The 988 Suicide & Crisis Lifeline replaces the National Suicide Prevention Lifeline (1-800-273-8255).

All contacts with 988 (calls, chats, and texts) remain free of charge.

What does this mean for Marylanders?

When someone in Maryland calls 988, the call will be routed based on the caller's area code. For those calls routed to Maryland, the call will be answered by one of the eight strategically-located call centers. These centers provide phone-based support and information regarding local resources.

Maryland has been operating its own crisis hotline (call 211, press 1) which will remain in operation and accessible to Marylanders throughout the transition period and beyond.

When will 988 be implemented?

July 16, 2022 — 988 becomes operational across the nation.

Both 211 press 1 and the existing National Suicide Prevention Lifeline phone number (1-800-273-8255) will remain available. Those experiencing a behavioral health-related or suicidal crisis, or those looking to help a loved one through a crisis, should continue to call 211 and press 1 in Maryland or the Lifeline at its current number(1-800-273-8255) until July 16, 2022.

Who can call 988?

Anyone in need of assistance with behavioral health-related problems.

What can callers expect when they call 988?

Starting July 16, 2022, when calling 988: Callers will hear a greeting message while their call is routed to a Lifeline network crisis call center (based on the caller's area code)

- A trained crisis counselor will answer the phone, listen to the caller, understand how their problem is affecting them, provide support, and provide resources and interventions as needed
- If a Maryland crisis center is unable to take the call, the caller will be automatically routed to a national backup crisis center
- The Lifeline provides live crisis center phone services in English and Spanish and uses Language Line Solutions to provide translation services in over 150 additional languages for people who call 988
- Veterans can access the Veterans Crisis Line by calling 988 and pressing 1

What can someone expect during a chat or text?

- Texts and chats to 988 will also be routed to a Lifeline network crisis call center based on area code.
- A response to chats and texts will be given by a call center staff person

988: The New Way to Connect to Behavioral Health Crisis Services



Starting July 16, 2022, Maryland will have a new way to connect to local behavioral health crisis services.

Calling 988 will connect callers directly to the National Suicide & Crisis Lifeline which encompasses all behavioral crisis services, to include all mental health and substance use (problems with drug and alcohol use).

The 988 Suicide & Crisis Lifeline replaces the National Suicide Prevention Lifeline AND expands services to cover all behavioral health crisis services.

What does this mean for Marylanders?

When someone in Maryland calls 988, it will be routed to one of the state's **eight call centers**. These centers provide phone-based support and information regarding local resources. Marylanders can also text 988.

Maryland has been operating its own crisis hotline, **211 press 1**, and that number **will remain in operation and accessible to Marylanders throughout the transition period and beyond.**

Who can call 988?

Starting July 16, 2022, anyone in need of assistance with behavioral health related needs can call 988.

The new 988 feature is available nationwide for call (multiple languages), text or chat (English only). Both "211, press 1" and the existing Lifeline phone number (1-800-273-8255) will remain available throughout the transition period and beyond.

What can you expect when calling 988?

Starting July 16, 2022, when calling 988:

- Callers will hear a greeting message while their call is routed to the Maryland Lifeline network crisis center (based on the caller's area code)
- A trained call specialist will answer the phone, listen to the caller, understand how their problem is affecting them, provide support, and share resources if needed
- If the Maryland crisis center is unable to take the call, the caller will be automatically routed to a national backup crisis center
- The Lifeline provides live crisis center phone services in English and Spanish and uses Language Line Solutions to provide translation services in over 150 additional languages for people who call 988

How does 988 help Marylanders?

988 call specialists located at crisis call centers around Maryland can immediately provide phone-based support and connections to local resources.

By directing cases to 988 when a behavioral health crisis (mental health and substance use) isn't life threatening, the response provided by public services, such as law enforcement and EMS, can be reserved for situations in which lives are endangered.

In 2020, Congress designated the new 988 calling code to be operated through the existing [National Suicide Prevention Lifeline](#). The [Substance Abuse and Mental Health Services Administration \(SAMHSA\)](#) sees 988 as a first step towards a transformed crisis care system in America.
