Greetings, honorable Chair Feldman, Vice Chair Kagan, and members of the EEE Committee. My name is Lee Blinder, I use they/them pronouns, and I am the executive director of Trans Maryland, a multi-racial, multi-gender community power building organization for Maryland's trans community. Trans Maryland runs the state's largest volume name and gender marker change program, offering peer-to-peer guidance and financial assistance to Marylanders seeking a name and gender marker change, as well as providing support for social and medical transition through our programming that runs twelve months a year. We are deeply proud to serve as Maryland's transgender rights organization.

In addition to my work with Trans Maryland, I also serve as the chair of the policy committee for the Maryland Commission on LGBTQ Affairs, in that capacity and in my capacity as the executive director of Trans Maryland, I ask for a favorable report on Senate Bill 0251.

The Maryland Commission on LGBTQ Affairs was created through legislation in 2021 by the Maryland General Assembly, and provides the first official representation in Maryland state government offices and agencies for LGBTQIA+ persons. The LGBTQIA+ community has lacked representation on the state level, and the creation of The Maryland Commission on LGBTQ Affairs was an essential first step towards addressing the significant barriers facing this historically and currently marginalized community. SB 0251 will make a few small but impactful changes to the legislation to assist the commission to fully realize our potential as the mouthpiece of the community to Maryland's government and governmental agencies, and ensure that all members of the community find themselves represented. These changes include, modernizing the acronym to use more inclusive language to reflect intersex, agender, asexual, and aromantic persons, expanding the number of commissioners to be consistent with the size of other similar commissions in the Governor's Office of Community Initiatives, and adding an additional detail to the language about the qualifications for membership of the commission to ensure the commission reflects the socioeconomic diversity of the State.

We urge a favorable report on this Bill SB 0251 to ensure the Commission on LGBTQ Affairs will embody the words of the first Black governor of Maryland - Governor Moore - who reaffirmed his pledge in his recent State of the State that we will leave no one behind, and enable the Commission to adequately reflect the diversity of the community we represent.

Good afternoon, Mr. Chair and members of the committee. Thank you for the opportunity to provide informational testimony on SB 0251 on behalf of the Maryland Commission on LGBTQ Affairs. My name is Jeremy Browning, I am the Administrative Director of the Maryland Commission on LGBTQ Affairs.

I would like to commend the members of the General Assembly for their work on behalf of our LGBTQIA+ community and their families. The efforts to create a Commission and Office to address the needs and issues of the communities are laudable.

The Maryland Commission on LGBTQ Affairs was created by the 2021 Maryland General Assembly to assess challenges facing our LGBTQ community, collect data across state agencies, study and establish best practices for LGBTQ inclusion, and offer testimony on issues concerning LGBTQ persons before legislative and administrative bodies.

Senate bill 251 aims to make the commission more inclusive and representative of the diverse LGBTQIA+ communities in Maryland.

The bill would rename the commission to be the Maryland Commission on LGBTQIA+ Affairs, reflecting the inclusion of lesbian, gay, bisexual, transgender, queer, questioning, intersex, agender, asexual, aromantic, and additional identities.

The bill would increase the number of commissioners from 15 members to 21 members which is consistent with the size of many other commissions in the Governor's Office of Community Initiatives. The bill also proposes changes to the membership of the commission by using more

specific language and in addition to the previous requirements that members reflect the age, gender, sexual orientation, racial, ethnic, socioeconomic, and geographic diversity of the state.

Additionally, the bill removes the unnecessary use of "women and LGBTQIA+ persons," since women are already included in the LGBTQIA+ acronym.

With this information, Mr. Chair and members of the committee, I conclude my testimony. I am optimistic that the Commission will work hard and have tremendous success in improving the lives of our LGBTQIA+ communities and their families. I look forward to furthering those activities and I would be happy to answer any questions.
