## Written Testimony Senate Bill 168 - Maryland Developmental Disabilities Council – Establishment Senate Finance Committee – February 7, 2023

#### Support

**Background: Senate Bill 168** would establish the Maryland Developmental Disabilities Council to promote inclusive communities and equity in services for individuals with disabilities in the State; research best practices and provide related training and technical assistance to communities in the State; and inform State and local leaders about disability issues.

Written Comments: The Baltimore Jewish Council represents The Associated: Jewish Federation of Baltimore and all of its agencies. This includes Jewish Community Services (JCS), which provides counseling, advocacy, and case management services to adults, and families of individuals with disabilities. Other services include assistance with independent living skills, tutoring, and locating and obtaining special equipment. JCS works with the Developmental Disability Administration (DDA) to obtain and fund resources and services.

Additionally, JCS has residences established to enable adults with developmental disabilities to live as independently as possible and participate fully in community life. Currently, JCS operates nine professionally staffed homes, each with 3 to 4 participants, in Northwest Baltimore City and Baltimore County who receive residential funding from the Developmental Disabilities Administration (DDA).

As large advocates and supporters of the developmental disability community, this agency of the Associated would benefit greatly from the establishment of the Council proposed in SB168 for guidance, best practices, training, and more.

The Associated strives to foster a welcoming and inclusive community for all community members, and as such, supporting people of all abilities, their caregivers, and loved ones is a priority. Disability impacts all of us. According to the CDC, 25.6% of adults in the U.S. and 21.5% of adults in Maryland have some type of disability (*Disability & Health U.S. State Profile Data for Maryland (Adults 18+ years of age)*). For these reasons, the Baltimore Jewish Councils asks for a favorable report on SB168.

The Baltimore Jewish Council, a coalition of central Maryland Jewish organizations and congregations, advocates at all levels of government, on a variety of social welfare, economic and religious concerns, to protect and promote the interests of The Associated Jewish Community Federation of Baltimore, its agencies and the Greater Baltimore Jewish community.

# SB168- Maryland Developmental Disabilities Council - Establishment Senate Finance Committee February 7, 2023

**Position: Support** 

The Arc Maryland is a statewide non-profit advocacy organization dedicated to advancing and protecting the rights and quality of life of people with intellectual and developmental disabilities. The Maryland Association of Community Services (MACS) is a non-profit association of over 100 DDA-licensed agencies that provide community supports to people across the state. We support SB168 as it will establish the Maryland Developmental Disabilities (DD) Council as an independent unit of state government, outlines requirements of the Council that mirror federal law, and clarifies the purpose of the Council; to address identified needs through advocacy, system change, and capacity building efforts that promote self-determination, integration, and inclusion.

<u>Background:</u> There are 56 DD Councils nationally- one in every state and US territory. The Maryland Developmental Disabilities Council (MDDC) is an independent, public policy organization that creates change to make it possible for people with developmental disabilities to live the lives they want with the support they need. Currently, the MDDC is positioned under the Maryland Department of Disabilities, but this structure is not necessary, nor does it align with the independent, self-governing nature of the MDDC. The MDDC operates under a federal mandate and with federal funding, reporting directly to the Administration for Community Living of the US Department of Health and Human Services.

This bill would move the MDDC out from under the Department of Disabilities and would codify that a state entity may not interfere with the Council's work, budget, personnel, or state plan development or implementation. In fulfillment of its duties, the MDDC may advocate for a position that may not always align with the views of the Governor or the MDOD. This is why establishing the MDDC's autonomy as an independent unit is important.

The Arc Maryland and MACS partner with the MDDC on many issues, and we are members of the Developmental Disabilities Coalition. For decades we have worked cooperatively to advocate for positive systems changes for people with intellectual and developmental disabilities. We place high value on our partnership and believe this bill will help to ensure the Council's autonomy and independence so they may excel; serving Marylanders with Developmental Disabilities.

The Catholic Conference is the public policy representative of the three (arch)dioceses serving Maryland, which together encompass over one million Marylanders. Statewide, their parishes, schools, hospitals, and numerous charities combine to form our state's second largest social service provider network, behind only our state government.

**Senate Bill 168** establishes the Maryland Developmental Disabilities Council as an independent unit of State government with the authority to conduct and support advocacy, systems change, and capacity-building efforts to promote inclusive communities and equity in services for individuals with disabilities in the State.

Senate Bill 168, will, among other things, provide authority to the Council to (a) develop and implement a 5 year strategic plan; (b) monitor, review, and annually evaluate the implementation of the State Plan; (c) review any plan in the State that relates to programs affecting individuals with Developmental Disabilities; (d) serve as an advocate for individuals with developmental disabilities; (e) conduct or support programs, projects, and activities that carry out the purpose of the act; (f) advise the Governor, State Legislature, and other pertinent agencies and organizations on policies, programs, and issues related to the needs of individuals with developmental disabilities and their families; and (g) review and make findings and recommendations regarding programs related to the support and services provided to individuals with developmental disabilities and their families.

Recent estimates in the United States show that about one in six, or about 17%, of children aged 3 through 17 years have one or more developmental disabilities. <sup>1</sup> The establishment of a Council to research and support programming, services, and policy will provide helpful

The Office of the Attorney General supports Senate Bill 168, Senator Guzzone's bill to codify the Maryland Developmental Disabilities Council as an independent unit of State government. If enacted, this bill would ensure that Maryland's Developmental Disabilities Council complies with federal law.

Federal "developmental disability" legislation dates back to the Kennedy administration. The 1975 law - the "Developmentally Disabled Assistance and Bill of Rights Act" (DD Act) clearly identified that people with developmental disabilities were entitled to a variety of services and opportunities and that people with developmental disabilities and parents should participate in decisions about services/funding. The DD Act established the Developmental Disabilities Councils (DD Councils) to coordinate and integrate the provision of services for individuals with developmental disabilities in the least restrictive environment.

The most recent amendments to the DD Act were in 2000. The 2000 amendments to the law added that the makeup of DD Councils shall be comprised of 60% of people with developmental disabilities and their families, among a number of other changes, including but not limited to: increasing the accountability of programs funded under the DD Act, and aiming to increase coordination and collaboration within and across those programs. There is a DD Council in every U.S. state, including Maryland, and territory. The 56 DD Councils across states and territories work to address identified needs by conducting advocacy, systems change, and capacity building efforts that promote self-determination, integration, and inclusion. Key activities include conducting outreach, providing training and technical assistance, removing barriers, developing coalitions, encouraging citizen participation, and keeping policymakers informed about developmental disability issues.

Approximately 6 million individuals in the U.S. have developmental disabilities. Approximately 108,000 Marylanders have developmental disabilities. The Council is 100% federally funded and must comply with the DD Act. At the State level, the Maryland DD Council was formally established through executive order in 1971, with the most recent changes in 1987. This legislation is necessary because the language in the existing executive order is not current or consistent with the current DD Act. Of the 56 DD Councils across the U.S. states and territories, a majority (33) are formally codified in state statute. Of those 33, 9 are their own designated state agency. It is high time that Maryland caught up with the majority of states and codified it's Developmental Disabilities Council into Maryland law.

For all of the foregoing reasons, the Office of Attorney General Anthony G. Brown urges a favorable report on SB 168.

Dear Madam Chair and Members of the Senate Finance Committee,

My name is Mary Manzoni. I serve as CEO of Maryland Works, an advocacy organization that expands employment and business ownership opportunities for individuals with disabilities and other barriers. I am writing today in support of SB 168. The Maryland State Planning Council on Developmental Disabilities was established by Governor Marvin Mandel's Executive Order in 1971 to carry out provisions of the federal Developmental Disabilities Services and Facilities Construction Act of 1970 (PL 91-517) and Developmentally Disabled Assistance and Bill of Rights Act of 1975 (PL 94-10). Those previous acts are now the Developmental Disabilities Assistance and Bill of Rights Act (PL 106-402). Additionally, the Maryland State Planning Council on Developmental Disabilities is now known as the Maryland Developmental Disabilities Council.

#### Your support of SB 168 would:

- Establish the Maryland Developmental Disabilities Council as an independent unit of state government. Currently, the Council is a program of the Maryland Department of Disabilities (MDOD). The Council and MDOD agree that this restructuring is necessary for the reasons outlined below.
- 2. **Update an outdated Executive Order and codify the Council's authority in state law.** In 1971, the governor formally established the Council by executive order to carry out the



functions outlined in the DD Act. That executive order was updated in 1987 but has not been updated since.

- 3. Outline other requirements that mirror the federal law.
- 4. Codify that a state entity may not interfere with the Council's work, budget, personnel, or state plan development or implementation. This aligns with the requirement of the DD Act and allows the Council to continue their advocacy, capacity building, and systems change efforts.

The Maryland Developmental Disabilities Council (Council) is an independent, public policy organization that creates change to make it possible for people with developmental disabilities to live the lives they want with the support they need. Our vision is that people with and without disabilities in Maryland live, learn, work, and play together. We have been creating change to make that possible and improve the lives of people with developmental disabilities since 1971.

The Council was established through federal law and operates according to the law's mandates and related regulations and policies. The federal law – the Developmental Disabilities Assistance and Bill of Rights Act (DD Act) – guides our work, and all of our funding comes from the federal government. The Council is located within state government, but we are independent. The DD Act explicitly requires this independence, stating that the State must provide assurance that any "agency, office or entity of the State, will not interfere with the advocacy, capacity building, and systemic change activities, budget, personnel, State plan development, or plan implementation of the Council." This is the "non-interference clause." People with developmental disabilities and family members of people with developmental disabilities lead our work.

#### WHAT does this legislation do?

- Establishes the Maryland Developmental Disabilities Council as an independent unit of state government. Currently, the Council is a program of the Maryland Department of Disabilities (MDOD). The Council and MDOD agree that this restructuring is necessary for the reasons outlined below.
- Updates an outdated Executive Order and codifies our authority in state law. In 1971, the governor formally established the Council by executive order to carry out the functions outlined in the DD Act. That executive order was updated in 1987, but has not been updated since.
- Outlines other requirements that mirror the federal law.
- Codifies that a state entity may not interfere with the Council's work, budget, personnel, or state plan development or implementation. This aligns with the requirement of the DD Act and allows the Council to continue our advocacy, capacity building, and systems change efforts.

#### WHY is this legislation important?

- It updates language, aligns with federal law to be current and consistent, moves us out of the Department of Disabilities, and codifies current operations.
- Moving the Council from under the structure of MDOD better aligns with the spirit and intent of the DD Act.

- While MDOD and the Council work closely together, and have a strong, positive, and productive
  working relationship, being within the formal structure is cumbersome, unnecessary, and can
  lead to misunderstandings because the Council does not operate under the direction of the
  Governor or MDOD. As federal law requires, the Council's positions, decisions, and actions are
  solely our own and should not reflect on MDOD.
- The Council will continue to create change and improve lives by:
  - Leading the way with new ideas and taking bold steps to improve the lives of people with developmental disabilities.
  - Empowering people to advocate effectively for themselves
  - Advocating for people with developmental disabilities have the same opportunities in life as others.
  - Advising leaders in state government and the legislature to improve laws, policies, programs, and services.
  - o Finding solutions, testing new ideas, and making a difference.
- The Department of Disabilities and all of our colleagues and partners support this move, and Maryland will join the majority of other DD Councils that exist under their state laws rather than executive orders.

The Council will remain accountable to applicable state and federal laws, regulations, and policies, and will continue to create change, but we will be able to do this – and continue to be innovative - without any misunderstanding and while operating in a more streamlined manner.
