Good afternoon, Chair Griffith, Vice-Chair Klausmeier and honorable members of the Committee. Thank you for this opportunity to present **SB 806 Maryland Health Benefit Exchange and Maryland Department of Health – Health Care Coverage for Undocumented Immigrants – REPORT.**

The bill directs the Maryland Health Benefit Exchange and the Maryland Department of Health to produce a report that investigates options for offering affordable health care coverage to all income-eligible Marylanders, regardless of immigration status.

Why do we need to look into this? It's a huge health equity issue. According to the Maryland Center on Economic Policy testimony, while 3% of white Marylanders and 5.6% of black Marylanders are uninsured - a whopping 21% of the Latino population is uninsured.

According to the Kaiser Family Foundation as many as 46% of the 275,000 undocumented people in Maryland have no healthcare coverage.

While Maryland has made significant progress in reducing our uninsurance rate over the last decade (we are down to 6% uninsured), the undocumented population makes up nearly 40% of our uncovered individuals.

There are a couple of reasons behind this: certain industries that employ immigrants are less likely to provide employer sponsored healthcare, undocumented individuals must currently purchase individual insurance outside of the Exchange, which has much higher rates, and income eligible low-income immigrants who are not pregnant are not currently eligible for CHIP, Medicare or Medicaid.

This study is supported across the board by healthcare industry stakeholders including CareFirst, the Hospital Association and the Kennedy Krieger Institute. You can review their reasons for support in their written testimony.

The Access to Care Study continues the important work of the General Assembly in 2022 when it passed the Health Babies Equity Act. This Act expanded Medicaid coverage to all pregnant individuals regardless of their immigration status.

The Access to Care Study will examine the costs to the State for all qualified plan alternatives, including plans on the Health Benefit exchange, Medicaid programs, Children's Health Care Programs. The Study will identify the impact on the uninsured and detail implementation considerations. It will consider coverage options for all eligible individuals as well as options that are more limited in scope for children up to 21 years of age and seniors who are 65 or older. Study results will be available by October 31, 2023.

Thank you for your consideration of SB 806 and I respectfully ask for your favorable report.

Our undocumented immigrant neighbors make significant contributions to the national and Maryland economies by working in essential jobs, particularly during the pandemic, paying income taxes, Social Security and Medicare FICA contributions in excess of \$4 billion annually. However, due to their status as undocumented immigrants, they are currently ineligible for Medical Assistance, the MD Children's Health Program and the MD Health Benefit Exchange–even though many of them would otherwise qualify– making them and their families susceptible to illnesses and diseases that in the long run without care may threaten our public safety. As a retired medical social worker, I feel strongly about this bill. I

Lack of health insurance not only affected the sick person, but also their families. MHA Position

On behalf of the Maryland Hospital Association's (MHA) 60 member hospitals and health systems, we appreciate the opportunity to comment in support of Senate Bill 806.

This legislation represents an important milestone in our journey toward a resilient health care system for all, especially marginalized communities like undocumented individuals, who have been disproportionately impacted by lack of care.

MHA was proud to participate in the Maryland Health Benefit Exchange's (MHBE *or* Exchange) Health Equity Work Group. The Work Group met in 2021 and issued its final report in 2022, which recommended MHBE "continue exploration and discussion of coverage options for individuals who are currently ineligible for existing programs—specifically undocumented immigrants."¹ The legislature has taken bold steps to improve coverage for this population, including 2022's Healthy Babies Equity Act, which expanded the Maryland Medical Assistance Program (Medicaid) to pregnant individuals and their children up to 1 year of age regardless of immigration status. Yet, there are still a significant number of undocumented immigrants and Deferred Action for Childhood Arrivals (DACA) recipients who are not eligible for qualified health plans (QHPs) on the Exchange. As of 2019, MHBE estimated there were 244,700 undocumented immigrants residing in Maryland—almost half of whom are estimated to be uninsured.²

With recent significant changes in federal policies, including elimination of the "family glitch" and the public charge rule, the time is ripe to study available options for affordable health

No one should get sick or die because of their income or immigration status. More than 40% of undocumented residents are uninsured.

Black and Latino residents become sicker, are hospitalized at higher rates, and die younger as they are forced to face life or death situations due to their exclusion from programs such as the Affordable Care Act. Everyone in Maryland faces the consequences of undocumented residents being denied healthcare.

Senate Bill 806 – Health Care Coverage for Undocumented Immigrants – Report

Position: Support

Thank you for the opportunity to provide written comments in support of Senate Bill 806. This bill requires the Maryland Health Benefit Exchange (MHBE) and the Maryland Department of Health to develop a report comparing options for offering affordable healthcare coverage to State residents who are ineligible for the Maryland Medical Assistance Program, the Maryland Children's Health Program, or qualified health plans through MHBE due to the individual's immigration status. It is CareFirst's mission to promote the integration of a healthcare system that meets the healthcare needs of *all* the residents in Maryland, therefore we applaud the intent of this legislation and requirements of the report which are rooted in equity, affordability, and access to care.

Undocumented immigrants likely experience adverse health outcomes directly related to their high risk of being uninsured. Often, they have limited access to employer-sponsored insurance and face eligibility restrictions preventing their ability to purchase individual health insurance plans offered through MHBE or enroll in Medicare, Medicaid, or the Children's Health Insurance Program. It is well documented that timely use of health care services is associated with better health outcomes. Inadequate health insurance coverage is one of the largest barriers to health care access for reasons such as high out-of-pocket medical care costs, which lead to individuals delaying or forgoing much-needed medical care. Data illustrates that uninsured adults are less likely to receive preventive services for chronic conditions such as diabetes, cancer, and cardiovascular disease. Similarly, children without health insurance coverage are less likely to receive appropriate treatment for conditions such as asthma or critical preventive services such as dental care, immunizations, and well-child visits that track developmental milestones (Healthy People 2030).

The report described in Senate Bill 806 is an important first step in creating a pathway for undocumented immigrants in Maryland to obtain health insurance. Bill Summary:

Senate Bill 806 would require the Maryland Health Benefit Exchange and the Maryland Department of Health to develop a report comparing options for offering affordable health care coverage to State residents who are ineligible for the Maryland Medical Assistance Program, the Maryland Children's Health Program, or qualified health plans due to the individuals' immigration status; and requiring the Maryland Health Benefit Exchange to report its findings and recommendations to certain committees of the General Assembly by October 31, 2023.

Background:

Kennedy Krieger Institute is dedicated to improving the lives of children and young adults with developmental, behavioral, cognitive, and physical challenges. Kennedy Krieger's services include inpatient, outpatient, school-based, and community-based programs. Over 27,000 individuals receive services annually at Kennedy Krieger.

The vision for the newly established Office for Health Equity Inclusion and Diversity (O-HEID) at Kennedy Krieger Institute is to promote the health and well-being of those who work and receive training and services at Kennedy Krieger Institute. The O-HEID uses evidence, culturally relevant, and equity-based approaches that assures diversity and inclusion. The O-HEID is working to establish collaboration, data, and metrics to address remediable disparities within our patient populations, policies, and practices.

Rationale:

Maryland is now the most diverse state on the east coast.¹ In Maryland, undocumented immigrants represent 5% of the total state population including approximately 275,000 individuals² who have significant barriers to insurance eligibility due to their legal status. Distress due to immigration status is associated with the physical and mental health of undocumented immigrants, with difficulties in accessing healthcare underlying this relationship.³ One in four children in Maryland has at least one immigrant parent and though the vast majority of these children are U.S. citizens (86%),⁴ families with mixed documentation status often have multiple and chronic stressors to their health including history of trauma and limited opportunities.⁵ Lack of health insurance increases the risk of developing preventable conditions and undocumented immigrants are particularly vulnerable due language barriers and challenges with health care access. *This is important from a fiscal perspective because undocumented immigrants comprise 6% of the Maryland workforce as of 2016 and they paid an estimated \$373.5 million in federal taxes and \$242.3 million in state and local taxes in 2018.²*

In addition to the fiscal implications of a large segment of the population being uninsured, health-care providers have ethical obligations to provide care to all individuals regardless of "race, gender, socioeconomic status, ethnicity, religion, or any other social category."⁶ There is a public health imperative to improve undocumented immigrants' ability to access vaccinations that benefits the community as a whole.⁷ Overall, given the current structural barriers in the population of undocumented individuals, there is a lack of empirical information regarding policies affecting undocumented individuals and their health.⁸ As such, we support further investigation and a report on affordable healthcare options for undocumented individuals who are currently ineligible for coverage.

Furthermore, it requires the Maryland Health Benefit Exchange to report its findings and recommendations to certain committees of the General Assembly by October 31, 2023.

Undocumented immigrants face unique challenges in the U.S. health care system^{1, 2}. They are ineligible for federal insurance programs in the Affordable Care Act (ACA), resulting in the lowest health care coverage rates of any segment of the U.S. population¹. Lack of coverage has led to harmful delays in care, increased acute care utilization, and poor health outcomes²⁻⁶. TESTIMONY IN SUPPORT OF SB806

Bill Title: Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report Committee: Finance Committee Committee Hearing: March 8, 2023

My name is Jennifer Escobar, I'm a graduate student at the University of Maryland Baltimore, School of Social Work and I strongly support SB806, which requires the Maryland Health Benefit Exchange (MHBE) and the Maryland Department of Health (MDH) to develop a report comparing options for affordable health care coverage for State residents who are ineligible for Medicaid, MCHP, or any qualified plans due to immigration status. In addition to this, the MHBE and MDH will report their findings and recommendations to specified committees of the General Assembly by October of 2023.

My personal experience: As a social work student and an immigrant myself, I have been able to serve working families in my community who do not have access to public health care or afford private insurance. Several of these families and individual youth work in service industries like cleaning companies, retail stores, and trade jobs paying taxes through their ITIN while not receiving any benefits. I have friends who are DACA recipients, and not only it is hard for them to get a job that aligns with their expertise and fair pay, but when studying, they are obligated to pay thousands of dollars out of pocket for health care coverage or they won't be accepted in school. A dear friend of mine quoted that health insurance is such a burden while being in school as a DACA recipient, and considers not continuing higher education because of the monetary loss while in school. My grandfather who 25 years lived in the United States, paid taxes when he was a floorer, and in his late 60s when he became a driver continued to do so. His health became so bad, he decided not to go to the doctor anymore, even when he had been diagnosed with several treated illnesses thinking it would cause a financial burden; it caused the family stress and worry. This is the story of what many working immigrant families face when coming to the U.S. They sacrifice themselves for their families and children, paying taxes, not being treated even if they have cancer because the financial and timely costs are too high at the ER, and not having accessible affordable care.

SB806 is the first step as a state to provide access to health insurance to all Marylanders regardless of immigration status. In 2022, Maryland showed commitment to providing access to health assistance to moms and babies without legal documentation by passing the Healthy Babies Act (HB1080)¹; SB806 is the next step in providing access to care to the entire family. It is not only a reflection of the values of Maryland to provide access to health care to its residents², but it is also a fair action to give health care access benefits to those who pay taxes without ever receiving a refund, and in most cases working in the service industry, making it difficult to afford private insurance. With SB806, the state can find the best options for healthcare access for all working families in the State of Maryland.

SB806 would reduce the costs of Marylander families and the state. The Emergency Room is expected to provide health care access to everyone regardless of their immigration status; the ER, however, is expensive yet the only option people without insurance have. A visit in the ER can cost \$5000 when it could have been less at a doctor's office. With more access to health care, there can be a decrease in the uncompensated costs at the ER by allowing this population to seek affordable health care elsewhere. Adding to this, in 2018 undocumented immigrants paid an estimated of \$373.5 million in federal taxes and \$242.3 million in state and local taxes; Maryland DACA recipients and DACA-eligible individuals paid an estimated \$33.7 million in state and local taxes, this without counting their spending power and the taxes others than federal, state, and local³.

I strongly urge a favorable report on SB806. Access to healthcare is paramount for the overall health and well-being of all Marylanders. Thank you for considering this testimony today.

HEALTH CARE FOR THE HOMELESS TESTIMONY <u>IN SUPPORT OF</u> SB 806 – Maryland Health Benefit Exchange and Maryland Department of Health -Health Care Coverage for Undocumented Immigrants - Report

Senate Finance Committee March 8, 2023



Health Care for the Homeless strongly supports SB 806, which requires the Maryland Health Benefit Exchange and the Maryland Department of Health ("the Department") to develop a report comparing options for offering affordable health care coverage to State residents who are ineligible for the Maryland Medical Assistance Program ("Medicaid"), the Maryland Children's Health Program, or qualified health plans due to the individuals' immigration status. Last year, Health Care for the Homeless strongly supported the landmark bill, HB 1080, which expanded Medicaid to people who are pregnant and post-partum regardless of immigration status. The bill was groundbreaking in understanding the significant negative consequences of a person not having health coverage when they are pregnant or post-partum. We have appreciate working with the Department to implement this program and we have huge numbers of clients awaiting care due to this law going into effect. While we made huge strides in Maryland due to the passage of HB 1080, we must go further. *Everyone* deserves regardless of immigration and, as such, Medicaid must be expanding to *everyone* regardless of immigration status. This bill is a logical continuation of that work, taking the next step in gathering the data needed to understand the impact of coverage to all people who would have Medicaid but for their immigration status. For Health Care for the Homeless, *health care is a human right*. As such, we stand in support of SB 806.

Both Medicaid and the Affordable Care Act has shown transformative health outcomes for people across the country, but these lifesaving policies, particularly Medicaid, has been categorically denied to Marylanders who are undocumented. Health care is a human right and should never depend on a person's immigration status.

Generally, denial of health coverage leads to <u>poorer health outcomes</u>. Barriers to Medicaid coverage, and outright exclusions from Medicaid, have far-reaching implications — from missed early cancer diagnoses to reduced medication adherence for treatable conditions — that causes unnecessary suffering in families.

People without health insurance are more likely to skip preventive services and are less likely to obtain regular health care. Adults who are uninsured are over three times more likely than insured adults to say they have not had a visit about their own health to a doctor or other health professional's office or clinic in the past 12 months.¹ People who are uninsured are also less likely to seek medical care when they have a health problem. One in five (20%) uninsured adults say that they went without needed care in the past year because of cost compared to 3% of adults with private coverage and 8% of adults with public coverage.²

Because uninsured people are less likely than those with insurance to obtain regular medical care, they are more likely to have negative health consequences. This can include having an increased risk of being

diagnosed at later stages of diseases, including cancer, and have higher mortality rates than those with insurance.³

While safety net providers, like Health Care for the Homeless, are crucial in providing care to people who are uninsured, and particularly people who are undocumented, the safety net system does not nearly close the gap in care for the uninsured.⁴ For Health Care for the Homeless in particular, while we are a federally qualified health center that provides care for all people regardless of immigration status, we are primary care provider and generally cannot provide specialty care. We can treat people up to an extent, but if a person needs more specialized services, it is exceedingly hard to get them care.

As a federal qualified health center, treating all people regardless of immigration status, at Health Care for the Homeless we seen firsthand that denial of health insurance coverage due to immigration status has tremendously negative consequences. Over the past two years, we have seen an exponential increase in the number of clients present who are undocumented – oftentimes we see these clients through our pediatrics department. For our clients, access to this oftentimes life-saving care is both critical to public health and is also an issue of fundamental human rights. Health coverage must be made accessible for everyone regardless of immigration status.

Nurse Manager Julia Davis detailed the stories of two clients, with almost identical health conditions, one with Medicaid and one without. These two clients both suffered strokes, with nearly identical consequences: both lost their ability to walk and needed intense care to improve their mobility. One man had Medicaid and the other man was an undocumented immigrant without any access to health insurance. For the man who had insurance through Medicaid, he got the treatment he needed. He came to us experiencing housing insecurity and is now housed, has his own apartment, follows multiple specialists and gets the care he needs for the after-effects of a stroke. His mobility is not perfect but is significantly improved and can lead a fulfilling life. For the man who is undocumented, he had no access to health insurance and but for his immigration status, he would be eligible for Medicaid. Because he was not able to access the follow up care for his stroke, unlike Nurse Davis' client with Medicaid, this client's health has deteriorated – he is paraplegic and has not gotten the care he needs to improve his mobility. He has to self-catheterize and gets frequent urinary tract infections because no access to catheters. Nurse Davis shares that we do the best we can to provide care at our clinic, but there is specialty care we cannot provide him. We refer to specialty care but there's only a certain amount of specialty care other providers are able to give for people without insurance. Nurse Davis also shares that the inability to access care leads to exponential consequences, not just in physical health but also mental health, such as depression and the inability to work due to lack of improved health has put him and his family in a perpetual experience of homelessness. As is evidenced by this story, the inability to access care doesn't just impact one individual, it has ripple effects for an entire family.

No one should get sick or die because they are poor or undocumented. Health care is a human right. A person's immigration status should never, under any circumstances, determine the ability to receive affordable and high-quality health care. As a matter of public health and a matter of fundamental human rights, Medicaid must be extended to all qualified residents regardless of immigration status.

We urge a favorable report on SB 806.

Thank you for this opportunity to submit written testimony concerning an important priority of the **Montgomery County Women's Democratic Club** (WDC) for the 2023 legislative session. WDC is one of Maryland's largest and most active Democratic clubs with hundreds of politically active members, including many elected officials.

WDC urges the passage of SB0806. This bill calls for a study to determine the need for the state of Maryland to provide healthcare coverage for undocumented immigrants. According to a March 2016 report by the Maryland Center on Economic Policy¹, "undocumented immigrants in Maryland pay an estimated \$308 million in state and local taxes per year." However, undocumented immigrants are not legally allowed to claim those taxes. To compound this, they are unable to access the healthcare benefits that their taxes pay for. The state of Maryland can and should do better, buy extending healthcare for a vulnerable population that is generating hundreds of millions in tax revenues, often in difficult, low-wage jobs without benefits.

Additionally, Maryland's undocumented immigrants pay about 8.3 percent of their household incomes in taxes compared to the top 1 percent of taxpayers in Maryland who pay an average effective tax rate of 6.7 percent just.² Yet undocumented immigrants are denied access to affordable healthcare benefits. Equity demands that all taxpayers and everyone living in Maryland should have access to affordable and quality healthcare.

WDC believes healthcare is a right, regardless of status. A 2020 report by the American Immigration Council found that over 126,000 citizens living in Maryland live with at least one undocumented family member.³ Additionally, approximately 7 percent of children living in Maryland households who are U.S. citizens live with at least one undocumented family member.⁴ This means that an undocumented parent may not have access to healthcare to care for their child who is a U.S. citizen. In fact, U.S. citizen children who live with an undocumented parent are two times more likely to be uninsured than their counterparts who live in fully documented households. This does not fulfill our goal of equity and inclusion for all residents.

We should at least study the feasibility of providing healthcare coverage for all undocumented persons in the state. We ask the Maryland General Assembly to vote yes for Senate Bill 806 to develop a report outlining the options for affordable healthcare coverage for study the efficacy of providing healthcare coverage for State residents regardless of immigration status.

We ask for your support for SB0806 and strongly urge a favorable Committee report.

All Marylanders Should Have Access to Affordable Health Coverage

Position Statement Supporting Senate Bill 806

Given before the Senate Finance Committee

Being able to access affordable health coverage is a critical step towards health and wellbeing. Senate Bill 806 would require the Maryland Health Benefit Exchange and the Maryland Department of Health to produce a report assessing the impact of extending Medicaid, the Maryland Children's Health Program (MCHP), or qualified health plans (QHPs) to all Marylanders who meet the regular eligibility requirements, regardless of their immigration status. This report will provide essential data on the options for improving health accessibility and equity in the state. The Maryland Center on Economic Policy supports Senate Bill 806 because it's an important step in improving health equity for one of Maryland's most vulnerable communities.

While the extension of Medicaid through the Affordable Care Act (ACA) has enabled more Marylanders to get the medical attention they need, hundreds of thousands of residents are without health insurance. The undocumented population, in particular, is at much greater risk of being uninsured. According to the Census Bureau, 21.3% of Latine Marylanders were uninsured in 2021, compared to 5.6% of Black and 3% of White residents.ⁱ The disproportionate numbers are likely an indication of the large share of immigrants in the Latine community: non-citizen immigrants accounted for 38% of the uninsured in Maryland despite accounting for only 7.2% of the state population.

Gaining health coverage greatly improves access to health care and decreases the negative effects of being uninsured. Research shows that the expansion of Medicaid through the ACA improved access to care, affordability, financial security, and health outcomes.ⁱⁱ We are all affected when people in our communities delay seeing a doctor due to financial or documentation status concerns associated with health coverage: public or communal health is comprised as seen through the COVID-19 pandemic, in addition to possible uncompensated care for hospitals.ⁱⁱⁱ It was also found that Medicaid expansion reduced \$1,140 in medical debt per person, in addition to reducing evections for lower-income households.^{iv}

Multiple states across the country have established comprehensive care programs to extend coverage to undocumented immigrants. Twelve states in addition to the District of Columbia provide some type of state-funded healthcare to income-eligible children regardless of immigration status; other states have passed legislation that will do so in the next couple of years.^v

SB 806 is a step toward ending healthcare disparities for immigrant communities in Maryland. With the production of this report, the state would be better equipped to become a safer and healthier place for all its

residents. For these reasons, **the Maryland Center on Economic Policy respectfully requests the Finance Committee to make a favorable report on Senate Bill 806.**

Equity Impact Analysis: Senate Bill 806

Bill Summary

SB 806 would require the Maryland Health Benefit Exchange and the Maryland Department of Health to produce a report comparing options for offering affordable health care coverage to state residents that are ineligible for Medicaid, the Maryland Children's Health Program (MCHP), or qualified health plans (QHPs) because of their immigration status.

Background

Maryland's decision to expand Medicaid under the Affordable Care Act is one of the reasons why the state's uninsured rate is low (6%). Unfortunately, around 275,000 undocumented Marylanders are ineligible for care through Maryland's Medical Assistance Program, MCHP, the Maryland Benefit Health Exchange or other government-funded programs except for emergency services, even if they meet all the criteria but for their immigration status. Multiple states across the country have established comprehensive care programs to extend coverage to immigrants regardless of their documentation status. In 2022, the Maryland General Assembly passed the Healthy Babies Equity Act, which expands Medicaid to cover prenatal and postpartum care up to 12 months for pregnant individuals regardless of their documentation status.

Equity Implications

Immigration status can be a social determinant of health for many people, particularly for undocumented immigrants. This community often bears one of the highest uninsured rates nationwide: 46% of nonelderly undocumented immigrants were uninsured compared to 25% of lawfully present immigrants and 8% of U.S. citizens.^{vi} Employer-sponsored coverage is also an obstacle for undocumented immigrants as they tend to work in lower-wage occupations that do not offer health coverage.^{vii}

Not only does accessibility impact immigrant population's health, so does affordability. Research shows that immigrants' out-of-pocket healthcare expenses tend to be higher than those of citizens,^{viii} especially for undocumented immigrants that are elderly or have recently arrived.^{ix} However, subsidies and other forms of financial assistance can reduce families' need to rely on less affordable and comprehensive health coverage, and can encourage preventative rather than urgent care.

Impact

Senate Bill 806 will likely **improve racial**, health and economic equity in Maryland.

Dear Senate Finance Committee,

This testimony is being submitted by Showing Up for Racial Justice Baltimore, a group of individuals working to move white folks as part of a multi-racial movement for equity and racial justice in Baltimore City, Baltimore County, and Howard County. We are also working in collaboration with CASA de Maryland. I am a resident of **12A**. I am testifying in support of SB0806, the Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report Bill.



This bill will require the Department of Health to conduct a study comparing options for providing health insurance coverage to undocumented immigrants who would be eligible for medicaid but for their immigration status.

Access to healthcare is a human right, and it should not be limited by immigration status. Right now, undocumented immigrants in Maryland pay billions in dollars of federal and state taxes¹, but are ineligible for healthcare through Medicaid. Ineligibility for Medicaid has left over 300,000 undocumented Marylanders uninsured, which means that they then face health challenges with no support, which in many cases become life or death situations.

Additionally, providing equitable coverage for undocumented immigrants makes financial sense. Right now, undocumented patients receive care much later in the course of diseases,² which means that they face serious, and more costly, health conditions in the long run. Oftentimes undocumented immigrants rely on the emergency room again and again, which can be very expensive. Shifting from emergency care to prevention would mean that diseases are caught early and treatments could be avoided, reducing costs over time.

Opponents to this bill and ultimately to providing health insurance coverage to undocumented immigrants may claim that providing healthcare for undocumented immigrants would lead to an influx of people requesting free healthcare. The current data suggests otherwise. Since 2016, California has included undocumented children in its Medicaid coverage and has seen no increase in migration of undocumented immigrants³. European countries who have extended their healthcare coverage to migrants have also not seen any indication of "health tourism".⁴

Today I am calling upon you, as my representative in the Maryland Legislature, to follow through on the responsibility you have to care for all of their constituents' needs. Please vote in support of the Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report Bill (SB0806).

The Horizon Foundation is Howard County's community health foundation and the largest independent health philanthropy in the state of Maryland. We lead community change so everyone in Howard County can live a longer, better life.

The Foundation supports SB 806 – Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report.

SB 806 will help us better serve our immigrant community by studying and recommending different potential paths to quality, affordable healthcare coverage for those ineligible for the Maryland Medical Assistance Program, Maryland Children's Health Insurance Program, or qualified health plans through the Maryland Health Benefit Exchange.

This bill, in combination with SB 365 – Health Insurance - Qualified Resident Enrollment Program (Access to Care Act), would provide uninsured immigrants access to health insurance that they need and deserve. SB 806 would provide a roadmap for potentially many paths to quality, affordable coverage for this population while SB 365 would begin the process for providing care for many through the Maryland Health Benefit Exchange. Both bills are warranted and deserve your support.

Health equity is a priority for the Horizon Foundation. Along with a broad coalition of health providers, grassroots advocacy organizations, and health institutions, the Foundation pressed for the successful adoption of the Healthy Babies Equity Act (Chapter 28 of 2022), which will extend comprehensive medical care and other health care services to certain undocumented pregnant women and their children.

Dear Chair Griffith, Vice-Chair Klausmeier, and members of the Senate Finance Committee:

My name is Laura Atwood. I have lived in Maryland since 1999, and I represent Takoma Park Mobilization, an all-volunteer grassroots advocacy organization founded in 2016 that is active in environmental, justice, economic, and electoral matters. We are in SUPPORT of SB806, which would be an important step in reducing healthcare inequities within Maryland.

I'm also testifying as a healthcare employee who's so often struck by how many health problems, with accompanying anguish and multidimensional costs, could be prevented. I'd like to share the story of one man, whom I'll call Mario, who was my home health patient a few years ago. I work as a home physical therapist with patients who are "homebound," or unable to tolerate going to a physical therapy clinic; I typically make 4-6 visits per day, and people invite me into their homes and lives, hoping that I can help them get stronger and healthier.

Normally people without insurance are simply absent from my worklife. But Mario had come through my organization's hospitals and we were able to make a very few unreimbursed visits; even this is uncommon.

Mario had lost insurance when he changed jobs, didn't qualify for Medicaid or ACA subsidies because of immigration status, and couldn't afford his cardiac medications. Yes, these stories are real, in the form of so many human beings. So he had a simultaneous heart attack and stroke, couldn't return to his restaurant job which included heavy lifting, and couldn't pay rent for his room in a family's home; the family (including elementary school children) relied on that income as well but didn't want to make him homeless. The man was in his early 50s and eager to work, but unable when I last saw him.

How much better, in so many ways, would it have been to prevent the cascade of devastation from Mario's lack of health insurance? We need to do what we can, going forward, to find the best way to prevent others from facing Mario's situation. SB806 is an important step.

Madam Chair and members of the Committee, thank you for the opportunity to speak in favor of expanding access to health care in Maryland. I am Lee Hudson, assistant to the bishop for public policy in the Delaware-Maryland Synod, <u>Evangelical Lutheran Church in America</u>, a faith community with congregations with three judicatories across all regions of our State.

Our community advocates access to appropriate, adequate, and affordable health care for all people in the United States and its territories ("Caring for Health," ELCA, 2003).

We welcome an opportunity to enlarge the discourse about expanding access to health care in Maryland, as **Senate Bill 806** intends to do. Assumptions about access typically begin after exclusions have been presumptively established.

Senate Bill 806 will convene the Maryland Health Benefit Exchange and the Maryland Department of Health for study of the need and the options for gathering more people into Maryland's existing health insurances.

Status procedures and other circumstantial exigencies should not amount to denial of access to health care. People struggling to afford a decent living will be struggling to afford health care. One result of health un- and under-insurance will be excess health costs from uncompensated care, the hidden tax allocated on the medical care market. It also will increase the aggregate health care cost by compromising health outcomes (an articulated concern of our 2003 "Caring for Health" social statement). Untreated health issues don't save money and cause needless human suffering.

We supported expanding Medicaid for pre- and post-natal care regardless of immigrant status in the prior General Assembly session. We will support further expansions of access to care when they come before the MGA.

Successful expansion of health care access in Maryland needs to find a feasible way to cover at least 115,000 more medically uninsured people, the number identified in a 2021 MHBE report. We know what cohort of Maryland residents that includes, and we know why they're denied reasonable, adequate health care. Let's have a credible study and findings for how to gather them into the available care. Let's pass **Senate Bill 806**.

This testimony is being submitted by Showing Up for Racial Justice Baltimore, a group of individuals working to move white folks as part of a multi-racial movement for equity and racial justice in Baltimore City, Baltimore County, and Howard County. We are also working in collaboration with CASA de Maryland. I am a resident of District 46, and I am testifying in support of SB0806, the Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report Bill.



This bill will require the Department of Health to conduct a study comparing options for providing health insurance coverage to undocumented immigrants who would be eligible for medicaid but for their immigration status.

Access to healthcare is a human right, and it should not be limited by immigration status. Right now, undocumented immigrants in Maryland pay billions in dollars of federal and state taxes¹, but are ineligible for healthcare through Medicaid. Ineligibility for Medicaid has left over 300,000 undocumented Marylanders uninsured, which means that they then face health challenges with no support, which in many cases become life or death situations.

Additionally, providing equitable coverage for undocumented immigrants makes financial sense. Right now, undocumented patients receive care much later in the course of diseases,² which means that they face serious, and more costly, health conditions in the long run. Oftentimes undocumented immigrants rely on the emergency room again and again, which can be very expensive. Shifting from emergency care to prevention would mean that diseases are caught early and treatments could be avoided, reducing costs over time.

Opponents to this bill and ultimately to providing health insurance coverage to undocumented immigrants may claim that providing healthcare for undocumented immigrants would lead to an influx of people requesting free healthcare. The current data suggests otherwise. Since 2016, California has included undocumented children in its Medicaid coverage and has seen no increase in migration of undocumented immigrants³. European countries who have extended their healthcare coverage to migrants have also not seen any indication of "health tourism".⁴

Today I am calling upon you, as my representative in the Maryland Legislature, to follow through on the responsibility you have to care for all of their constituents' needs. Please vote in support of the Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report Bill (SB0806).

Our names are Liz Enagonio and Susan Radke, lead advocates for Indivisible Central Maryland, a grassroots organization of constituents dedicated to protecting progressive and democratic values. Indivisible Central Maryland **strongly supports SB0806.**

You have seen and heard other testimony that lays out the facts: that more than 275,000 undocumented immigrants in Maryland are ineligible for health care through the Maryland Health Benefit Exchange (MBHE). Let me note that some DOCUMENTED immigrants remain ineligible as well. One of the immigrants I work with through my volunteer group Asylum Helpers has been granted asylum, but remains ineligible to access any government programs, including medical care through the MHBE, even though he has a work permit, a job, and pays Federal, State, and social security taxes. Sadly, this extends to his wife and young son who remain undocumented because they are still awaiting their asylum hearing after 4 years in the US because the court system is so backed up. This means that if one of the family members get sick, they must seek care through an urgent care center, or if more serious, through an emergency room. They are then liable for whatever costs they may incur, with no insurance assistance. So, of course, those family members have had NO well-child or well-woman care since they arrived in the US.

As well, one of their cousins, age 4 years, was actually accepted into CASA's medical relief program, but there are no pediatricians in Prince George's County to accept him as a patient under the CASA program. He has had no well-child care, let alone sick child care, since arriving here in 2021. Of note, that branch of the family DID have health coverage through the state of Oregon's Health Benefit Exchange. Maryland needs to provide the same opportunity.

SB0806 tasks the Maryland Health Benefit Exchange and the Maryland Department of Health with developing a report on how the state can most cost-effectively deliver affordable health care

to Maryland residents who are ineligible for the Maryland Medical Assistance Program, the Maryland Children's Health Program, or qualified health plans through the Maryland Health Benefit Exchange solely due to the individuals' immigration status. This report is a necessary first step to explore how best to meet the health care insurance needs of our immigrant neighbors. On behalf of our valued immigrant community, Indivisible Central Maryland STRONGLY SUPPORTS SB0806 and recommends a FAVORABLE report in committee. Thank you.

The Catholic Conference is the public policy representative of the three (arch)dioceses serving Maryland, which together encompass over one million Marylanders. Statewide, their parishes, schools, hospitals, and numerous charities combine to form our state's second largest social service provider network, behind only our state government.

Senate Bill 806 requiring the Maryland Health Benefit Exchange and the Maryland Department of Health to develop a report comparing options for offering affordable health care coverage to State residents who are ineligible for the Maryland Medical Assistance Program, the Maryland Children's Health Program, or qualified health plans due to the individuals' immigration status.

In Maryland, over 275,000 undocumented immigrants are ineligible for care through the Maryland Health Exchange. Multiple states have established comprehensive care programs to extend coverage to immigrants regardless of their immigration status. This has had the highest impact on Black and Latino residents, who have become sicker, hospitalized at higher rates, and die younger as they are forced to face life or death situations due to their exclusion in essential programs.

Senate Bill 806 would identify healthcare disparities for immigrant communities in Maryland and form a study on providing health care coverage to undocumented immigrants in the pursuit of a common good.

Centro SOL, the center for Salud/Health and Opportunity for Latinos at Johns Hopkins, is pleased to support SB806.

Centro SOL is a Baltimore-based organization committed to promoting equity in health and opportunity for Latinos by developing patient and community-centered programs focused on physical and mental health, as well as clinical care innovations. Please note that while Centro SOL is partnered with Johns Hopkins University, this testimony does not necessarily represent the views of the University.

Latinos continue to have the highest uninsured rates of any racial or ethnic group within Maryland, despite an overall decrease in uninsured rates in the state. The Kaiser Family Foundation reported in 2019 that 21.4 percent of Hispanics in Maryland were uninsured, compared to 3.8 percent for non-Hispanic whites.¹ The high rate of uninsured Hispanic individuals can be partly attributed to the systematic exclusions certain immigrants face from federal health insurance programs. Some immigrants can participate in these programs, but undocumented immigrants and DACA recipients are still not eligible.

Maryland is more diverse now than when the Affordable Care Act was first enacted in 2010. As of 2017, two hundred and seventy-five thousand undocumented immigrants reside in Maryland, accounting for about 5% of Maryland's population.² Further, one in five workers in Maryland is an immigrant. Their work and entrepreneurship contribute to Maryland's economic growth and vitality. Despite the profound contributions immigrants make to the state, their essential role in the Maryland workforce, and millions in contributions to the economy through federal, state, and local taxes - they are still ineligible for the Affordable Care Act. Even when they meet all other basic eligibility requirements, many cannot buy health coverage from the State's Marketplace because of their immigration status.

Changing the State's law to extend access to health care to immigrants who are not eligible due to immigration status is a necessary next step to meet the health needs of immigrants.

In 2022 this committee took a bold step in ensuring that pregnant women have access to care for their unborn babies. The Healthy Babies Equity Act, expands Medicaid to pregnant individuals who meet the normal requirements of the program regardless of immigration status.

Dear Honorable Chair, Vice-Chair and Members of the Committee:

On behalf of the pediatric nurse practitioners (PNPs) and fellow pediatric-focused advanced practice registered nurses (APRNs) of the National Association of Pediatric Nurse Practitioners (NAPNAP) Chesapeake Chapter, I am writing to express our support of **HB 634 Public Health - Sale of Diet Pills to Minors - Prohibition (Protecting Teenagers From Unregulated Diet Pills).**

This bill would prohibit retailers from selling dietary supplements for weight loss, muscle building and over-the-counter diet pills to anyone under the age of 18 without a prescription. Weight loss supplements and pills, and muscle building supplements aren't regulated by the Food and Drug Administration (FDA). The FDA has also warned the public of the dangers of certain weight loss products, highlighting contaminated pills that have been tainted with dangerous ingredients. The American Academy of Pediatrics has released two reports strongly cautioning against teens using diet pills and muscle-building supplements for any reason. These products can be sold to consumers of any age without restriction, so any child can go to their local grocery store, convenience store, or gym or go online to buy these unsafe products.

For these reasons the Maryland Chesapeake Chapter of NAPNAP extends their support to HB 634 Public Health - Sale of Diet Pills to Minors - Prohibition (Protecting Teenagers From Unregulated Diet Pills) and requests a favorable report.

The pediatric advanced practice nurses of your state are grateful to you for your attention to these crucial issues. The members of Chesapeake Chapter of the National Association of Pediatric Nurse Practitioners are committed to improving the health and advocating for Maryland's pediatric patients. The League of Women Voters Maryland supports Senate **Bill 806: Health Care Coverage for Undocumented Immigrants- Report**, which would require the development of a report comparing options for healthcare coverage for undocumented immigrants. **The League believes that healthcare is a human right, and that every U.S. resident should have access to affordable, quality health care.**

Marylanders need expanded and equitable access to care. No one should suffer with a treatable illness, or die from one, because their undocumented status leaves them unable to access the medical care they need.

Over 275,000 undocumented immigrants in Maryland are currently ineligible for Medicaid, MCHP, and Medicare coverage, and are unable to purchase health insurance through the Health Benefit Exchange.

But uninsured patients still require medical care, and they often wind up in hospital Emergency Rooms. As the healthcare setting of "last resort," hospitals are mandated by the federal government to stabilize and treat all patients. Under EMTALA (the Emergency Medical Treatment and Labor Act), passed by Congress in 1986, hospitals must provide care for every patient presenting with an emergency medical condition, regardless of their ability to pay. Violating the law can lead to termination of a hospital's Medical Provider status: an extremely serious consequence.

Thus, if an undocumented immigrant presents to a hospital Emergency Department with crushing chest pain, sudden inability to speak, a bloody cough, or other symptoms indicating an emergency medical condition "such that the absence of immediate medical attention could reasonably be expected to result in placing the individual's health in serious jeopardy..." the patient WILL receive necessary treatment. In Maryland, the bill for that emergency treatment will be covered under Emergency Medicaid. And the hospital charges will likely be very expensive.

But, if that patient had been receiving regular, appropriate, cost-effective medical care from a primary care provider- including needed lab tests, imaging, and medications-they would have been much less likely to need emergency care in an ER.

So while the State of Maryland pays for treatment of uninsured patients with potentially lifethreatening medical emergencies, thousands of those patients, because of their immigration status, are not eligible for the high-quality non-emergency medical care that can be delivered in other, less expensive, and ultimately more effective settings.

As a society, a state, we are only as safe and healthy as the most vulnerable among us. ALL Maryland residents need access to affordable, equitable, quality health care. For that reason, the League and its 1,500+ members urge the committee to give a favorable report to Senate Bill 806.

This testimony is being submitted by Showing Up for Racial Justice Baltimore, a group of individuals working to move white folks as part of a multi-racial movement for equity and racial justice in Baltimore City, Baltimore County, and Howard County. We are also working in collaboration with CASA de Maryland. I am a resident of District 41 in Baltimore City. I am testifying in support of SB0806, the Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants -Report Bill.



This bill will require the Department of Health to conduct a study comparing options for providing health insurance coverage to undocumented immigrants who would be eligible for Medicaid but for their immigration status.

Access to healthcare is a human right, and it should not be limited by immigration status. Right now, undocumented immigrants in Maryland pay billions in dollars of federal and state taxes¹, but are ineligible for healthcare through Medicaid. Ineligibility for Medicaid has left over 300,000 undocumented Marylanders uninsured, which means that they then face health challenges with no support, which in many cases become life or death situations.

Additionally, providing equitable coverage for undocumented immigrants makes financial sense. Right now, undocumented patients receive care much later in the course of diseases,² which means that they face serious, and more costly, health conditions in the long run. Oftentimes undocumented immigrants rely on the emergency room again and again, which can be very expensive. Shifting from emergency care to prevention would mean that diseases are caught early and treatments could be avoided, reducing costs over time.

Opponents to this bill and ultimately to providing health insurance coverage to undocumented immigrants may claim that providing healthcare for undocumented immigrants would lead to an influx of people requesting free healthcare. The current data suggests otherwise. Since 2016, California has included undocumented children in its Medicaid coverage and has seen no increase in migration of undocumented immigrants³. European countries who have extended their healthcare coverage to migrants have also not seen any indication of "health tourism".⁴

Today I am calling upon you, as my representative in the Maryland Legislature, to follow through on the responsibility you have to care for all of their constituents' needs. Please vote in support of the Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants - Report Bill (SB0806).

The Maryland Community Health System (MCHS) supports *Senate Bill 806 – Maryland* Health Benefit Exchange and Maryland Department of Health – Health Care Coverage for Undocumented Immigrants – Report.

As a network of federally qualified health centers, we provide somatic, behavioral, and oral health services to underserved communities. Many of our health centers have a high concentration of patients who are immigrants. These patients face significant barriers to obtaining health care as they are far more likely to be uninsured. According to the Kaiser Family Foundation, 25% of legal immigrants and 46% of undocumented immigrants are uninsured.

Maryland made progress recently by extending Medicaid coverage to pregnant individuals who were not eligible because of immigration status. This legislation will provide options for further closing the gaps.

We would request one amendment to clarify that the study would also include dental coverage for immigrants:

On page 1 in line 24, insert "stand alone dental plans" after "qualified health plans".

The Maryland Dental Action Coalition strongly supports *Senate Bill 806 – Maryland Health Benefit Exchange and Maryland Department of Health Coverage for Undocumented Immigrants – Report.* The bill requires a report on the different options to extend coverage to individuals who are undocumented. Maryland took a significant step forward with immigrant coverage when the Maryland General Assembly enacted *The Maryland Healthy Babies Act.* Set to begin in July 2023, Medicaid will cover the full range of Medicaid services, including dental, for undocumented immigrants who are pregnant.

We would request an amendment to clarify that dental coverage will also be included in the report. Under the Maryland Health Benefit Exchange, the term "qualified health plan" does not include the stand-alone dental plans offered on the Exchange:

On page 1 in line 24, insert "stand alone dental plans" after "qualified health plans".

We Oppose SB806

On behalf of our 200,000 followers across the state, we respectfully object to SB806. The bill seeks to expand eligibility in the Maryland Medical Assistance program and the Maryland Children's Health Program by seeking ways of offering health care coverage to undocumented immigrants. Expanding eligibility means additional funding that would include funding for abortion services. We oppose expanding eligibility without excluding abortion funding.

The Maryland Medical Assistance Program and the Maryland Children's Health Program (MHCP) are the two primary programs used for publicly funded reimbursements to abortion providers in Maryland. The Maryland Department of Legislative Services, in their *Analysis of the FY 2022 Maryland Executive Budget*, shows that Maryland taxpayers are forced to fund elective abortions. For the years 2018, 2019 and 2020, over \$6 million was spent each year for almost 10,000 abortions each year. In that same report, we see that for Fiscal 2020, less than 10 of the almost 10,000 abortions were due to rape, incest or to save the life of the mother.

Medical Assistance Expenditures on Abortion Language attached to the Medicaid budget since 1979 authorizes the use of State funds to pay for abortions under specific circumstances. Specifically, a physician or surgeon must certify that, based on his or her professional opinion, the procedure is necessary. Similar language has been attached to the appropriation for MCHP since its advent in Fiscal 1999. Without language to prohibit abortion funding, expansion of the Maryland Medical Assistance Program and MHCP will certainly increase the number of abortions and thus the amount of taxpayer money spent on abortions.

Maryland is one of only 4 states that forces taxpayer funding of abortion. Maryland taxpayers are forced to subsidize the abortion industry through direct Maryland Medicaid reimbursements to abortion providers, through various state grants and contracts, and through pass-through funding in various state programs. Health insurance carriers are required to provide reproductive health coverage to participate with the Maryland Health Choice program. Programs involved in reproductive health policy include the Maryland State Department of Education, Maryland Department of Health, Maryland Family Planning Program, maternal and Child Health Bureau, the Children's Cabinet, maryland Council on School Based Health Centers, Maryland for the Advancement of School Based Health, Community Health Resource Commission, Maryland Children's Health Program (MCHP) and Maryland Stem Cell Research Fund.

Abortion is not healthcare and abortion is never medically necessary. A miscarriage is the ending of a pregnancy *after* the baby has died; an ectopic pregnancy is not a viable pregnancy and the baby cannot continue to develop. Abortion is the destruction of a developing human being and often causes physical and psychological injury to the mother. In the black community, abortion has reached epidemic proportions with half of pregnancies of Black women ending in abortion. The abortion industry has long targeted the Black community with 78% of abortion clinics located in minority communities. Abortion is the leading killer of black lives. See www.BlackGenocide.org.

Americans oppose taxpayer funding of abortion. The 2023 Marist poll shows that 60% of Americans, pro-life and pro-choice, oppose taxpayer funding of abortion. 81% of Americans favor public funds being prioritized for health and family planning services that save the lives of mothers and their children including programs for improving maternal health and birth and delivery outcomes, well baby care and parenting classes.

Funding restrictions are constitutional. The Supreme Court of the United States, in *Dobbs v. Jackson Women's Health* (2022), overturned *Roe v. Wade* (1973) and held that there is no right to abortion found in the Constitution of the United States. As early as 1980 the Supreme Court affirmed in *Harris v. McRae*, that *Roe* had created a limitation on government, not a government funding entitlement. The Court ruled that the government may distinguish between abortion and other procedures in funding decisions -- noting that "*no other procedure involves the purposeful termination of a potential life*", and held that there is "*no limitation on the authority of a State to make a value judgment favoring childbirth over abortion, and to implement that judgment by the allocation of public funds.*"

For these reasons, we respectfully ask you to oppose SB806.

Updates

1. Medical Assistance Expenditures on Abortion

Language attached to the Medicaid budget since 1979 authorizes the use of State funds to pay for abortions under specific circumstances. Specifically, a physician or surgeon must certify that, based on his or her professional opinion, the procedure is necessary. Similar language has been attached to the appropriation for MCHP since its advent in fiscal 1999. Women eligible for Medicaid solely due to a pregnancy do not currently qualify for a State-funded abortion.

Exhibit 33 provides a summary of the number and cost of abortions by service provider in fiscal 2018 through 2020. **Exhibit 34** indicates the reasons abortions were performed in fiscal 2020 according to the restrictions in the State budget bill.

Dear Senator Hettleman and Members of the Committee,

Thank you for the opportunity to comment on Senate Bill 806 – "... Report." I am a Facilitator for the Immigration Action Team of Indivisible of HoCo; I am an immigrant; a former medic in the U.S. Army; and a retired attorney. <u>I respectfully oppose SB806.</u>

SB806 requests a report on the cost to the State and potential benefits designs for offering insurance to uninsured immigrants. It is hard to argue against seeking further information. But, the information for implementation of benefits to immigrants already exists, if they are to parallel the benefits already provided to other residents. I fear that SB806 would serve as an excuse for others to postpone passage of SB365. SB365 aims to obtain ACA insurance for immigrants. There are approximately 110,000 immigrants lacking insurance in Maryland. These are individuals who benefit the State with their labor and taxes paid. Any emergency medical services they currently are able to obtain are costly to all of us, as they are insufficient to maintain a healthy population. Senator Hettleman, I admire your leadership on sponsoring SB365. I believe that proposing SB806 you may be causing unnecessary tension with SB365.

Dear Chair Griffith and Members of the Senate Finance Committee,

The Maryland Health Benefit Exchange (MHBE) respectfully submits this letter of information on Senate Bill (SB) 806 – Maryland Health Benefit Exchange and Maryland Department of Health - Health Care Coverage for Undocumented Immigrants – Report. SB 806 would require MHBE jointly with the Maryland Department of Health (MDH) to develop a report comparing options for offering affordable health care coverage to State residents who are ineligible for the Maryland Medicaid, the Maryland Children's Health Program (MCHP), or qualified health plans (QHPs) due to the individual's immigration status, and present these findings to the General Assembly by October 31, 2023.

In the last ten years, Maryland's uninsured rate has fallen in half and stands at about six (6) percent. However, as of 2019 approximately **357,000 individuals** remain uninsured in Maryland, almost **one third** of whom are ineligible for coverage through Medicaid or the individual market due to immigration status.¹

Pursuant to the 2021 Joint Chairmen's report (pg. 44), in November 2021 MHBE submitted a report to the General Assembly that reviewed options for providing affordable coverage and subsidies for Marylanders who are unable to enroll in Medicaid or QHPs and are not eligible for the Advanced Premium Tax Credit (APTC), and made recommendations on options for health coverage and cost sharing.² The report also describes actions other states are taking or exploring to provide coverage to similarly situated individuals in their states. The greatest level of detail provided in this report is regarding the option of covering ineligible individuals under QHPs through the MHBE using a combination of a federal 1332 waiver and a state-based premium and cost-sharing subsidy program. While the report does also summarize key considerations relating to provide enrollment or cost projections for these options.

By assigning this report jointly with MDH, who is the subject matter expert and state agency responsible for the administration of Maryland Medicaid and MCHP, SB 806 will build on MHBE's 2021 JCR report to provide a more comprehensive analysis, comparing enrollment and cost projections for Medicaid coverage of undocumented immigrants in Maryland.
