(First Reading File Bill)

On page 8, in lines 4 and 15, in each instance, strike the brackets; and strike in their entirety lines 16 through 32, inclusive.

On page 9, in line 4, strike “, **WHEN FEASIBLE,**”; in line 9, strike the second set of brackets; in line 10, strike “**(4)**”; in line 11, strike the brackets; in the same line, strike “general” and substitute “**PRIME**”; in lines 16, 19, 22, 23, 24, 27, and 29, in each instance, strike the brackets; in line 12, strike “**DOCUMENTATION OF GOOD FAITH EFFORTS**”; in line 13, strike “**REFERENCED UNDER ITEM (4) OF THIS SUBSECTION**”; in line 23, strike “provide”; strike beginning with “**AUTHORIZE**” in line 29 down through “**EXPERTISE**” in line 31; and in line 33, strike “**AND**”.

On page 10, in lines 1, 5, 10, and 27, in each instance, strike the brackets.
