STATEMENT FOR HEARING

SB907 Maryland Film Office - Entertainment and Film Funding Grant Program - Establishment

Dear Chair, Vice Chair, and Committee Members,

Thank you for the opportunity to speak before you today. For the record, I am Senator Johnny Ray Salling and I would like to ask for your support and consider SB907 for your approval.

Throughout the years, Maryland has been a host to many production companies to film movies and television shows. Most notably are House of Cards, The Wire, The West Wing, St. Elmo's Fire, Patriot Games, and Wedding Crashers.

This bill will give our Governor the option to set aside \$5 million in the budget to assist with the production costs of entertainment and film projects in the State. A maximum of \$200,000 will be used for every qualifying project until the total \$5 million is exhausted.

I have put forth an amendment to change the language of the bill from "shall" to "may" to ensure that this bill is not a mandate for Governor Moore's administration. This bill will give many artists an opportunity to complete their projects and give Maryland an opportunity to be showcased on the world's stage. This bill received a unanimous vote in the Budget and Taxation Committee and on the Senate floor.

Senate Bill 907 establishes the Entertainment and Film Funding Grant program (Program) within the Maryland Film Office which is within the Maryland Department of Commerce (Commerce). Through the Program, Commerce would issue grants of up to \$200,000 to assist with the production costs of entertainment and film projects in the State.

Maryland has a long history of film production. We have a strong crew base, a wealth of talent and many support services. We have a variety of locations, and our film office has a strong reputation. The State currently offers the Film Production Activity Tax Credit to award a refundable tax credit of up to 27% of film production costs incurred in the State. The tax credit is capped at \$12M per fiscal year, of which 10% must be reserved annually for Maryland small and independent film entities.

Thirty-five states presently offer incentives to attract film production. Maryland ranks 24th in the amount of incentives available per fiscal year. Few states offer grants for film production, and those that do base the grants on qualifying expenses incurred in the State, where this Program would issue grants in advance of filming to assist with production costs.

Since the inception of the Film Production Activity Tax Credit in 2011, the nineteen productions that have qualified for tax credits have had a combined economic impact in Maryland of well over a billion dollars. During its six seasons in Maryland, House of Cards hired more than 2,000 Maryland residents per season and purchased or rented goods and services from more than 2,000 Maryland businesses per season. Each season averaged \$118 million in economic impact for the State.
