HB389 (Del. Healey) FAVORABLE

Dear Committee Chair and Members,



Friends of the Greenbelt East Trail is a 501(c)(3) non-profit organization dedicated to improving safety and accessibility for all residents and road users along Greenbelt Road (MD Route 193) in Prince George's County.

The Greenbelt East Trail is a proposed two-way, protected shared use trail between Eleanor Roosevelt High School in Greenbelt and the WB&A trailhead in Glenn Dale MD. The trail would be on the shoulder or alongside Route 193, wholly on state right of way, with a short section within the city limits of Greenbelt and a longer section through unincorporated Prince George's County. There is currently no safe bike, walk, or bus stop access on many sections of Route 193 along our proposed trail route, and there have been several recent fatalities, including a pedestrian and a four-year-old child.

The picture below shows my wife on her bike next to Route 193 in Greenbelt – that's a typical streetscape: an 6-8 lane highway with overhead signs and guardrails for speeding cars, and a dilapidated sidewalk on one side of the road for everybody else. There were 129 traffic fatalities in Prince George's County in 2023 (see image below).

HB389 is ostensibly about maintenance of sidewalks and bike trails along state roads – removing the outdated and unfair requirement in law that localities are required do the maintenance. However, nobody maintains the sidewalks on state roads in the Greenbelt area, and we don't have any bike trails or side paths on state-owned roads yet. Therefore, the bill would not affect maintenance in our area at all. The more immediate purpose of HB389 is to remove a process impediment that held up the study of our trail proposal, and which has presumably held up or thwarted many other worthy safety and accessibility projects along state roads throughout our state.




HB389 stemmed from our efforts to get MDOT SHA to launch a feasibility study of the Greenbelt East Trail proposal in 2023. In order to be considered, we were asked to first obtain letters from Prince George's County and the City of Greenbelt agreeing that those local jurisdictions would be responsible for maintaining any trail that was built. Neither the County nor the City even seemed aware that they were supposed to maintain the sidewalks. In fact, one of the top engineers at our county's DPW&T all but yelled at me – in a recorded public meeting – when I asked for a county maintenance pledge. We eventually succeeded in getting those letters, as well as support letters from many other stakeholder groups. But obtaining maintenance letters in advance was difficult and time consuming, and, we believe, unnecessary.

The current design and condition of state roads in Greenbelt illustrates MDOT SHA's historic contempt for people trying to walk or bike or take the bus. We want to fix that by quickly building new or wider sidewalks and new shared use sidepaths on state roads in Prince George's County, such as our proposed the Greenbelt East Trail!

We urge the committee to report HB389 favorably and thereby remove an outdated bureaucratic process hurdle for studies of much needed safety and accessibility improvements along state roads.
