Dear Chairperson Barnes, Vice-Chairperson Chang, and Committee Members:

I write in favor of HB348 because I believe that other organizations, agencies, and individuals deserve to experience the amazing capacity-building, growth, and other opportunities that my organization, Hamilton-Lauraville Main Street (HLMS),¹ and I have seen thanks to Maryland's 2022 investment in current and aspiring public leaders.

You now have the opportunity to take part in continuing this wide-ranging public good by permanently funding the Schaefer Center for Public Policy (the Center) at the University of Baltimore (UB) through a favorable recommendation of HB348.

To assist you with this decision, I briefly offer just a few examples of Schaefer Center initiatives that positively impacted our organization and community:

• UB students from the Center and the **NextGen Leaders for Public Service Internship** program (NexGen) played key roles in HLMS projects – roles that our small organization could not have afforded and, therefore, would have been unable to do without them – that will have long-lasting benefits for our entire area.

¹ HLMS is a not-for-profit community and economic development organization that works to improve the appearance, infrastructure, and overall health of our area of Northeast Baltimore by, among other activities, assisting existing businesses, encouraging new businesses, facilitating facade and other grants for business or commercial property owners and community groups, and working with community members and both business and residential associations to facilitate inclusive community-based programming. We house a Healthy Neighborhoods Initiative (HNI) program and one of Baltimore City's eight designated Main Streets programs. Our goal is to help our entire wonderfully-eclectic and diverse community thrive by creating opportunities for local businesses – the lifeblood of a community – and providing quality of life experiences that retain residents and attract new neighbors.

HLMS and I are tremendously grateful for the opportunities that your support of the Center has provided, and I urge you to continue providing those opportunities with this bill.
