Chair Guzzone, Vice Chair Rosapepe, and members of the Committee, please be advised that the Baltimore City Administration (BCA) **supports** Senate Bill (SB) 848.

The Enoch Pratt Free Library (the Pratt) is one of Baltimore's most trusted institutions. The library breaks down the barriers for our community, connecting people with information, services, and opportunities to help them meet their goals. However, the Pratt has reached a crossroads when it comes to infrastructure. The library has some of the oldest buildings in the state, with 6 libraries over 100 years old. Only two Pratt Library buildings were built this century. A recent building assessment by an outside vendor found the total cost to stabilize Pratt Library infrastructure is \$197,300,000. Those improvements include structural upgrades and repairs to ensure long-term integrity of buildings, replacing antiquated systems with energy-efficient new technology, modernization of public spaces to improve user experience, and more.


These critical infrastructure needs are taking their toll on our city. The Pratt's Northwood branch is one example of a building with high usage, but significant structural deficiencies. The branch serves a community that is predominantly African American. Nearly 20% of that community face economic insecurity and more than 18% lack digital access. But last Fiscal Year, the Northwood branch was forced to close for 58 days due to deteriorating building conditions. That means for 20% of the year, that community could not access free internet, free resources, free tutoring, free after school programs for kids, free legal help, free social work, and more. A recent Facility Condition Report of the branch found every piece of the building - from the roof, to the walls, to the HVAC system - to be either in a critical state, potentially critical, or in need of replacement. For years, library officials have taken measures to try and alleviate building issues, such as installing temporary cooling units. However, without critical intervention, the Northwood branch will close permanently. Northwood is just one of many branches in need of critical repairs.

SB 848 could be a game changer for the Pratt Library. An infusion of state funding would help maintain infrastructure, functionality, and sustainability of library buildings. It will help the library leverage private dollars that can also be used to improve customer experience. And most importantly, it will help ensure that future generations have access to the vital resources of our public library.

For the above reasons, the BCA respectfully requests a favorable report on SB 848.

Dear Chair Guzzone, Vice Chair Rosapepe, and distinguished members of the Senate Budget and Taxation Committee,

I am writing in support of Senate Bill 848: Enoch Pratt Free Library Capital Project Funding sponsored by Senator Mary Washington. The Enoch Pratt Free Library is widely acknowledged as an essential and valued institution within the city of Baltimore and state of Maryland. The Pratt is also one of the most innovative libraries in the country, adapting traditional services to meet the growing needs of our community.

However, the vital work the library is doing is hampered by aging infrastructure that has reached a critical point. The Pratt has some of the oldest library buildings in the state, and deferred maintenance due to lack of funding is leading to more building closures and emergency repairs that are having a negative impact on our community and my constituents.

In my district, the Hamilton branch library first opened in 1959. Six decades later, the Hamilton branch has never had a major renovation. There's critical problems with the envelope of the library, with significant water intrusion. The Hamilton library is a safe haven for the children in my community, with dozens of them flooding through the doors the second school lets out. Without additional funding, this building will inevitably require an increasing number of closures, leaving children with no place to go.

We're already seeing that impact at the other branch in my district, the Northwood library. Due to failing infrastructure, in Fiscal Year 2023 *the Northwood branch was closed for 58 days. That's 20% of the year!* Library staff have done what they can to keep the building cool in the summer. However, the cooling tower in the Northwood branch is original to the 1960 building. A recent building assessment found major structural deficiencies in the building, making it fiscally irresponsible to simply repair the

HVAC.

Both the Northwood and Hamilton communities deserve libraries that can provide the vital services our neighbors need. Pratt Library leaders are looking for innovative solutions to improve the sustainability of the entire library system. However, that requires investment from the state, city, and private donors. Senate Bill 848 would help the library make strides towards a comprehensive capital improvement plan and ensure access to the library for generations to come.

We are writing in support of Senate Bill 848: Enoch Pratt Free Library Capital Project Funding sponsored by Senator Mary Washington. With 22 locations across Baltimore, the Pratt Library is a vital community resource, as evidenced by the recent compliment cards submitted by customers:

Each of these customers received library services at the Pratt's Northwood branch which serves the communities of Hillen, Original Northwood, New Northwood, Ednor Gardens, Montebello, and Morgan State University. But deteriorating infrastructure conditions *forced the library in Northwood to close for 58 days last Fiscal Year*. That means for **20% of the year**, that community was left without a place to access free internet, free tutors, a safe space, friendly faces, new technology, after school programs, and more. A recent Facility Condition Report of the Northwood branch conducted by an outside vendor found **every piece of the building** from the roof, to the walls, to the HVAC system to be either in a critical state, potentially critical, or in need of replacement.

Unfortunately, this is a widespread issue across the Pratt Library system, which has some of the oldest libraries in the state with *only two built this century*. A recent building assessment found that the **total cost to stabilize Pratt Library infrastructure is \$197,300,000**. Those improvements include structural upgrades and repairs to ensure long-term integrity of buildings, replacing antiquated systems with energy-efficient new technology, modernization of public spaces to improve user experience, and more.

Pratt Library leaders have been innovative in trying to continue serving our community. Private funding has been raised to refresh several library spaces. The Pratt is engaged in a new library model with public-private partnerships in several communities. The Library secured American Rescue Plan funding to replace HVAC systems in several branches. And pop-up libraries have been established in partner spaces to serve neighborhoods when libraries close. However, an infusion of funding is needed so the library can continue to meet the vital needs of customers.

The funding provided in Senate Bill 848 will help the library make major strides towards modernization of the Pratt infrastructure. The bill also requires a 10% match of funds from the Pratt Library Board of Trustees. We are committed to that match as an investment in the future of the Enoch Pratt Free Library. Together, we can ensure that the doors of our libraries stay open for generations to come. We respectfully ask for your support of Senate Bill 848.

My name is Barellie Thompson. I have been a patron of Enoch Pratt Library since I was in the 8<sup>th</sup> grade at Winston Middle School in Northeast Baltimore. My father would bring me to the Northwood Branch on Loch Raven Boulevard and Coldspring Avenue where I would spend hours checking out the library's selection of comic book and teen fiction like Harry Potter and Percy Jackson. I was a kid who gravitated towards reading from a young age and had it not been for the free resources provided by Enoch Pratt, I may not have gotten as much exposure to literature as I have.

It is with this background that I feel the impact that funding, or lack thereof, has had on this neighborhood library. In previous years, including last summer in 2023, Northwood has been a nearly unbearable place to be due to an air conditioning system that is not working. Library staff have had to work half days before going to other locations or had to endure with the slight relief provided by fans and dehumidifiers. Patrons, especially our elderly population, have been reluctant to come to Northwood during the hot months to attend programming or utilize its resources, likely preferring to stay home. With everything else that has impacted this library, such as closing due to COVID and the loss of a nearby school, it would be unfortunate if funding becomes another detriment that gets added to the list.

It is my sincere wish that you all take the time to see the importance of supporting the funding of Enoch Pratt Libraries to continue the growth and maintenance of one of Baltimore City's most impactful resources.

I am a patron of the Northwood Branch of the Enoch B. Pratt Free Library, located at 4420 Loch Raven Blvd. Baltimore, Maryland, 21218, and am writing to provide my strongest, unequivocal support for Senate Bill 848 entitled "Enoch Pratt Free Library – Capital Project Funding" sponsored by Senator Washington. The Northwood Branch of the library system is in desperate need of crucial infrastructure repairs. During the COVID-19 pandemic, the Northwood Branch was one of the hubs that would open for patrons to obtain services that could be provided safely and for me personally, access to books and other materials that had been placed on hold online for pick up. Multiple times per week, Ms. Sandra Scott at the circulation desk would call or email me to let me know that one or more books were available at the library and arrange a time for me to come and pick up the materials. It was often one of the few, if only, outside social interactions that I had during the lockdown phase of the pandemic, and it was so appreciated! Not only was Sandra risking her health to provide patrons with books and materials to combat the drudgery and fatigue of remaining indoors and online, but she always did so with a smile and words of kindness and encouragement. Without qualification, I can truly say that Sandra is a hero of the Enoch B. Pratt Free Library and I know that her job would be easier if the infrastructure issues at the Northwood Branch were resolved—passage of this Senate Bill would make that a reality!

As a frequent patron of the library both during and post-pandemic, I'd also like to express to the Chair, Vice-Chair and Committee Members my appreciation and gratitude to all the staff at the

Northwood Branch for exceptionally positive interactions multiple times per week. For example, I frequently discuss my fiction book preferences with Ms. Ny'ilah Whitaker, the Northwood Branch Manager, who is also an avid reader. Based upon those discussions, she has books held at the circulation desk for me written by authors that she intuits that I might like. To me, this goes above and beyond what one might reasonably expect from the administrative management and/or staff at a local library branch. As a Baltimore City resident and constituent of City Council District 3 and State Senate District 45. I am writing this letter to provide my strongest support of SB848 titled Enoch Pratt Free Library - Capital Project Funding sponsored by Senator Washington. I am a long-term patron of the Pratt Library system and the Northwood Branch at 4420 Loch Raven Boulevard in particular. The Northwood Branch is a crucial component of the community that provides vital services to local residents that go well beyond simply being a source for the thousands of books in circulation. This library branch serves as a safe place for children to go outside of school hours while their parents are at work. It provides daytime shelter from the extreme heat and cold weather for those community residents who are unhoused. It provides a means for idle hands and minds to be occupied; thus, minimizing their owners' opportunities for involvement in dangerous activities such as crime and substance abuse. It provides a source to find answers to questions that patrons might be too afraid or embarrassed to ask. The more tangible services provided by the Northwood Branch include story time for children, book clubs for adults, robotics programs, ALANON meetings, and free laptops for qualified individuals. And... The list goes on. Those items mentioned here barely scratch the surface of the value of the Northwood Branch Library to the community and serving as a steadfast anchor in the neighborhood.

Unfortunately, the building and infrastructure at the Northwood Branch Library have fallen into disrepair and require urgent upgrades to continue all of the outstanding work that they do. I want to commend the Northwood staff for the tireless effort that they put forth, in often difficult circumstances, to help library patrons and maintain a positive environment. For example, the building's air conditioning system is broken, causing the temperatures indoors to be utterly unreasonable. Yet, the staff members continue to work with a smile on their faces and a pleasant demeaner. Beyond the discomfort caused to the library staff, the lack of air conditioning frequently causes the library to be closed, which suspends the critical services that the neighborhood and community so desperately rely on. The ripple effects of the library closures are enormous and beyond measure. It is of the utmost importance that immediate action be

taken to perform the much-needed repairs to the Northwood Branch Library building and its infrastructure. Passage of SB848 is one step toward making this a reality.

Thank you for providing this opportunity for me to express my strongest and most enthusiastic support for passage of SB848 as well as an avenue to publicly recognize all of the valuable services and outstanding work that the Northwood Branch Library and its staff provide to the neighborhood and community. #### SENATE BILL 848 Enoch Pratt Free Library—Capital Project Funding

#### STATEMENT OF INFORMATION

DATE: February 21, 2024

**COMMITTEE: Budget and Taxation** 

SUMMARY OF BILL: Senate Bill 848 (SB 848) repeals and reenacts with amendments a mandate established under Section 23-402(a) of the Education Article, which concerns funding for the Enoch Pratt Free Library System in Baltimore City. Under the current statute, additional operating support in the amount of \$3 million has been mandated beginning with fiscal year 2023 and continuing each fiscal year thereafter to fund expenses associated with increased hours of operation across the System. Baltimore City is presently required to provide a 25% match for each dollar of State funds for this purpose, which SB 848 proposes to repeal. Additionally, SB 848 would require \$10 million in State appropriation in the annual budget bill in fiscal 2025 and fiscal 2026 to fund improvements to aging infrastructure and capital projects that exceed \$1 million. Eligible initiatives may include alterations to achieve ADA compliance, repair or replacement of roofs or HVAC systems, or replacement of obsolete or unsafe buildings. Receipt of State funds under the proposed amendment would require a 10% match from the Enoch Pratt Free Library Board of Trustees.

**EXPLANATION:** The fiscal 2025 – 2029 Capital Improvement Program (CIP) includes \$7.5 million in GO bonds annually for the Maryland State Library Agency under the Public Library Capital Grant Program. This program provides grants to public libraries to acquire land and to design, construct, expand, renovate, and equip public library facilities across the State; inclusive of all those operated under the Enoch Pratt Free Library System. Funding for the program is mandated under Section 23-509 of the Education Article, and each year specific projects are selected by a committee of library directors and trustees, and subsequently approved by the State Library Board. With regards to the proposed legislation, it is the intent of the General Assembly to enhance funding for the Enoch Pratt Free Library System specifically to advance the role of its branches as vital places of community development, arenas for innovation, and resources for the State's workforce system. SB 848 also affirms the System's role in supporting equitable economic recovery by providing its patrons with opportunities to access new technology, gain digital skills, and pursue vocational and educational programs.

The \$10 million funding mandate set forth by SB 848 in fiscal 2025 and fiscal 2026 is intended to be supplemental to, and may not supplant, funds appropriated to the Enoch Pratt Free Library System from any other sources. There is one project within the Enoch Pratt Free Library System planned in fiscal 2025

under the Public Library Capital Grant Program, Forest Park Library Renovation and Expansion, at a cost of \$2.2 million. Implementing this new mandate would result in a cost of \$20 million from fiscal 2025 to fiscal 2026, which would necessitate a reduction in other critical programs and projects already planned in the CIP. The \$10 million mandate would not be applicable to the fiscal 2025 capital budget.

Additionally, the repeal of the 25% local match requirement associated with the State's \$3 million operating mandate to support extended hours at Enoch Pratt Free Library branches may reduce local operating support to the System by up to \$750,000 if Baltimore City decides not to contribute.
