Subject: Legislative Initiative – Holding Permits for Unpaid Personal Property Taxes

- Introduction: Personal property generally includes furniture, fixtures, office and industrial equipment, machinery, tools, supplies, inventory, and any other property not classified as real property. In Maryland, the tax on business-owned personal property is assessed through the Department of Assessments and Taxation and then imposed and collected by Carroll County Government.
- Summary: On September 21, 2023, in an effort to collect delinquent taxes, the Carroll County Board of Commissioners approved the policy to reserve the right to withhold the issuance of permits requested by business owners that have unpaid assessed personal property taxes.
- Background: Carroll County does not currently have an efficient or effective mechanism to hold businesses responsible for unpaid property taxes, therefore businesses can continue to operate without penalty for failure to pay this tax. Currently, the only option to enforce payment of these taxes requires the County Attorney's Office to pursue a court proceeding which is slow, expensive, and if successful, leads to the sale of equipment with little or no monetary value. This option adds considerable administrative expense to the county.

Rationale:

- Currently, the County has the authority to withhold issuance of a trader's license or liquor license if a business has an open personal property tax bill.
- Requiring all business requesting permits to pay all taxes, would eliminate costly court proceedings.
- Without this in place, businesses are allowed to continue to operate without penalty for failure to pay their personal property taxes.
- This action would also:
 - o treat all businesses fairly and equitably
 - save staff time and resources

Statistics:

- In FY23, the Comptroller's Office went to the Board of Commissioners regarding personal property tax bills over \$5,000 - 6 accounts equaling \$58,356.07 were written off. In addition, the County wrote off another 121 accounts that were under \$5,000 and totaled \$67,626.07 going back to FY14.
- Currently, the county has 130 outstanding personal property tax bills spanning from 2008 to July 2022, this is the current time span of open personal property tax bill on the county's books. These are 130 unique businesses with multiple open bills.
- After cross referencing with types of business and businesses that have open personal property tax bills, the county can reasonably deduce that potentially 43 of these businesses could pull a permit to do business in the county.
- Request: The Carroll County Commissioners request your support and ask the Carroll County Delegation to submit legislation to the Maryland General Assembly for consideration.



Dear Chair Guzzone and Members of the Committee,

We write in support of **SB963** as amended, sponsored by the Carroll County Senators on our behalf, which will provide the County Comptroller with an additional tool to collect delinquent personal property taxes from businesses seeking commercial permits and/or licenses.

The bill as drafted would have required any business seeking a permit or license to provide documentation that personal property taxes have been paid. The amendments put the bill back in a form consistent with its original intent. When a business in Carroll County seeks to secure a new, or renew an existing, commercial permit or license, the Office of Permits and Licenses, after conferring with the Comptroller's Office, will deny the issuance of the permit or license if the applicant has delinquent personal property taxes.

Carroll County does not currently have an efficient or effective mechanism to hold businesses responsible for delinquent personal property taxes, therefore business can continue to operate without penalty for failure to pay the tax. Currently, the only option to enforce payment requires the County Attorney to pursue a court proceeding which is slow, expensive and, if successful, leads to the sale of equipment with little to no monetary value. This option adds considerable administrative expense to the county.

In FY23, the Comptroller's Office approached the Board of Commissioners regarding personal property tax bills over 5000 - 6 accounts equaling over 58,000 were written off. In addition, the county wrote off another 121 accounts under 55,000 and totaled nearly 68,000 going back to FY14. Currently, the county has 130 outstanding personal property tax bills representing 130 unique businesses with multiple open bills. In reviewing those businesses, the county believes as many as 43 of these businesses could seek a permit or license.

We believe this is a matter of basic fairness to the greater business community in our county that continue to play by the rules and are current in the payment of their personal property tax bills.

For these reasons the Board respectfully requests a FAVORABLE report on SB693.
