

I write today on behalf of the Board of County Commissioners of Allegany County, Maryland, to express my support of House Bill 1330, sponsored by the Allegany County Delegation. The Board of County Commissioners have received comments from numerous small businesses in Allegany County that are currently prohibited from employing employees between the ages of 16 to 18 for general employment purposes because the business possesses a liquor license. House Bill 1330 would allow license holding businesses in Allegany County to employ these employees as general employees but would prohibit them from serving beer, wine, or liquor.
