Dear Chair Feldman,

The mission of the Maryland Public Service Commission (PSC) is to ensure safe, reliable and economic public utility service to the citizens of Maryland. In doing so, under the Public Utilities Article, the PSC must consider the environmental and climate impacts of all matters before it. The PSC aims to support the climate goals of the State and has consulted with State agencies on the various aspects of climate change.

The General Assembly and the Governor have looked to the Maryland Commission on Climate Change (MCCC) to provide recommendations that advise "on ways to mitigate the causes of, prepare for, and adapt to the consequences of climate change." Many of the recommendations that are developed by the MCCC are highly technical, and intersect with the work of the PSC and affect the utility ratepayers of Maryland. The PSC has diligently monitored the work of both the MCCC and its working groups. However, the PSC is not a voting member of the MCCC. This limits the ability of the PSC to share information and provide feedback on recommendations that come before the working groups and the MCCC as a whole.

I am requesting that the Chair of the Public Service Commission be added as a standing member of the Maryland Commission on Climate Change. The People's Counsel was added as a member of Climate Commission in the recent past. To accomplish this, statute 2-1302 of the Environmental Article of Maryland will need to be amended. The PSC appreciates your sponsorship and support of the bill to make this statute change. I have spoken with the Secretary of the Department of the Environment about PSC membership, and she agrees that the formal participation of the PSC on MCCC would benefit the Climate Change Commission as a whole. I would be happy to meet with you to discuss issues involving the PSC including this request coming before your committee.

The Office of People's Counsel ("OPC") supports Senate Bill 337, which would add the Chair of the Public Service Commission ("PSC") or the Chair's designee to the Maryland Commission on Climate Change ("Climate Commission"), of which OPC is also a member.

The PSC has an important role to play in developing and implementing policies that will achieve the State's ambitious greenhouse gas emissions reduction goals set in the Climate Solutions Now Act, particularly in the electricity and buildings sectors. As such, the Climate Commission has made—and inevitably will continue to make—policy recommendations that either directly or indirectly implicate the work of the PSC. The 2023 Annual Report made the following recommendations, among others, that directly implicate the work of the PSC:

- support and enforce the 2025 electric school bus mandate;¹
- provide funding for EV readiness projects;²

- modify the Strategic Infrastructure Development and Enhancement Plan (STRIDE) to reduce ratepayer costs and facilitate electrification;³ and
- sunset financial incentives for fossil fuel appliances/systems in the EmPOWER program.⁴

In developing such recommendations, the Climate Commission would benefit from the PSC's experience and expertise in the area of public utilities law and regulation.

Recommendation: OPC requests a favorable Committee report SB 337.
