Anne Arundel County Public Schools (AACPS) supports **SB657 Anne Arundel County – Student Loan Assistance Repayment Program for Educators - Established**. This bill authorizes the Anne Arundel County Council to create the Anne Arundel County Student Loan Assistance Program for educators to assist in the repayment of student loans owned by educators employed by AACPS. The purpose of the program is to attract, recruit, and retain a diverse cadre of qualified educators in AACPS reflective of the student population within the county. Qualifying loans include a loan for undergraduate or graduate study that is obtained for tuition, educational expenses, or living expenses from a college, university, government, commercial, or nonprofit source. In order to benefit from the program, individuals must receive a graduate, professional, or undergraduate degree from an accredited college or university, be employed by AACPS, commit to serve in AACPS for a period of not less than five years, and receive an income that is less than the maximum eligible total income levels established by the County Council. Finally, the bill authorizes the Anne Arundel County Council to establish additional criteria for the program.

We recognize the educational benefits of a diverse workforce that enriches the educational experience of all AACPS students. Investing in the development of highly effective teachers and leaders that reflect our diversity and commitment to diversity, equity, inclusion, and high-quality education for all AACPS students ensures that all students can grow, belong, and succeed.

AACPS teachers are valued as leaders and actively participate in making decisions that impact teaching and learning at the school level. We are proud of our teacher workforce and value them as a critical asset in contributing to student academic achievement. The Board believes that the quality of education is directly dependent on the quality of the teacher workforce, which is directly impacted by the school system's ability to recruit and retain high-quality educators.

AACPS supports resources such as loan assistance repayment programs to help recruit a more diverse teacher workforce. This program would provide a mechanism for educators employed by AACPS to receive student loan repayment assistance, if funded by the Anne Arundel County Council. Accordingly, AACPS respectfully requests a **FAVORABLE** committee report on SB657.

Testimony in Support of SB0657 - Anne Arundel County - Student Loan Assistance Repayment Program for Educators - Established

Mr. Chair, Madame Vice Chair, and Members of the Senate Education, Energy, and the Environment Committee:

SB0657 would authorize Anne Arundel County to establish a Student Loan Assistance Repayment Program for Educators employed by Anne Arundel County Public Schools (AACPS). The purpose of the program is to attract, recruit, and retain a diverse cadre of qualified educators in AACPS that reflects the student population within county schools. The program must be administered by AACPS. Funds for the program must be as provided on an annual basis in the county budget in an appropriation separate from the county's appropriation to the operating budget of the Anne Arundel County Board of Education. Funds for the program may be used to cover administrative expenses of the program.

Background

Chapter 140 of 2018 authorized Howard County to establish a Student Loan Assistance Repayment Program for Teachers employed by the Howard County Public School System (HCPSS). In June 2023, the Howard County Council unanimously passed Council Bill 14 which established the Student Loan Assistance Repayment Program for Teachers pursuant to the 2018 enabling legislation passed by the Maryland General Assembly. As the benefit design and funding amount is up to the locality, Howard County provided \$1.5 million over five years for student loan repayments.

Solution

SB0657 would enable Anne Arundel County to establish a student loan repayment program for educators who:

1. Receives a graduate, professional, or undergraduate degree from an accredited college or university;

- 2. Obtains employment as an educator in AACPS;
- 3. Commits to serve in AACPS for at least five years;
- 4. Receives an income that is less than the maximum eligible total income levels established by the county, including any additional sources of income the individual may earn;
- 5. Is not in default on any student loan; and
- 6. Satisfies any other criteria established by the county for the program.

Loan assistance provided under the program must be in the amount and on the terms and conditions established by the county. An applicant for assistance in the repayment of a commercial loan must demonstrate to the county that the loan was used for tuition, educational expenses, or living expenses for graduate or undergraduate study.

Per the Fiscal Note, SB0657 would not require any additional state resources. To the extent that Anne Arundel County establishes a student loan repayment assistance program pursuant to this bill, financial obligations will be entirely up to the county. For these reasons, I respectfully request a favorable report on SB0657.
