### American Lung Association Testimony Senate Bill 1056 Senate Finance Committee March 6, 2024 Support

Chair Beidle, Vice-Chair Klausmeier and Members of the Committee:

We thank you for the opportunity to provide comments on Senate Bill 1056 – Tobacco Retail Modernization Act of 2024 which would address a number of policy changes regarding tobacco sales in Maryland. The American Lung Association supports this legislation inclusive of the technical amendments being offered by the bill sponsor.

The American Lung Association is the leading organization working to save lives by improving lung health and preventing lung disease, through research, education and advocacy. The work of the American Lung Association is focused on four strategic imperatives: to defeat lung cancer; to improve the air we breathe; to reduce the burden of lung disease on individuals and their families; and to eliminate tobacco use and tobacco-related diseases.

Tobacco use remains the leading cause of preventable death in the United States, killing an estimated 480,000 Americans and 7,500 Marylanders each year.<sup>1</sup>

In data from the <u>2023 National Tobacco Youth Survey</u>, tobacco use among high school and middle school students continue to show high levels with more than 2.8 million youth using a tobacco product. The American Lung Association is particularly alarmed by the trends of use by middle school students with the CDC report showing a significant increase in tobacco use. The report showed that tobacco use overall for middle school students increased nearly 50% from 4.5% to 6.6%. The report also shows that 2.1 million youth are still vaping, and over 25% are vaping daily which indicates a very high addiction rate.

In Maryland, close to 15% (14.7%) of high school students use an electronic smoking device. Nationally, nearly 90% of the youth survey respondents reported using flavored e-cigarettes including mint and menthol. In addition, of the youth who smoke, 40.4% smoke menthol cigarettes. Flavored tobacco products remain the primary gateway for youth addiction. The tobacco industry has continued to target youth users with marketing of flavored tobacco products which makes them appealing to youth, with many of them not realizing that these products contain nicotine. As a result, we are setting our kids up for a lifetime of addiction and losing the opportunity for the first tobacco-free generation.

Senate Bill 1056 addresses a number of important policy changes that the Lung Association supports as effective measures to address tobacco use. These include:

- Making updates to Maryland's law to comply with and mirror federal law on underage sales of tobacco.
- Increasing the cost of a tobacco retail license, requiring a set number of annual enforcement checks of retailers ensuring retailers in Maryland are complying with the law, and more frequent checks for those who have found to be in violation of the law. A successful tobacco retail licensing program includes important key components, including graduated fines and license suspension after a certain number of violations. The Lung Association also believes that revenue raised from the increased costs associated with the license should be used to support enforcement efforts.
- Ensuring that all tobacco products are kept behind the counter which according to <u>Counter</u> <u>Tobacco</u> can help control the visibility and accessibility at the point of sale.
- Prohibiting tobacco products from being sold in pharmacies. Pharmacies are places where
  people go to get well and should not be selling deadly products. Selling tobacco products in
  pharmacies send a mixed message to consumers about the dangers of tobacco products.
  According to a study in the Journal of American Medical Association, when filling prescriptions
  for chronic illnesses worsened by smoking, 1 in 20 customers also purchased cigarettes. In the
  Journal of Preventative Medicine, 2 million smokers last purchased their cigarettes from a
  pharmacy and tobacco products in pharmacies make quit attempts for current smokers less
  successful. In fact, after CVS stopped selling tobacco in September 2014, cigarette pack sales
  decreased, and nicotine patch purchases increased in states where the chain had a large retail
  presence. Finally, in FDA compliance data, some large pharmacy chains are the leading sellers of
  tobacco products to underage individuals. By prohibiting the sale of tobacco products in
  pharmacies this critical access point for kids and young adults will be eliminated.

Thank you for your continued commitment to the health and wellbeing of the residents of Maryland, we urge you to support Senate Bill 1056 which includes important policy changes in tobacco retails sales to help address tobacco use in the state.

The Office of the Attorney General urges this Committee to report favorably on Senate Bill 1056 – Cigarettes, Other Tobacco Products, and Electronic Smoking Devices – Revisions (Tobacco Retail Modernization Act of 2024).

Senate Bill 1056 brings much-needed improvements to Maryland's electronic smoking devices ("ESDs") law, Business Regulation Title 16.7. ESD use has exploded since Maryland enacted Title 16.7 in 2017, as an ever-increasing number of new products, many attractive to children, have flooded the market. The consequences are all too predictable: from January 2020 to December 2022, total U.S. e-cigarette unit sales increased by 46.6%, from 15.5 million to 22.7 million units,<sup>1</sup> and ESDs are the second largest nicotine product category after traditional combustible cigarettes for adult users. And despite Maryland's law banning ESD sales to persons under the age of 21, ESD use for our youth is higher than it is for cigarettes: the 2021 Maryland High School Survey reports that while 3.6% of high school students smoked cigarettes, 14.7% of high school students currently used ESDs—the equivalent of more than 4 students in a class of 30.<sup>2</sup> Because youth are particularly susceptible to developing nicotine's addictive properties, the widespread availability of e-cigarettes in Maryland risks poses a long-term danger to this vulnerable population.

Senate Bill 1056 helps solve this problem by making Maryland's licensed Vape Shop Vendors the only entities authorized to sell ESDs to the public, and by requiring that ESDs are the only products that Vape Shop Vendors are allowed to sell. This will remove ESDs from retail environments, such as convenience stores, which are frequented by youth. SB 1056 makes it easier for responsible and law-abiding Vape Shop Vendors to enforce Maryland's prohibition on sales of ESDs to any person under the age of 21 by requiring that all tobacco and ESD products be located behind the counter, accessible only to employees of the Vape Shop Vendor. In addition, Senate Bill 1056 bans sales of ESDs directly from the manufacturer to consumers online or by mail, thus eliminating a loophole in Maryland law which allows teens to order ESDs from unscrupulous suppliers over the internet.

The Office of the Attorney General also believes that the Committee should consider ways to make enforcement of Senate Bill 1056 even more effective, by authorizing the Alcohol, Tobacco, and Cannabis Commission to conduct unannounced inspections of Vape Shop Vendors to ensure compliance with the law and to seize contraband products. The Attorney General also recommends that SB 1056 include a requirement that Vape Shop Vendors obtain their ESD merchandise from Maryland's licensed ESD wholesalers. This would create the same chain of distribution for e-cigarettes that governs Maryland's cigarette industry and facilitate effective enforcement of Maryland law.

For the foregoing reasons, the Office of the Attorney General urges a favorable report on Senate Bill 1056.

I am writing to you as the Executive Director of No Boundaries Coalition, living in Baltimore, to express my support for SB 1056, the Tobacco Retail Modernization Act of 2024. I support this bill because I believe that sale of tobacco products should be limited because of the danger of affects. My advocacy is to ensure that big tobacco ends the targeting of black and brown communities and youth.

Despite progress in tobacco control, the problem of youth access to tobacco products, including e-cigarettes, remains significant. Data indicates that over 48,000 Maryland high school students **self-report** they use tobacco products, a number that likely falls short of the true total. The marketing strategies and new products like flavored e-cigarettes target and hook kids, Big Tobacco's next generation of customers.

The impact of youth tobacco use is both a public health and economic burden. Maryland incurs annual healthcare costs of approximately \$3.14 billion directly related to smoking, and 27.5% cancer-related Maryland deaths can be traced to tobacco use. These steps are crucial for developing effective healthcare and public health strategies to protect Maryland's youth and to ensure that retailers are held accountable to state and federal law.

As we all know, the problem of youth access to tobacco products remains a significant public health and economic issue. Data indicates that over 48,000 Maryland high school students use tobacco products, a number that likely falls short of the real total. Big Tobacco industries have hooked my friends, my classmates, and even my family by their strategic marketing and flavor components. To set the stage, It's estimated that smoking will prematurely kill 92,00 kids now living in our state. These ESDs impact not only youth development but our economy, Maryland incurs annual healthcare costs of approximately \$3.14 billion directly related to smoking. Keeping these staggering figures in mind, it is of life or death important that Maryalnd produces a conclusive and multifaceted approach to this crisis.

HB 1180s' proposals take a significant step towards this by limiting manufacture power and sale of ESD to licensed vendors. Controlling ESD purchasing to vape stores will significantly reduce teen access. However, lawmakers need to go even further. While limiting access is important, this bill needs to include provisions to educate youth about the direct correlation of ESD products and what we, as teens, do. We need PSAs and visual advertisements in these vape stores that specifically target what youth care about. We as Gen-Z are a visual generation: we care about sports, skin, and how we look. If these in-person required advertisements target ESD's effects it's much more probable that other teens will develop a well rounded perspective of just how detrimental these are. Along with more targeted advertisements, I encourage the ATCC and MDH to use the data from the end of year report to thoroughly look at the manufacturer's role in tobacco retail, tackling the root cause of this issue.

Finally, I support raising the licensing fee: the idea that counties will use \$100 from each license to enforce existing preventive laws shows Marylands' commitment to protecting teens from the dangers of vaping. I strongly support earmarking these allotments for these previously mentioned visual advertisements.

I urge you to vote in favor of this bill, the Tobacco Retail Modernization Act of 2024, and am looking forward to the development this bill will take on, as well as the continuation of youth voices in the implementation and editing process.

My name is Dr. Francesca Weaks, a Faculty Researcher at University of Maryland Center for Health Equity, where I have the pleasure to work with Dr. Stephen B. Thomas, Professor of Health Policy and Management and Director, the University of Maryland Center for Health Equity. I speak in my personal capacity today. I appreciate the opportunity to hear my support for Senate Bill 1056- Cigarettes, Other Tobacco Products, and Electronic Smoking Devices - Revisions (Tobacco Retail Modernization Act of 2024). I urge a favorable report on Senate Bill 1056.

According to the CDC (2023), 2.13 million U.S. middle and high school students reported using ecigarettes in the past 30 days, including 4.6% of middle school students and 10.0% of high school students. E-cigarettes are being marketed to youth and young adults as a less harmful alternative to cigarettes. Although true, e-cigarettes still contain potentially harmful substances, including nicotine, heavy metals like lead, volatile organic compounds, and cancer-causing agents (US Department of Health and Human Services, 2016).

E-Cigarettes contain nicotine, an addictive chemical that can have a significant impact on the development of adolescent's brains and can harm the parts of the brain that control attention, learning, mood, and impulse control until development ends at age 25(Taylor, 2014). E-cigarettes are a gateway to smoking cigarettes. Obisesan et. al (2019) found that youth e-cigarette and cigarette use have been associated with mental health symptoms such as depression.

I am deeply committed to helping to address the public health challenges of underserved

communities across Maryland and the country, and ensuring these communities have trust in the health care system and public health systems. I believe that updating the standing order to limit sales of tobacco products is an accountable and responsible decision for all Marylanders.

### On behalf of the Campaign for Tobacco-Free Kids, my name is Kristin Jimison, and I am here today in full SUPPORT of SB1056: The Tobacco Retail Modernization Act of 2024 ("TRMA").

We want to thank Senator Kramer for his leadership on this effort. We appreciate the Senator for meeting with us in the interim to discuss how we might approach reducing the harms of tobacco use on Maryland children, and very much appreciate his support and sponsorship of SB 1056.

We believe this bill offers common sense strategies for Maryland to reduce accessibility of tobacco products for kids in Maryland and to hold bad actors accountable for making products available to children. The bill also simply aligns with federal law in several instances. We look forward to working with the sponsor and other stakeholders should they have any suggestions to strengthen the bill.

Despite decades of progress in reducing smoking rates, kids are still accessing and using tobacco products, including ecigarettes in Maryland. Today over 48,000 Maryland high school students self-report using tobacco products. We have heard from countless teachers and students that vaping, in particular, is a tremendous problem in schools.

With tobacco companies continuing to market to a new generation of lifelong customers, we cannot rest on past progress, or risk backsliding as new products and new marketing strategies continue to attract kids to tobacco use. In fact, the tobacco industry spends \$8.6 billion annually in marketing - that's nearly one million dollars per hour, with more than \$95 million directly targeted at Marylanders.

The tobacco industry relentlessly targets our kids and other vulnerable communities. We need every tool possible to counter illicit sales and enforce tobacco laws. TRMA provides funding and tools to help Maryland's tobacco enforcement agencies hold bad actors accountable and limit the ability for kids to access tobacco products. It also ensures that we have current and accurate data to make informed future policy improvements.

With each year that passes, our *youth* tobacco crisis becomes an ongoing *adult* tobacco crisis and creates another \$3.14 billion in annual Maryland healthcare costs directly caused by smoking. The toll of human suffering is considerable. In fact, 27.5% of cancer deaths in Maryland are attributable to smoking.

A vast majority of Marylanders understand continued action must be taken, and support doing so: A recent poll conducted by OpinionWorks found that 81% of Maryland likely voters support taking further action to prevent the sale of tobacco to our kids.

The TRMA is a vitally important part of the long-term solution. It strengthens existing Maryland Law in three key areas: Licensing Reform

- o Increase the tobacco retailer license fee and use those funds to pay for enforcement activities.
- Increase penalty for sales to minors, authorize courts to temporarily suspend retail licenses for repeat violations, and offer the ability for courts to revoke licenses for especially bad actors.

Limiting Youth Access to Tobacco

• Adopt best practices including sale-to-minors audits, prohibiting sales in pharmacies, and restricting sales of ecigs/vapes to specially licensed dealers.

Youth Tobacco Access and E-Cigarette Study

 Study issues related to youth tobacco access and e-cig use, including mapping current retail license density and proximity to schools and healthcare facilities, and the public health impact to young people of tobacco and ecig/vape use.

These points of progress will help protect the health and future of our kids and prepare Maryland to win the war against tobacco-related addiction, disease and death.

For these reasons, The Campaign for Tobacco-Free Kids supports the TRMA and urges a favorable report from the Committee.

I even was familiar with a kid who would be selling them in school to other students as well. The only thing going through my mind at the time wasn't school work but it was more like I needed to get out of there as soon as possible. I didn't really get to hang out much after school because everyone around seemed to be addicted to these products and I didn't want to be dragged into these products with them.

After what felt like escaping the insufferable cloud in middle school I finally got to high school where I was thinking that finally people would be open with each other and not have their heads in their products. It seemed like wishful thinking but I was really hoping for the best. Just like my expectations with middle school, flavored tobacco seemed to be more severe in high school. Every time I go to the bathroom there is always someone in the stall and I can smell the flavored tobacco in the air. The administration has held multiple assemblies regarding this issue and they even closed the bathrooms on the third floor of my building. If that wasn't enough they even implemented a period where in the early morning we can only stay on the first floor until 20-25 minutes before class. I am so sick of all of these flavored tobacco products leaving an impact on my life. I have been trying to avoid this constantly but it is so apparent around me that I can never truly avoid it. Students seem to be at each other's throats just for some of these flavored tobacco products and it makes it hard to feel safe in my own school. I just try to get home as safe as I can because the last thing I want is to put my mom through grief just for accidentally getting in someone's way to get a puff of these products.

In order to pave a safer path for the students of the future these companies need to stop lying to the

youth claiming that these products are healthier than weed because they don't contain nicotine so they won't cause an addiction. But an addiction is caused due to an overflow of dopamine and as long as these youth can get that rush they will never quit and do anything to get that dopamine rush. Without a change society can easily take a turn for the worse leaving a dangerous environment for the kids of the future. Thank you for your time and consideration on this important legislation for heart health. My name is Laura Hale and I am the Director of Government Relations for the American Heart Association. The American Heart Association extends its support House Bill 1180 – Tobacco Retail Modernization Act of 2024 including the technical amendments offered by the sponsor.

We applaud Chair Wilson for putting in this strong piece of tobacco control legislation that makes sense for health and for business.

Strong retail licensure requirements are a proven way to prevent and limit youth use of tobacco products<sup>1</sup>. By increasing the cost to attain a license, the state can use these funds for better enforcement of tobacco control laws and will have funding to be process the paperwork. The current fee is so low, it doesn't account for the needs of the government to process the license and to do enforcement required for both state and federal compliance. Increasing these fees are essential in the business of running the state and will better equipe the state and local health departments to do enforcement checks. Maintaining these checks are essential and are also tied into federal compliance under the SYNAR program. SYNAR provides block grants to the state of Maryland that we can (and have in the past) lose for lack of compliance for selling to people under 21.

One in 10 middle and high school students under 18 report obtaining e-cigarettes at a gas station or convenience store<sup>2</sup>. By addressing where these items are sold we can also address increased use of these deadly products.

Places with stronger retail licensure requirements have lower rates of cigarette and e-cigarette use and initiation among both youth and young adults<sup>3</sup>. This bill strengthens the retail licensure

She waved it away, as if it was supposed to be normal and I was the one in the wrong for being concerned. I'd watch her energy deplete everyday. Her athletics and academics began to drop, while her eyes looked more and more bloodshot everyday. I watched her spend more and more time towards her addiction and she had less time to focus on other things. High school is not only the best years of your life, but also decides your future. She physically could not study and play as well as she used to. She still has not recovered from this addiction and it continues to consume a large part of her life. How is she supposed to do all the things required to get into a good college for a good future if she is consumed by tobacco constantly?

I witness students, my peers, being consumed by tobacco and vapes countless times throughout the day. It exhausts their body and you see the physical signs of the addiction they deny having. Many people I once knew are deeply changed by the ESDs they use everyday. Being surrounded by so many addicted people, I am often tempted to use as well. Vaping and tobacco use has become too normalized in today's world, especially in school. It is marketed and seen as something that you have lots of fun while doing and will miss out on if you do not participate. They way big tobacco companies make fun flavors, enticing packaging and advertisements, draws youth into these traps. This is especially detrimental to their health and can cause shortness of breath, lasting effects on brain development, and less stamina.

ESDs and OTPs shouldn't be so easily accessible to teenagers. Tobacco ads feed the notion that everyone smokes – and has lots of fun while doing it. It makes the youth feel like they're missing out. If tobacco and ESDs weren't so easy to buy, and they weren't so normalized among the youth, a lot of my peers, teenagers and kids around the world would not have their time stolen by this addiction.

Dear Chair Beidle,

I am writing to you as a parent, living in Riva, to express my support for SB 1056, the Tobacco Retail Modernization Act of 2024. I support this bill because as a parent of teens, I see how readily available vapes and nicotine/tobacco products are to minors. My kids avoid using the restrooms at school (Central Middle School and South River High School) because of the prevalent use of vape products in the restrooms.

Despite progress in tobacco control, the problem of youth access to tobacco products, including e-cigarettes, remains significant. Data indicates that over 48,000 Maryland high school students **self-report** they use tobacco products, a number that likely falls short of the true total. With lower odor than cigarettes and higher concentration of nicotine, vape products are easier for teens to conceal, while also being highly addictive. The marketing strategies and new products like flavored e-cigarettes target and hook kids, Big Tobacco's next generation of customers. What adult is using Peach Breeze vape to quit smoking. The Tobacco industry's claims that vapes help adults quit is a guise to allow them to get the next generation of customers addicted before leaving middle and high school.

The impact of youth tobacco use is both a public health and economic burden. Maryland incurs annual healthcare costs of approximately \$3.14 billion directly related to smoking, and 27.5% cancer-related Maryland deaths can be traced to tobacco use. We must act now to mitigate its influence on the health of our children and our communities at large.

SB 1056 proposes to impose stricter penalties on illegal sales to minors, including increased fines and potential license suspension for violators, restrict access to vapes to licensed dealers, and mandates a study on youth access to tobacco products. It also increases the cost of the tobacco retail license to help fund enforcement activities by our state and county agencies that help protect our communities from bad actors. These steps are crucial for developing effective healthcare and public health strategies to protect Maryland's youth and to ensure that retailers are held accountable to state and federal law.

Dear Chair Beidle and Committee members:

The Maryland Department of Health (Department) respectfully submits this letter of support with amendments for Senate Bill (HB) 1056 – Cigarettes, Other Tobacco Products, and Electronic Smoking Devices - Revisions (Tobacco Retail Modernization Act of 2024). SB 1056 updates licensing requirements and business operations for tobacco retailers in Maryland. As written, SB 1056 also requires the Department to conduct at least two unannounced inspections of licensed tobacco retailers each year and to conduct a one-time study of tobacco retailers and statewide tobacco enforcement efforts in conjunction with the Alcohol, Tobacco, and Cannabis Commission (ATCC). Finally, SB 1056 prohibits the sale of all tobacco products in pharmacies.

SB 1056 updates the regulatory scheme for licensing tobacco retailers in Maryland and better aligns Maryland law with evidence-based practices in tobacco use prevention and control. The Department supports many of the provisions of SB 1056, including: (1) increasing licensing fees to \$300; (2) increasing civil penalties for tobacco retailers who are found out of compliance; (3) requiring retailers to keep cigarettes, other tobacco products, and electronic smoking devices (ESDs) behind-the-counter and to verify all purchasers are at least 21 years old with a government-issued identification; (4) restricting the sale of all ESD products to the premises of licensed vape shop vendors; and (5) prohibiting the sale of all tobacco products in Maryland pharmacies. The Maryland Comptroller,<sup>1</sup> and several organizations, including the Centers for Disease Control and Prevention (CDC), the American Heart Association, the American Lung Association, and the Campaign for Tobacco-Free Kids recommend implementing such retailer strategies to address health equity and reduce youth tobacco use.<sup>2,3,4,5</sup>

The popularity of ESDs with Maryland youth is concerning as nicotine adversely affects adolescent brain development and mental health.<sup>6</sup> Youth who start using ESDs are more likely to completely transition to cigarettes or use both ESDs and cigarettes, putting them at risk for a lifelong addiction to nicotine and other substances.<sup>7</sup> Restricting ESD sales to licensed vape shop vendors will further limit youth access to ESDs as convenience stores and gas stations are common sources of tobacco products for youth, including ESDs. As written, SB 1056 would also restrict sales of ESDs to in-person on the premises of a vape shop, effectively eliminating online sales. SB 1056 also prohibits tobacco product sales in pharmacies. At least two other states and hundreds of US jurisdictions have also banned tobacco sales in pharmacies to the benefit of public health.<sup>8</sup> Professional organizations, pharmacists, pharmacy chains, and the public overwhelmingly support policies like SB 1056.<sup>9</sup>

SB 1056 would have a fiscal and operational impact on the Department as written. The Department has been working on amendments with other advocates and the sponsor. The amendments would offset the costs of SB 1056 and allow for more efficient operationalization of the bill. Among other amendments, the Department suggests reducing the number of required tobacco enforcement inspections from two inspections per retailer to one inspection per calendar year and allowing the Department *or their designee* (i.e., local health departments) to conduct inspections significantly reduces costs for the Department which were outlined in the original fiscal note. If accepted, the full set of amendments would allow the Department to offset the costs of the bill with the revenue generated by the increased retailer licensing fees, while also ensuring that the bill conforms to federal requirements limiting tobacco sales to individuals age 21 and over. As a result, the bill as amended would eliminate the significant fiscal impacts of the original language.

The Maryland Department of Health (Department) respectfully submits this letter regarding the estimated fiscal impact that Senate Bill (SB) 1056 – Cigarettes, Other Tobacco Products, and Electronic Smoking Devices - Revisions (Tobacco Retail Modernization Act of 2024) would have on the Department as amended.

The Department has appreciated working with Senator Kramer on this bill. With the amendments put forward by Senator Kramer yesterday in the final reprint, the Department estimates that this bill would be fiscally neutral. With Senator Kramer's amendments, SB 1056 would allow the Department to work through designees versus establishing a new program in house, while also generating revenue to conduct enforcement activities for the Department and Montgomery County by increasing retailer licensing fees, from \$25 to \$300. As amended, SB 1056 distributes \$25 to the Executive Director of the ATCC, and \$275 to the Department or, for retailers in Montgomery County, to Montgomery County. An existing carve out in statute allows Montgomery County to conduct their own inspections of the approximately 675 tobacco retailers within the County. With approximately 6,500 tobacco retailers in Maryland, including 675 retailers in Montgomery County, increases in licensing fees could generate up to \$1,601,875 in revenue for the Department and \$185,625 for Montgomery County to offset the costs of conducting retailer inspections through designees, including local health departments.

The revenue from the licensing fees to the Department would also offset the other costs of SB 1056. Specifically, the Department will have to hire an additional staff person to assist with coordinating funding of and reporting from local health departments; notify and distribute

updated materials to retailers, local health departments, and other partners regarding the new provisions of the bill; and conduct a one-time study of tobacco enforcement efforts with ATCC. We estimate the total costs of these expenditures to be less than the revenue generated from the fees.

MDDCSAM strongly supports the enhanced tobacco product placement and age verification provisions, the additional licensure requirement for the manufacture, distribution or sale of electronic smoking devices, and the prohibition of pharmacy sales of tobacco products and electronic smoking devices. Each of these provisions will reduce tobacco use and use disorder among youth and adults. Tobacco and e-smoking device are inherently dangerous products to which most customers become addicted. *Most long-term tobacco product users wish they could quit.* 

Tobacco use is one of the leading causes of preventable death and disease in the U.S.

We strongly support an amendment to remove the age exemption for active-duty military which **conflicts with federal law.** In 2019, federal legislation eliminated the military exemption to the prohibition of tobacco sales and related products to people under age 21. This bill will bring Maryland in alignment with federal law, and will save lives.

According to a Philip Morris internal document dated January 21, 1986, "Raising the legal minimum age for cigarette purchaser to 21 could gut our key young adult market (age 17-20) ..." (https://www.tobaccofreekids.org/what-we-do/us/sale-age-21)

Young people serving in the military deserve to have their health preserved as much as others in their age group. Historically, smoking rates have been particularly high among those serving in the military. Veterans Administration hospitals have been known for a high proportion of patients with tobacco-caused diseases such as chronic lung disease, heart disease, cancer in various organs, stroke, peripheral vascular disease, amputations, and other manifestations of tobacco addiction.

## We also support an amendment to allow local health departments to assist in enforcing youth access provisions such as product placement and age verification, and other provisions of the law.

We are pleased to support, with amendments, this important legislation which will improve the lives of youth and adults for decades to come.

**POSITION RATIONALE:** The Maryland Association of County Health Officers (MACHO) supports SB 1056 with amendments. This bill recognizes the current challenges of enforcing existing tobacco/vaping regulations and the persistently high use of these products by teens. Public health officials agree with the value of more effective enforcement to reduce underage sales of vape and traditional tobacco products.

Historically, local health departments (LHDs) have been charged with inspections of tobacco and vape retailers to enforce laws prohibiting sales to underage customers. In the wake of the 2008-09 recession, the Maryland Department of Health (MDH) abruptly stopped grants to LHDs from the Cigarette Restitution Fund that paid for enforcement efforts. As a direct result, within one year, more than 20% of retailers were violating Maryland law by selling vape and tobacco products to underage purchasers. This high rate of underage sales continued over multiple years and triggered a federal regulation that threatened \$40 million in substance abuse grants to Maryland. It was only this threat to losing tens of millions of dollars that prompted the restoration of state funding to LHDs for compliance checks.

The proposed increase in tobacco and vape retail licenses under SB 1056 is intended to improve the effectiveness of compliance checks and drive down underage use of nicotine products. Maryland's health officers favor amending SB 1056 to assure the revenue goes to the agencies responsible for enforcement, namely LHDs. We have seen first-hand the consequences of leaving funding to the discretion of a state agency, namely a complete disruption of enforcement resources with a resulting spike in underage vape and tobacco sales and violations of federal requirements. Dependable funding for local programs will increase capacity in larger jurisdictions and allow creative regional enforcement partnerships in more rural areas. Rural partnerships can produce dedicated staffing to not only meet, but to exceed the requirements in SB 1056. Dedicated staffing can also work with local school systems to take a more holistic approach to education and enforcement.

To better fund the staffing needs required for additional inspections, MACHO recommends: **Deletion of the text on Page 4, Lines 5-7 and replacing it with the following:** 

(ii) \$275 TO THE MARYLAND DEPARTMENT OF HEALTH. \$35 OF WHICH WILL BE RETAINED BY THE DEPARTMENT TO FULFILL THEIR OBLIGATIONS UNDER THIS STATUTE. THE REMAINING \$240 SHALL BE DISTRIBUTED TO JURISDICTIONS PROPORTIONAL TO THE NUMBER OF TOBACCO AND ELECTRONIC SMOKING DEVICE RETAIL LICENSEES IN EACH JURISDICTION AS FOLLOWS:

### 1. IN MONTGOMERY COUNTY, THE COUNTY WILL RECEIVE FUNDS TO BE USED TO ENFORCE EXISTING LAWS BANNING THE SALE OR DISTRIBUTION OF TOBACCO PRODUCTS OR ELECTRONIC SMOKING DEVICES TO INDIVIDUALS UNDER THE AGE OF 21

#### 2. IN ALL OTHER JURISDICTIONS, LOCAL HEALTH DEPARTMENTS WILL RECEIVE FUNDS TO BE USED TO ENFORCE EXISTING LAWS BANNING THE SALE OR DISTRIBUTION OF TOBACCO PRODUCTS OR ELECTRONIC SMOKING DEVICES TO INDIVIDUALS UNDER THE AGE OF 21

The portion of the license fee retained by MDH is based on their own estimate of the annual costs of nonenforcement elements of SB 1056. The proposed allocation removes the fiscal impact both on MDH and on LHDs. It shields local programs from the inevitable general economic declines and will allow for meaningful improvements in enforcement and more expansive approaches to reducing vaping and traditional tobacco use among teens.

The Maryland Association of Counties (MACo) **SUPPORTS** SB 1056 **WITH AMENDMENTS**. This bill is focused on combatting the adverse health effects of tobacco and other related products in communities. Specific to counties, it increases the licensing fee to sell these products and the number of inspections that must be done annually to ensure compliance with standards for providing these products in a retail setting.

Counties have hundreds of locations selling these products in their jurisdictions, while concurrently undertaking substantial efforts, both financial and operational, to remediate the negative effects these products have on the health of residents, particularly children. Law enforcement agencies, schools, and local health departments bear the brunt of this task, and their efforts are limited by the necessary funding to provide services. These programs include prevention education, smoking cessation resources, classes, social and traditional media campaigns, and the like. Counties appreciate the funding that would be allocated to local governments to aid in these remediation initiatives, but would recommend a larger portion of the new fine allocated to local governments who are doing this work.

The bill as written sends \$100 of the \$300 license fee to county governments, which is a portion that lacks an appreciation for the financial burden counties incur purely as a result of the licensing. Counties would increase the share of that fee sent to the local governments to supplement their existing remediation efforts. Additionally, counties believe the Alcohol, Tobacco, and Cannabis Commission should be tasked with the full responsibility of performing inspections, rather than delegating these duties to county governments.

SB 1056 takes a number of important steps to fight dependence on tobacco and electronic cigarettes for community members suffering the consequences of these products. Counties appreciate that, and the recognition of our efforts, and believe these amendments will help local governments achieve the full intent of the bill. For these reasons, counties urge a **FAVORABLE WITH AMENDMENTS** report on SB 1056.

# Written Testimony Regarding SENATE BILL 1056 FAVORABLE WITH AMENDMENTS

Esteemed members of the Finance Committee, and online guests...

My name is Scott Webber and I am the founder of the Vaping Awareness Public Education Society, a non-profit public health research organization dedicated to reducing cigarette smoking and the resultant cost in both dollars and lives.

I come before you today advocating for a FAVORABLE Report, but only upon the adoption of certain improving AMENDMENTS.

### Issues NOT Specific To SB1056 [ Obligatory Annual Reminder ]

Again... 'vaping devices' are NOT 'Smoking Devices' because there is NO SMOKE! As is almost universally known, 'smoke' is the produce of combustion. Vaping devices do not produce combustion. Vaping devices do not produce smoke. Defining a 'vaping device' an 'Electronic Smoking Device' is as logical, and accurate as calling a Tesla a 'Gasoline Powered Electronic Vehicle'. Defining vaping 'clouds' as 'smoke', when there is NO SMOKE, is just pure false. Such mis-defining is the product of either extreme lack of knowledge [Teslas are NOT powered by gasoline] or deliberate deceit because the definer has a specific reason for wanting to define the Tesla as a 'gasoline powered' device, in complete defiance of observable and obvious 'truth' to the contrary. Neither is acceptable.

The Maryland legislature should strive to be both truthful and accurate in the formation of the laws of the land. Definitions should conform to the meanings and understandings of populace upon which they apply. If it is not 'tobacco', it should not be called 'tobacco'. If it is not 'smoke', it should not be called 'smoke'. Deliberately, or intentionally defining, or even inferring the meaning, of anything that is known to be demonstrably false, is simply bad public policy, bad governance, and bad law.

### Issues Specific To SB1056 - Concurrence with the Intent of the Bill

SB1056 rightfully concentrates vaping sales in VAPE SHOPS!! This is where vapers should be purchasing their vaping equipment and supplies. Vape Shops function as extraordinarily effective harm reduction and smoking cessation support centers. They are staffed almost exclusively by personnel who understand the smoking addiction, and are ideally situated – and qualified - to assist smokers in the transition away from smoking.

SB1056 removes harmful, deadly, unhealthy tobacco products from pharmacies, which are intended to be destinations for finding health-related products.

### Issues Specific To SB1056 – Amendments to Text in the Bill

SB1056 should not have a carve-out for 18-20 year olds, regardless of military status.

AMENDMENT: Remove the under 21 exemption. [P.3:L14, et seq]

SB1056 should be strengthened to require any vaping, tobacco, or other tobacco products to completely out of sight of any individual under the age of 21. Display of any such products should be relegated exclusively to rooms restricted to persons verified to be over the age of 21.

AMENDMENT: Modify all sections referring to 'behind a counter', and replace such language with requirements that the display of any vaping or tobacco-related product shall be restricted to areas not physically or visually accessible to persons under the age of 21.

SB1056 should not restrict the verification of a person's age to face-to-face exchanges. Electronic devices such as ID Scanners are valuable tools to detect fraudulent identification.

AMENDMENT: Remove all restrictions involving the age-verification assistance of electronic or mechanical devices.

SB1056 should not restrict the purchasing or ordering of vaping devices or supplies via mail, or various electronic networks. As a matter if issue, 100% of all credit card transactions are transacted over various electronic networks. Instead, the language should simply be modified to require the PICK UP of any such orders to be done by an age-verified individual in the Vape Shop.

AMENDMENT: Retain the purchase or order ability under the current law, but ADD a section that requires the pickup of the product from a Licensed Vape Shop, and only after proper age verification.

SB1056 defines "Vape Shop Vendor" too restrictively in its demand for 'exclusivity'. There are many Vape Shops that also sell magazines, snacks, water, etc. These products should not be disallowed, but rather, the spaces in which they are sold should be held to all other requirements of a 'Vape Shop'; eg: holding a 'Vape Shop Vendor' license; the area is physically or visually inaccessible to persons under the age of 21, etc.

AMENDMENT: Remove all requirements of 'exclusivity', and replace it with requirements that any non-vaping products sold within any space designated as a 'Vape Shop' must adhere to all 'Vape Shop' restrictions and regulations.

### **Review Of Vaping Basics:**

It is a simple truth that smoking remains that #1 cause of preventable death; Worldwide, Nationally, and Statewide. Every year, almost a half a million people die in the US from smoking and smoking-related illness. In Maryland, that number is about 7500 deaths annually, or close to 75,000 this past decade.

To put this into perspective, this is 5 times more than ALL COVID deaths, and 3 times the number of annual deaths from opioids.

The number of deaths from vaping? The truth is not one single person – Statewide, Nationwide, or Worldwide has died from regular vaping – EVER.

It is also true that vaping is the most effective technology ever developed to get smokers to reduce or quit smoking. This claim is supported by the incontrovertible empirical evidence that there are 15-20 million vapers that are vaping more... and smoking less, and no other product or technology can claim that success.

It is also an undeniable truth that with the increase in vaping, there has been a dramatic DECREASE in smoking, for both adults, AND youth, resulting in the lowest rates of underage smoking in history.

Smart legislation would incentivize the successfully migration of 100% of smokers to vaping, and save thousands of lives, and tens of millions of Maryland taxpayer dollars.

Vaping is NOT the problem, and any legislation that dissuades smokers from migrating to a safer, healthier, less harmful alternative, becomes part of the problem. Any legislation that encourages and successfully converts a smokers into vapers, is good public policy.

The VAPESociety strongly requests that the Committee issue an **FAVORABLE** report on SB1056 if it incorporates the above AMENDMENTS, seen as assisting the favorable migration from deadly, combustible cigarettes.

### The Impact Of Vaping On Combustible Cigarette Smoking Cessation

The following literature review is a random assortment of scientific and medical articles and position papers pertaining to the use of the disruptive technology called 'Vaping' used by tens of millions of people worldwide to reduce or eliminate cigarette smoking. The articles come from a broad spectrum of sources including the New England Journal of Medicine, the Journal of the American Medical Association, British Medical Journal, BMC Medicine, the International Journal of Environmental Research & Public Health, the Journal of Nicotine & Tobacco Research, Addiction, the National Academies, and others. The research goes back to early in the last decade, up to current. Policy papers are included from the right-wing leaning and libertarian Heartland Institute, and the left-wing leaning Progressive Policy Institute - with both sides of the political spectrum strongly supporting the principles of 'Harm Reduction' to achieve the greatest economic, and public health benefits, with vaping at the center of the discussion due to its unparalleled success and clear benefits.

Ironically, while vaping has proven to be the single most effective means to get smokers to completely quit or greatly reduce their cigarette consumption, the vaping industry is forbidden - by law - to claim, or mention, or even suggest, that vaping can be an effective 'cessation' solution. Accordingly, you will find very little industry documentation. Nonetheless, the evidence, the data, the facts, the science, and the scientists back up the incontrovertible fact that vaping has worked as a cessation solution in the most important arena of empirical evidence: the literally tens of millions of vapers who have ceased using combustible cigarettes.

VAPESTake:	Vaping is not entirely 'safe', but it is many magnitudes 'SAF <u>ER</u> ' than smoking. Smoking is seriously estimated to be at least 2000% more harmful. Smoking kills nearly a half million Americans EVERY year, while legal nicotine vaping has not resulted in a single death <sup>1</sup> – worldwide – since it was invented and made commercially available in 2006.

**Quoted:** *"Previous research has found that when used in this way, e-cigarettes increase the chances of success by around 50% compared with using no support or one of the traditional nicotine products such as gum or skin patch."* 

"E-cigarettes appear to be helping a significant number of smokers to stop who would not have done otherwise - not as many as some e-cigarette enthusiasts claim, but a substantial number nonetheless."

**VAPESTake:** This is a 2016 study looking at 2014 data, so the raw numbers are significantly higher now, but the fundamental understanding that vaping has helped a staggering number of people to reduce or quit smoking entirely remains true. The effectiveness of vaping has been observed for a very long time, and the body of evidence is only growing.

Cigarette cravings were sharply reduced or completely eliminated, and withdrawal symptoms were minimal.

**VAPESTake:** This well-thought-out perspective piece from no other than the preeminent New England Journal Of Medicine, frames the current debate well. "Vape shops have the potential to play an important role in tobacco harm reduction, which could be increased if their service model were to extend to help smokers to quit."

**VAPESTake:** 'Success' should be measured by its level of success. Specialty vape shops were predominantly opened by former smokers who successfully transitioned from smoking cigarettes, to vaping. Specialty vape shops almost exclusively hire vapers who understand and can recount their own successful journey from cigarettes to vaping. The undeniably simple truth that tens of millions of smokers have successfully reduced or completely stopped smoking through vaping, is in itself a success story that should be celebrated, but this success was only made possible as the result of thousands of successful, small business, neighborhood corner, friendly Mom-N-Pop, family-owned, smoking-cessation centers... that are not even allowed to claim they help people quit smoking because Big Government – and Big Tobacco – and Big Phama – are terrified of their success.

Shutting down and destroying the most successful smoking cessation system ever designed, would not be a 'success' under any definition.

### **Closing Remarks From The Vaping Awareness Public Education Society**

The human consumption of nicotine from the tobacco plant dates back to 5000 BC, and is not likely to be abolished this year... or decade... or century.

### 2024 SESSION POSITION PAPER

BILL:SB 1056 – Cigarettes, Other Tobacco Products, and Electronic Smoking Devices –<br/>Revisions (Tobacco Retail Modernization Act of 2024)COMMITTEE:Senate Finance CommitteePOSITION:Letter of Support With AmendmentsBill ANALYSIS:SB 1056 would prohibit licensees that sell cigarettes, other tobacco products, or<br/>electronic smoking devices at retail from displaying those items for sale unless<br/>located behind a counter, require verification of a date of birth for certain<br/>individuals before sale, and make other changes to current law.

**POSITION RATIONALE:** The Maryland Association of County Health Officers (MACHO) supports SB 1056 with amendments. This bill recognizes the current challenges of enforcing existing tobacco/vaping regulations and the persistently high use of these products by teens. Public health officials agree with the value of more effective enforcement to reduce underage sales of traditional tobacco and vape products. Several times during recent years, inspections have revealed that greater than 20% of Maryland retailers have sold vape and tobacco products to underage purchasers. Local health departments (LHDs) are involved with the inspections of these retailers related to tobacco compliance enforcement.

To better fund the staffing needs required for additional inspections, MACHO recommends:

### Deletion of the text on Page 4, Lines 5-7 and replacing it with the following:

# (ii) \$225 TO THE COUNTY'S LOCAL HEALTH DEPARTMENT(iii) \$50 TO THE MARYLAND DEPARTMENT OF HEALTH'S PREVENTION AND HEALTH PROMOTION ADMINISTRATION

Enforcement is statutorily delegated to County Health Officers and law enforcement personnel, not county governments. In jurisdictions where law enforcement takes a role in tobacco/vape enforcement, it is through contracts with local health departments. To accomplish the goal of reducing sales to underage individuals, additional revenue generated by the licensing changes in HB 1180 should go primarily to LHDs. It is reasonable to allocate a portion of new revenue to the Maryland Department of Health to fund better coordination of statewide enforcement efforts, provide technical assistance to LHDs, and increase capacity for MDH to work with the Maryland State Department of Education to reduce vaping in schools.

Because local health departments are at the center of enforcement in communities across the state, MACHO asks that a Health Officer be included in all subcommittee discussions of SB 1056.

For these reasons, the Maryland Association of County Health Officers submits this letter of support with amendments for SB 1056. ### SB1056 Cigarettes, Other Tobacco Products, and Electronic Smoking Devices -Revisions (Tobacco Retail Modernization Act of 2024) Finance Committee March 7<sup>th</sup>, 2024

### **Position:** Unfavorable

The Maryland Retailers Alliance (MRA) has serious concerns about the overall impact of a slate of proposals introduced this year regarding tobacco sales. It appears that the legislature intends to use regulation as a vehicle for removing tobacco from the state through a combination of policies including high tax rates and retail sale prohibitions. We have chosen to address several bills in one document as these bills are scheduled to be heard in separate committees and on separate dates, and we want to ensure that each body is considering the full scope of these proposals and the impact of these policies as a package rather than passing them in a vacuum.

Our membership does not disagree with an intent to address minors' use of illegal products, but the manufacturing and sale of tobacco products is already a highly regulated industry. Age-restriction laws are in place to keep these items out of the hands of children, and consumers in Maryland face some of the highest taxes on tobacco in the country at \$3.75 per pack of 20 cigarettes – higher than all of our neighboring states: Virginia (\$0.60 per pack), West Virginia (\$1.20 per pack), Pennsylvania (\$2.60 per pack), Delaware (\$2.10 per pack), and even Ohio (\$1.60 per pack), North Carolina (\$0.45 per pack), and New Jersey (\$2.70 per pack).

Restricting or prohibiting the sale of products is often well-intentioned and seems like the simplest solution to curb tobacco use: ban or make it difficult for tobacco customers to buy their preferred products, and they will stop using them. We know from cases around the country where governments have passed local flavored tobacco bans that this is not the case. Customers who cannot conveniently purchase these products in Maryland will go to another state to buy the items that they are looking for. There are over 1,600 tobacco retailers within ten miles of Maryland's border in neighboring jurisdictions and no Marylander lives farther than 35 miles from a tobacco retailer across the state line. Users who face a barrier to travel will simply get their products online or illegally from the black market.

We support a regulated industry, and that includes making sure that the products that are available to customers are vetted items. Efforts to curb use that could result in increased black market activity may be detrimental to the health of adult consumers of tobacco products, and we would respectfully urge the Committees to strongly consider this when discussing these bills.

### SB1056/HB1180 Cigarettes, Other Tobacco Products, and Electronic Smoking Devices -Revisions (Tobacco Retail Modernization Act of 2024)

SB1056 would, among other things, prohibit retailers with a pharmacy permit from selling tobacco products. As a proponent of the free market, we strongly oppose this prohibition which would restrict access to legal, regulated products for purchase by consenting adults. This is of extremely serious concern to not only our retail chain drug stores but also grocery stores in Maryland that provide a pharmacy counter in their community. It is unclear in the bill whether this prohibition on sales in pharmacies would apply only to the pharmacy area in grocery stores, or if retailers would be restricted from selling any tobacco products anywhere in a store that also includes a pharmacy counter.

Marylanders are accustomed to being able to buy a variety of goods outside of the primary categories of food and medicine at both grocery stores and pharmacies, with retail pharmacies often meeting consumer needs by operating as a small general store in many communities. As noted in our introduction, restricting access to legal products may only drive consumers to shop in jurisdictions outside of Maryland or to purchase their desired items through illegal, unregulated channels. We strongly oppose this proposal and believe that it would harm the business community in Maryland without effectively reducing tobacco use in the state.

We would urge an unfavorable vote on SB1056.

## HB1033/SB987 Business Regulation - Electronic Smoking Devices Manufacturers – Certifications

HB1033 would require the establishment of a directory of electronic smoking devices that have been approved for sale by the Food and Drug Administration (FDA), ostensibly in an effort to reduce the proliferation of illegal products in the market. We do not oppose the goal of this legislation but there are issues with the bill as proposed.

The directory created by HB1033 would allow the sale of products that have already received approval for sale by the FDA but the bill does not include any statutory requirement to update the directory as new products are approved. This omission fails to address products that were submitted for federal consideration by the September 9, 2020 deadline but which have not yet received a final decision from the FDA.

A separate bill being considered this year, HB1197, proposes a similar directory but requires the Office of the Attorney General to update the directory as needed in order to correctly reflect approved products. Our members have expressed a preference for HB1197 over HB1033 due to this difference.

We would urge an unfavorable report on HB1033.

HB844/SB582 Business Regulation - Cigarette, Other Tobacco Product, and Electronic Smoking Device Retailers - Nicotine Replacement Therapy Products (Make Quitting Convenient Act)

HB844 would require any retailer that sells tobacco products to also sell nicotine replacement therapy products and to post signage in stores. It is inappropriate for the legislature to mandate that retailers carry specific products and to even establish parameters around ordering and stocking timelines, which can vary widely between individual business practices.

In addition to this overreach, the signage requirements in HB844 would be burdensome for businesses. "Real estate" space for notices and signs in stores is a tight market, and customers are already overwhelmed with signs on a multitude of topics in aisles, at the entrance of stores, and at the point of sale, especially in stores like pharmacies, grocery stores, and convenience stores that sell a wide variety of items. A federal order already exists which mandates that businesses post signage about the dangers of smoking, and this should be sufficient to suggest changes to consumer behavior.

We would urge an unfavorable vote on HB844.

## HB1197 Business Regulation - Electronic Smoking Devices Manufacturers – Certifications

HB1197 would require the establishment of a directory of electronic smoking devices that have been approved for sale by the Food and Drug Administration (FDA), ostensibly in an effort to reduce the proliferation of illegal products in the market. Unlike HB1033, HB1197 would require that the directory be updated to reflect products that have been newly approved for sale by the FDA, as many items were submitted for review by the federal deadline in 2020 but have yet to receive final determination. A similar bill was recently passed in Virginia and HB1197 would create a consistent market between Maryland and our close neighbor, decreasing the likelihood of consumers crossing the state line in search of specific legal products. Our members have expressed a preference of HB1197 over HB1033 for these reasons.

We would support a favorable report on HB1197.

### HB1073 Tobacco Tax - Cigarettes - Rate Alteration

HB1073 would increase the sales tax rate on cigarettes from \$3.75 per pack of 20 cigarettes to \$4.50 per pack, and from 17.5 cents per cigarette in a larger pack to 22.5 cents per cigarette. As noted in our introduction, Marylanders already pay a higher tobacco tax than consumers in any of our immediately neighboring states and beyond, and can reach cigarette retailers in any of those states by driving less than 40 miles. This regressive tax would primarily impact tobacco use for consumers who cannot travel even that simple distance, and could result in higher sales in the black market rather than any

actual reduction in tobacco use. Increasing the tax on cigarettes by almost \$1.00 per pack would increase "border bleed" sales and harm businesses by greatly increasing the price of legal, regulated products for adult consumers.

We would urge an unfavorable report on HB1073.

HB1414 Electronic Smoking Devices - Licensure, Indoor Use, and Taxation – Alterations

HB1414 would, among other things, increase the sales tax rate on electronic smoking devices from 12% to 30%. As noted in our introduction, regressive tax increases such as this merely encourage consumers to cross Maryland's very close borders to purchase their desired products. Increasing prices as a method to encourage a change in consumer behavior is inappropriate for these items, as is using the consumption of certain products as a method of increasing tax revenue. Increasing this tax would harm businesses and increase prices for legal items for use by adults in Maryland. Other bills have been introduced which would update the Clean Indoor Air Act to restrict the indoor use of electronic smoking devices, and which have not been opposed by MRA.

We would urge an unfavorable report on HB1414.
