### **Health Occupations - Pharmacists - Administration of Vaccines HB0076**

Good afternoon,

My name is Ayo H. Kimathi. In 2022 and 2023, I testified against many bills proposed in Maryland seeking to seductively force unwanted and undesired bioweapon technologies on the public. # Technology Injection & Emergency Health Agenda Bills

This email is to contextualize a couple of bills that are collectively designed as part of a larger effort to force dangerous technology and accompanying agendas, under the guise of helpful "vaccinations" and emergency health procedures, on the residents of Maryland.

By now, most American citizens are aware of the fact that the injections provided to the public called COVID-19 "vaccinations" do not prevent people from getting sick nor spreading the sickness. They are not vaccinations. They are an emerging form of gene-altering technology called mRNA. At least since 2022, we witnessed bills coming out of Maryland trying to force mRNA injections and accompanying emergency health agenda bills on residents. Here is a short list:

## <u>2022</u>:

# SB839 - Maryland Voluntary COVID-19 Vaccine Passport

This would allow a moderate system of slavery to be instituted where people with "passes" or passports are treated preferable to those without passports.

# SB840 - COVID-19 Response Act of 2022

This bill would have allowed the state of Maryland to legally require the state to murder Maryland citizens who tested "positive" for COVID-19 by mandating the Remdesivir protocol. Remdesivir is a poisonous medication that has proven to destroy the kidneys, liver, and other organs. It's a lethal concoction used in America when people test "positive" for COVID-19. Thousands of Americans were murdered under the guise of COVID-19 when they were and are actually being killed with the Remdesivir protocol.

#### 2023:

#### **SB378 - Vaccinations: Minor Consent**

This bill was pulled by the sponsor. However, it will likely return next year. It is a basic carbon copy of the Washington, DC <u>Minor Consent for Vaccination Act of 2020</u> we fought and achieved an injunction on in March 2022. DC pushed to make 11 year olds into adults and authorize them to get the mRNA injections without parental consent and Maryland was seeking to do it for 14 year olds and above. Both bills are designed to rob parents of their right to protect our children. Also, both laws are aimed at forcing this mRNA DNA-altering technology into the bodies of our children. (PS: We are uncomfortable with the language "Minor Consent" as it has obvious pedophilic undertones.)

#### HB 1232 (SB372) - Pharmacists: Administration of Vaccines

This bill is the same as bill SB378, except it extends the capacity for children as young as (3) years old to be injected with this mRNA technology by pharmacists – who are not doctors. This can be done w/o their parents' knowledge or consent.

Beyond the obvious attempts to inject people's children without the parents giving permission or having informed consent, the danger of these injections presents a worse threat.

The Vaccine Adverse Events Reporting System (VAERS) is the most popular system used by the US Federal government to track death and injuries from vaccinations and the new mRNA technology injections. It was started in 1990. More deaths have been reported in the 1<sup>st</sup> (2) years from the mRNA injections than the combined total of all vaccines given over the past (32) years. This makes these injections the most dangerous injections passing as medicine in the history of America.

Additionally, I have included the Pfizer document published in April 2021 where they listed over 1,200 known adverse side effects of their mRNA COVID-19 injection. Nevertheless, they pushed to get the CDC to approve it for giving to the American public.

In short, not only should we not have bills allowing pharmacists and/or doctors to give these dangerous injections to children w/o their parents' permission, but we shouldn't be allowing any American citizen to receive known dangerous genealtering technology into their bodies.

All of these bills are designed to force us to accept these gene-altering technology injections into our bodies and the bodies of our children. And after they do it, they want to be able to track us and control those who don't comply.

For these reasons, we request that you vote against HB1232 and all bills that push these agendas in the future.
