## AMENDMENT TO HOUSE BILL 822

(First Reading File Bill)

On page 2, in line 24, strike "DEPOSITED BY THE" and substitute "<u>OF A</u>"; in line 25, after "RECIPIENT" insert "<u>OR FUNDS FROM OTHER SOURCES DEPOSITED BY OR</u> FOR THE RECIPIENT;

(II)";

in the same line, strike "WITH" and substitute "<u>FOR WHICH THERE IS</u>"; in line 26, after "YEAR" insert "<u>AND DEPOSITED INTO THE ACCOUNT</u>"; and in line 27, strike "(II)" and substitute "(III)".

On page 3, in line 21, after "(5)" insert "(I)"; in line 23, after "INCOME" insert "; AND

- (II) ESTABLISH MONTHLY PREMIUM CONTRIBUTIONS
  LEVELS FOR RECIPIENTS WITH COUNTABLE INCOME LEVELS ABOVE 300% OF THE
  FEDERAL POVERTY LEVEL IN ACCORDANCE WITH SUBSECTION (D) OF THIS
  SECTION.
- (D) FOR RECIPIENTS WITH COUNTABLE INCOME LEVELS ABOVE 300% OF THE FEDERAL POVERTY LEVEL, THE MONTHLY PREMIUM LEVELS SHALL BE AS FOLLOWS:

- (1) FOR A RECIPIENT WITH A COUNTABLE INCOME THAT IS AT LEAST 301% BUT LESS THAN 451% OF THE FEDERAL POVERTY LEVEL, THE MONTHLY PREMIUM AMOUNT IS \$129;
- (2) FOR A RECIPIENT WITH A COUNTABLE INCOME THAT IS AT LEAST 451% BUT LESS THAN 601% OF THE FEDERAL POVERTY LEVEL, THE MONTHLY PREMIUM AMOUNT IS \$242; AND
- (3) FOR A RECIPIENT WITH A COUNTABLE INCOME THAT IS AT LEAST 601% OF THE FEDERAL POVERTY LEVEL, THE MONTHLY PREMIUM AMOUNT IS \$484.
- (E) SUBJECT TO SUBSECTION (F) OF THIS SECTION, THE DEPARTMENT MAY ADOPT REGULATIONS THAT DEVELOP SPECIFIC ELIGIBILITY CRITERIA FOR PARTICIPATION IN THE EID PROGRAM";

in line 24, strike "(D)" and substitute "<u>(F)</u>"; in line 28, strike "OR"; in lines 29 and 30, strike "APPLICANT OR THE APPLICANT'S" and substitute "<u>APPLICANT'S OR RECIPIENT'S</u>"; and in line 30, strike ", INCLUDING:" and substitute "<u>THAT ARE NOT JOINT ASSETS FOR A RECIPIENT</u>;".

On page 4, strike in their entirety lines 1 through 3, inclusive, and substitute:

- "(III) ANY RETIREMENT ACCOUNT ASSETS OR RESOURCES FOR AN APPLICANT OR RECIPIENT; OR
- (IV) ANY ASSETS OR RESOURCES IN AN INDEPENDENCE ACCOUNT ESTABLISHED FOR A RECIPIENT OF EID PROGRAM SERVICES;";

and in lines 11 and 17, strike "(E)" and "(F)", respectively, and substitute "(G)" and "(H)", respectively.
