TESTIMONY FOR SB1017 Correctional Services - Maryland Correctional Enterprises Formerly Incarcerated Individuals

I am submitting this testimony in favor of SB1017 on behalf of the Maryland Legislative Coalition. The Maryland Legislative Coalition is an association of activists - individuals and grassroots groups in every district in the state. We are unpaid citizen lobbyists, and our Coalition supports well over 30,000 members.

SB1017 aims to address the reintegration of formerly incarcerated individuals into society by requiring Maryland Correctional Enterprises (MCE) to develop a plan for an individual's employment after their release, whether on parole or other supervised programs. The plan is to be a collaboration among MCE, the Maryland Department of Labor, the Division of Parole and Probation, and local workforce development boards. The bill also establishes procedures for helping formerly incarcerated individuals in the competition for state jobs.

Having stable employment increases the chance of a successful transition by reducing recidivism. A job provides stability, purpose, and financial independence by helping to meet basic needs such as housing, food, and healthcare. Having a job facilitates social connections, self-esteem, and purpose, leading to greater opportunities in the future.

Stable employment also reduces the impact on families and children who stand to benefit from a more successful reentry of the former offender. Thus, a more successful reentry could mean avoided costs associated with re-incarceration and the support families would need who were financially dependent on this individual.

The Maryland Legislative Coalition continues to advocate for this and similar bills that increase chances for a successful reentry for former offenders.

We support this bill and recommend a FAVORABLE report in committee.

Mr. Chairman and members of the Committee, thank you for this opportunity to support restorative justice for incarcerated individuals in Maryland. I am Lee Hudson, assistant to the bishop for public policy in the Delaware-Maryland Synod, <u>E</u>vangelical <u>L</u>utheran <u>C</u>hurch in <u>A</u>merica. We are a faith community with three judicatories located in every region of our State.

Our community committed itself to work and advocate publicly for better outcomes for the incarcerated <u>and</u> their communities. We have said, *To dramatically increase chances for success, re-entry support must begin long before release from prison. By identifying needs such as basic life-skill and job-skill training, education and treatment needs at sentencing, and then comprehensively addressing these needs during incarceration, the likelihood of successful transition back into the community is heightened. ("The Church and Criminal Justice," ELCA, 2013) We have also conducted a ministry inside Jessup since 1985 known as the Community of St. Dysmas. One of its goals is successful reentry into community, family, and society after its incarcerated members are released. We share the interest of many others in the State in restorative efforts to reduce recidivism and reclaim human life for productive social engagement.*

The State established an education and training program in 2021, the *Inmate Training and Job Pilot Program* to provide educational and vocational training opportunities for inmates in the 12 months preceding their release. Our understanding is that it was successful.

Furthering that success appears to be in the State's interest in "corrections" and social wholeness in the result labeled "reentry." **Senate Bill 1017** calls for Maryland Corrections Enterprises to build on some of this policy experience by developing an employment plan for program participants upon their release from incarceration. Our experience informs us that this is the right idea restorative justice.

Therefore, we urge your favorable report.
