RE: Support of HB1063 - Criminal Organizations - Criminal Prohibitions, Civil Actions, and Forfeiture

Dear Chairman Clippinger and Committee members,

I am writing to express my strong support for HB1063, which aims to address critical issues related to criminal organizations within our state. As Baltimore City's States Attorney I'm deeply invested in the safety and well-being of our community, I believe that the provisions outlined in this bill are essential steps towards combating organized crime and ensuring justice for victims.

House Bill 1063 introduces significant measures to establish the statute of limitations for civil actions resulting from participation in criminal organizations. By implementing a five-year timeframe following the termination of criminal conduct, this bill provides a crucial window for individuals to seek damages. This limitation period is necessary to facilitate timely legal action while ensuring that victims have the opportunity to pursue justice.

Furthermore, the bill expands the definitions of "criminal organization" and "underlying crime," providing a comprehensive framework for identifying and prosecuting organized criminal activities. By encompassing both formal entities and informal associations engaged in patterns of organized crime, the legislation broadens the scope of law enforcement efforts to combat illicit activities effectively.

Additionally, HB1063 authorizes civil actions for injunctive relief and damages, empowering individuals and the state to take legal action against criminal organizations. These provisions not only provide avenues for victims to seek compensation but also enable authorities to disrupt and dismantle criminal enterprises through civil forfeiture procedures.

Moreover, the bill incorporates measures to divest criminal organizations of their assets and revoke licenses or charters associated with unlawful activities. By imposing

significant penalties and sanctions, including the dissolution of enterprises and the forfeiture of property, this proposed law will serve as a deterrent against engaging in organized crime while promoting public safety and accountability.
