This bill requires the State Department of Education to develop curriculum content standards for a high school peace and conflict studies course and mandates that each county board of education implements this course in each public high school.

Our students need to learn about conflict resolution and peaceful communication. By providing students with the necessary skills to navigate conflicts and engage in productive conversations, we are investing in their future and equipping them with the tools to succeed in a diverse and interconnected world.

The curriculum content standards outlined in this bill cover various topics, including cybersecurity, environmental justice, history, international studies, law and criminal justice, peace engineering, philosophy, social work, technology, and more. These standards will enable students to gain a deep understanding of the causes and effects of conflicts. They will equip them with the skills to constructively and peacefully resolve disputes.

Furthermore, this bill requires each public high school to hire a mediator to educate and support students and school personnel regarding conflict resolution and peaceful communications. This is an essential component of the bill as it ensures students can access the necessary resources and support to resolve conflicts peacefully.

The Peace and Conflict Studies program in high school can bring numerous benefits to students, their schools, and the broader community. Some of these benefits include:
