Bill: House Bill 1257 - Public Schools - Restorative Practices Schools - Establishment

**Position: Support** 

Dear Chair Atterbeary, Vice Chair Wilkins, and Members of the Committee:

The Maryland Psychological Association (MPA), which represents over 1,000 doctoral-level psychologists throughout the state, is writing in SUPPORT of House Bill 1257 - Public Schools - Restorative Practices Schools - Establishment, which will increase the capability of local school systems to implement restorative practices and thereby better support student accountability for behavior through community social connections and improved relationships between individuals.

Increasing local school system resources by the addition of a restorative practices coach to work in conjunction with the behavioral health services coordinator and school staff will support positive classroom environments and decreases in achievement gaps for students with disciplinary issues, absenteeism, and related challenges. The restorative practices approach deals holistically with student behavior by handling behavioral incidents as they arise along with increasing social and emotional skills in students and staff. Thus, conflict and disruptions are reduced and marginalized students are more likely to succeed. We urge that HB 1257 receive a favorable report.
