HB 1181: Education – Curriculum Standards – Antihate and Holocaust Education (Educate to Stop the Hate Act): Please OPPOSE this bill as written!!

I encourage all of you to OPPOSE this bill as it is currently written. OR introduce amendments that would make this legislation more fair to ALL groups.
