Subject: Request for FAVORABLE Report – SB0089 – Department of the Environment – Notation of Veteran Status and Eligibility for Benefits

Dear Chair Feldman and distinguished members of the Education, Energy, and the Environment Committee:

On behalf of the members of the Maryland Military Coalition (MMC), I write to recommend a **FAVORABLE report** by the Committee on *SB0089 – Department of the Environment – Notation of Veteran Status and Eligibility for Benefits*, sponsored by Senator Bryan Simonaire. This bill encourages the Department to establish a process to include a notation of veteran status on a license or certificate to assist in determining the eligibility of a veteran for State and federal veteran benefits. If the veteran agrees to have that notation applied, that individual also agrees to be contacted by appropriate Executive Branch agencies regarding their eligibility for State or federal veteran benefits.

The MMC supports the intent and processes of this bill. It **recognizes veteran status and reduces the burden on individuals to prove their eligibility for State or federal veteran benefits**, saving them personal time and effort to do so. We applaud this step in making it easier for those who have served other than dishonorably.

The Maryland Military Coalition strongly supports SB0089 and asks for a FAVORABLE report from the Education, Energy, and the Environment Committee.

The Maryland Military Coalition is a registered non-profit, non-partisan advocacy organization comprised of 22 prominent Maryland-based veteran and military groups. #### SB89 Health Occupations Boards – Notation of Veteran Status and Eligibility for Benefits Senate Education, Energy and the Environment Committee Favorable January 28, 2025

Good afternoon, Chairman Feldman, Vice Chair Kagan and members of the Senate Education, Energy and the Environment Committee. My name is Jim Campbell, President Emeritus for AARP Maryland, former Maryland State Delegate, and chair of AARP Maryland's Veterans' committee. AARP has four area of focus serving members of the military: caregiving, fighting fraud, helping with career and employment opportunities though the Veterans and Military Spouse Job Center, and access to benefits. AARP Maryland and its 850,000 members support SB67 and thank Senators Simonaire and Jackson for sponsoring this legislation.

#### What SB 89 Does

- SB89 authorizes the Department of the Environment where one or more boards under its control is required to create a process that provides a notation indicating veteran status on a license, or certificate, or registration upon application and consent of a veteran.
- Notation and consent of the notation provide a mechanism for appropriate Executive Branch Agencies to contact a Veteran with information regarding eligibility for State and Federal Veterans' benefits.
- Included in this process is the consent for information of Veterans status to be communicated with appropriate Executive Branch Agencies for the purpose of sharing information and outreach regarding Veterans' benefits.

#### Why This Matters

Veterans serve our country and people by putting their lives and livelihoods in jeopardy to protect and preserve our democracy and quality of life. As they transition to civilian life, many will be unable to work due to injuries sustained in the line of duty. In 2023, Maryland had approximately 348,459 veterans living in the state. Of those, 83,978 or 23.8% had a service-connected disability.

#### **Broader Context – Service-Connected Disability Status**

The Maryland Department of Veterans and Military Families 2022 Report states:

- According to the US Census, compared to civilian counterparts, veterans today are more likely to suffer from trauma-related injuries, substance abuse, and mental health disorders.
- Compared to veterans of other service eras, Post 9/11 veterans have a significantly higher chance (43%) of having a service-connected disability and to have a rating of 70% or higher (39%).

• According to the VA, in December 2022 Post 9/11 veteran claims made up 24% of the total inventory, Gulf War made up 36%, and combined Vietnam, peacetime, and other eras made up 44%.

#### Goals of the Maryland Department of Veterans and Military Families include;

- Increase outreach to women and other marginalized veteran populations to ensure they are aware of VA benefits, healthcare, and mental health services.
- Increase outreach to caregivers, spouses, and adult children of veterans to ensure they are aware of the VA Caregiver Support Program, Charlotte Hall Veterans Home, VA benefits, and other wellness resources.
- Diversify outreach to communities serving veterans to educate on VA benefits and healthcare and increase capacity to serve more veterans filing VA claims in response to the PACT Act.
- Strategically provide outreach to state agencies and local municipalities, especially in rural areas, encourage government and community organizations to screen for military service and to refer to MDVA and VA for benefits information.

In recognizing the sacrifices of veterans made for our country, AARP believes we must ensure that our veterans have the most efficient access to the benefits they are entitled to receive. #### SB 89 - Environmental Licensure Veteran Designation

I am Senator Bryan Simonaire presenting SB 89.

I worked with the Department of Environment and the military community on this consensus legislation. It basically allows a veteran to put a 'Veteran notation' on their professional environmental license.

First, let me say this is enabling legislation for the department, and setups the framework if the Department implements it.

I have worked with the Department and flexibility is key to success and this bill provides that flexibility.

This bill does two main things:

- 1) Enables the Department to issue state identification cards with the "Veteran" notation placed on it, and
- 2) If enabled, it establishes an outreach to the veteran if they want the Veteran notation and the applicant consents to being contacted by appropriate Executive Branch agencies regarding the applicant's eligibility for State or federal veterans' benefits.

This may sound familiar as this is what is done for the MVA driver licenses. Driver license applicants can have a veteran's notation placed on their driver license and be contacted by the Department of Veterans and Military Families regarding available veteran benefits.

The only difference is that this legislation is enabling.

The advantage to this approach is the Department knows when and how quickly to roll it out. They could even do a pilot on a subset of their ID cards. This bill gives the Department tremendous flexibility to achieve success.

In fact, the Boards are in the process of transition to a new licensing system by mid-2026, so this is ideal to start planning and to be able to implement on their schedule.

While the MVA program has been hugely popular, Maryland has a long way to go to reach our veterans as less than 50% of our veteran population is taking advantage the MVA program.

That's why it is imperative we use as many methods as possible to reach out to our veterans. This legislation provides one more tool to reach out to veterans while also providing additional benefits to the veteran community.

Additionally, in Maryland, we are looking to do everything we can to help reduce veteran suicide. One of the key factors is avoiding isolation.

This legislation provides multiple benefits, including reducing isolation:

- 1. This will help with networking and reducing isolation as more people including other veterans will see these licensees are veterans and hopefully reach out more to them.
  - a. One of the many factors of veterans' suicide is isolation especially as it pertains to a veterans' own service and experiences. This will allow for public awareness of veterans through thanking them for their service, other veterans seeing it and talking with them and re-enforcing they are not alone.
- 2. It provides another tool to reach out to our veteran population with their consent through using their contact information to share eligible benefits with them,
- 3. It is another avenue for the public to show appreciation for their service, and
- 4. Lastly, it also provides potential financial benefits to our veteran as many customers are more likely to hire a veteran, repeat as a customer or just give a bigger tip for their service, where applicable.

If you think about it, you can't beat this is a low-cost investment with all its potential benefits.

For all these reasons, I ask for your favorable consideration.

The Maryland Department of the Environment (MDE) SUPPORTS SB 89.

Senate Bill 89 authorizes MDE's occupational boards to include a notation of veteran status on professional licenses or certificates issued by MDE, and assist in determining the eligibility of veterans for state and federal benefits. The bill allows applicants for professional licenses or certificates to present documentation of their veteran status and consent to having their status noted on their license or certificate. It also permits sharing relevant information with executive branch agencies to evaluate veterans' benefit eligibility.

The bill would apply to the following MDE boards: (1) Board of Waterworks and Waste Systems Operators; (2) Board of Well Drillers; (3) Board of Marine Contractors; and (4) Board of On-Site Wastewater Professionals. The bill is authorizing only in recognition that there may be varying degrees of cost and implementation challenges depending on the specific board.

MDE supports efforts to acknowledge and assist our veterans. MDE also appreciates working with the bill sponsor to address potential costs and implementation concerns. Accordingly, MDE asks for a **FAVORABLE** report for SB 89.
