The Maryland Agricultural Commission is charged with the duty of advising the Secretary of Agriculture, proposing agricultural improvements, promoting State agricultural industries and products, and reviewing legislation for its impact on the future of Maryland agriculture. Since its inception in 1961, the Commission has continued to grow and evolve its membership to ensure that it is on the cutting edge of agricultural advancements and emerging industries. In 1968, this Advisory Board doubled its membership with the spirit of being more representative of the agricultural sector and became the Maryland Agricultural Commission. The Maryland Agricultural Commission proposed the development of a Department of Agriculture in 1971 within the Executive Branch to adopt the duties of enforcing agriculturally related laws and separate the dual responsibilities of the State Board of Agriculture and University of Maryland Board of Regents. Today, the 31-member Maryland Agricultural Commission serves as the advisory body to the Secretary of Agriculture, comprised of Governor-appointed members in industry-specific seats to bring key voices to the table and advance the industry by providing recommendations and consideration on the initiatives of the Department.

I currently serve as the Vice Chair of this Commission, representing the Farm Direct sector. This testimony is being submitted on my personal behalf, as the Commission does not submit testimony. I am the owner of HopScratch Farm, a diversified family farm that produces beef, lamb, hops and eggs in Harwood MD. I encourage you to vote in favor of the proposed legislation.

In February 2024, the Commission engaged in a survey to identify key priorities that impact Maryland agriculture and connect industries that are not represented on the Commission but are integral in the success of the whole industry. At the March 2024 meeting, the first draft of their strategic plan was introduced and modified at each subsequent meeting until June 2024 when it was unanimously adopted.

The 2024 Strategic Plan for the Maryland Agricultural Commission outlined a framework for the Commission to consider as it works to advance Maryland agriculture. In conjunction with the establishment of working committees we moved to adopt the Young Farmers Advisory Board to now be a standing Committee on Young Farmers with leadership from a newly established Young Farmer seat. The Young Farmers Advisory Board was formed in 2004 and charged with advising the Maryland Agricultural Commission on issues pertinent to young farmers and the next generation of agriculture. Adoption of the Young Farmers Advisory Board into the Maryland Agricultural Commission, as proposed in this legislation, ensures that the future of Maryland agriculture is always considered.

Intentional nomenclature changes to the membership seats as outlined in the strategic plan expand the Agritourism industry to include Value Added Agriculture, amend the Horse Breeding industry to represent the entire Equine industry, clarify the horticulture industry to focus on fruit production which will be a sister seat to the vegetable producer, and engage with the nursery, landscape and greenhouse industry in addition to the original Nursery seat. Duplicative Poultry, Dairy, Nursery, and Related

Agricultural Service seats were removed to ensure all industries carried an equal voice, and the longstanding tobacco grower position was removed, marking a historic shift from the crop that was once prolific throughout the State. Lastly, several new seats were added to represent growing industries like Controlled Environmental Agriculture and the Urban & Small Farm Sector, and ensure that Historically Underserved Farmers, Veteran Farmers, and New & Beginning Farmers have a seat at the table.

Advisory bodies have played an integral role in spurring the success of the agricultural industry for over 60 years and the evolution of those bodies from a grassroots initiative ensures that its unified voice is fully representative of Maryland's number one commercial industry. Thank you for your consideration of the proposed legislation that makes the statutory changes formulated through several months of examination from the Maryland Agricultural Commission.

Delmarva Chicken Association (DCA) the 1,600-member trade association representing the meat-chicken growers, companies, and allied business members on the Eastern Shore of Maryland, the Eastern Shore of Virginia, and Delaware supports SB 240 and urges a favorable committee report.

SB 240 would alter the membership of the Maryland Agricultural Commission by eliminating redundant industry representation and adding seats for a new and beginning farmer, a veteran farmer, an urban/small farmer, and a socially disadvantaged farmer, among others. The bill would also establish a Committee on Young Farmers.

The Maryland Agricultural Commission provides invaluable collaboration between different sectors of agriculture and the Maryland Department of Agriculture. By eliminating the duplicative seats on the commission, we hope that the Commission will foster closer collaboration, while also including voices that have unfortunately been absent in the development of agricultural policy.

The additional seats are also apt to directly benefit our chicken community. About 23% of chicken farmers are from minority groups, compared with 4.5% of farmers nationally. In addition, chicken farming is one of the most accessible enterprises for new and beginning farmers, owing to the relatively minimal land and equipment requirements. Therefore, we believe the additional representation of underserved and new and beginning farmers will also represent the interests of many of our members.

The new composition of the Commission will be more reflective of the citizenry of Maryland and the future of our industry, fostering more productive and meaningful collaboration across sectors. As such, we urge a favorable vote on SB 240.

The Maryland Agricultural Commission is charged with the duty of advising the Secretary of Agriculture, proposing agricultural improvements, promoting State agricultural industries and products, and reviewing legislation for its impact on the future of Maryland agriculture. Since its inception in 1961, the Commission has continued to grow and evolve its membership to ensure that it is on the cutting edge of agricultural advancements and emerging industries. A 1990 survey of Commission members encouraged the inclusion of the rapidly growing nursery industry. Within a decade, this industry was the #2 agricultural commodity in the state, and by 2018 generated over \$1.376 billion in agricultural product sales per a Maryland Nursery, Landscape and Greenhouse Association survey. Today, the Nursery representative serves as Chair of the Commission, highlighting the valuable foresight and awareness of the Maryland Agricultural Commission as it makes recommendations to restructure membership in this proposed legislation to embody the future of the industry.

In 1916 a 9-member State Board of Agriculture was established and charged with enforcing the agriculturally related laws of Maryland, as well as serving as the Board of Regents for the Maryland State College of Agriculture, later named the University of Maryland. In 1961, the legislature formed the Agricultural Advisory Board of Maryland to identify challenges within the agricultural industry and bring them to the attention of the State Board of Agriculture. 7 years later, this Advisory Board doubled its membership with the spirit of being more representative of the agricultural sector and became the Maryland Agricultural Commission. FAVORABLE

The Maryland Horse Council (MHC) is a membership-based trade association that represents the \$2.9. billion, state-wide, horse industry in Maryland. Our members include horse farms; horse related businesses; equestrian competitors; trainers; individual enthusiasts; equine-assisted therapy programs; and breed, interest, and discipline associations. We represent over 30,000 Marylanders who make their living with horses, or who just own and love them.

The horse industry is the largest component of Maryland's agricultural industry, which is itself the largest commercial industry in the state. The horse industry comprises at least \$2.9 billion of the \$8.25 billion in agricultural economic impact on the state, compared to only \$1.23 billion in economic impact from the next largest segment, the poultry industry.¹

We are, therefore, pleased to see the Department of Agriculture taking the initiative to change the composition of the Maryland Agriculture Commission to reflect more accurately the farmers it represents.

The current seat on the Maryland Agricultural Commission is restricted to "horse breeding." While the horse breeding industry in Maryland is significant – one of the largest Standardbred breeding operations in the country is in Maryland, and Maryland's numerous sport horse breeding farms produce some of the best equine athletes in the world – it is but one portion of the overall industry.

An American Horse Council economic impact report released in 2024 shows the relative size of the non-breeding sectors as follows:

- Recreational riding (including lesson barns, boarding barns, private farms, etc.) has a \$421 million impact on the state;
- The competition sector (excluding racing and breeding) has at least a \$370 million impact on the state;
- The harness racing sector has a \$278 million impact on the state in addition to the \$43.1 million in economic impact in gambling revenue generated by the Ocean Downs Casino;
- The equine-assisted services sector contributes \$36 million; and
- The horse rescue and horse sanctuary sector contribute \$3.16 million.

SB 240, if passed, would bring the perspective of these critically important components of the commercial horse business to bear on the Maryland Agriculture Commission's work, which will, in turn, improve the Department of Agriculture's ability to fulfill its mission "to provide leadership and support" to this, the largest portion of its constituency.

We urge a favorable report.



Our recordkeeping system has been adopted by over 60 young farmers across the region, helping to build more sustainable and profitable agricultural operations.

The success of CBF's engagement efforts with young farmers demonstrate both the significant need for guidance and resources, and the way young farmers can thrive in the industry with appropriate support. With the average farmer now over 58 years old, we recognize the critical importance of equipping and empowering young farmers. Their success is vital for fostering a thriving local agricultural economy and ensuring the long-term health of the Chesapeake Bay. **CBF supports the Maryland Department of Agriculture's continued efforts to better engage young farmers and request the Committee's FAVORABLE report on SB 240**.

- Remove duplicative Poultry, Dairy, Nursery, and Related Agricultural Service seats, and the longstanding Tobacco Grower seat,
- Addition of seats for Controlled Environmental Agriculture, Urban & Small Farm Sector, Historically Underserved Farmers, Young Farmer, Veteran Farmers, and New & Beginning Farmers

Testimony, Favorable with Amendments, Senate Bill 240 - Department of Agriculture - Maryland Agriculture Commission and Young Farmers

January 24, 2025

Thank you for the opportunity to submit testimony in **SUPPORT WITH AMENDMENTS** of **SB240** on behalf of ShoreRivers, a river protection organization serving Maryland's Eastern Shore with more than 2,000 members. Our mission is to protect the waterways of Maryland's Eastern Shore through science-based advocacy, restoration, education, and engagement.

SB240 proposes establishing a Youth Farmer Committee tasked with:

- 1. Raising public and governmental awareness of the importance of young and beginning farmers to Maryland agriculture.
- 2. Identifying and addressing issues impacting young and beginning farmers and making recommendations to the Maryland Agricultural Commission.
- 3. Convening quarterly to fulfill its mandate.

Under this legislation, committee members are nominated annually by the Secretary of Agriculture and must meet criteria, including being Maryland residents under 45, deriving at least 50% of their income from agricultural activities, and reflecting regional diversity and industry variety to the extent practical.

ShoreRivers supports this bill because it prioritizes the voices and leadership of the next generation of agricultural decision-makers. These individuals play a crucial role in safeguarding Maryland's agricultural economy while also fostering sustainable land stewardship practices. On the Eastern Shore, where agriculture contributes over \$1 billion annually to the state's economy and supports 3,717 jobs, protecting farmland and waterways is essential to sustaining both local communities and ecosystems.

In 2022, ShoreRivers launched the **Next Generation Land Stewards** program to empower and connect rising agricultural leaders on the Eastern Shore. This initiative focuses on helping young landowners establish conservation goals for their properties while fostering peer support. Workshops have covered vital topics such as conservation easements, habitat management, and incentive programs for implementing buffers and wetlands. This experience has shown us that integrating conservation into farm management is not just beneficial but essential for balancing agricultural productivity with environmental health.

Recommended Amendments

To strengthen SB240 and ensure its success, we respectfully request the following amendments:

1. Incorporate Conservation Education:

Include language emphasizing the committee's role in pursuing education on conservation practices and water quality as vital components of farm resource management. This addition will align the committee's mission with Maryland's goals for sustainable agriculture and environmental stewardship.

2. Clarify Expectations and Time Commitments:

Recognize the significant demands placed on young farmers and adjust the responsibilities of committee members accordingly. For instance, requiring committee members to "communicate to the general public" about the challenges facing young farmers may be an overly burdensome expectation for a volunteer group balancing farm management and other responsibilities. A more collaborative approach to outreach could be considered.

By adopting these amendments, SB240 can not only elevate the voices of young farmers but also ensure their ability to contribute meaningfully without overextending themselves. Moreover, including conservation education in the committee's scope will foster a more sustainable future for Maryland's farms, waterways, and communities.
