Dear Chair Feldman and distinguished members of the Education, Energy, and the Environment Committee:

On behalf of the members of the Maryland Military Coalition (MMC), I write to recommend a FAVORABLE report by the Committee on *SB0048 – Department of General Services – Identification Cards – Veteran Status Notation*, sponsored by Senator Bryan Simonaire. This bill encourages the Department to include a notation of veteran status on an identification card issued to a State employee or other individual authorized by the Department's Secretary, indicating that the holder is a veteran if the individual issued that identification card presents certification of veteran status. If the veteran agrees to have that notation applied, that individual also agrees to be contacted by appropriate Executive agencies regarding their eligibility for State or federal veteran benefits.

The MMC supports the intent and processes of this bill. It **recognizes veteran status and reduces the burden on individuals to prove their eligibility for State or federal veteran benefits**, saving them personal time and effort to do so. We applaud this step in making it easier for those who have served other than dishonorably.

The Maryland Military Coalition strongly supports SB0048 and asks for a FAVORABLE report from the Education, Energy, and the Environment Committee.

SB 48 – Department of General Services – Identification Cards – Veteran Status Notation Education, Energy, and the Environment Committee January 30, 2025

AFSCME Council 3 represents 45,000 state, county, and municipal employees and we are pleased to support Senate Bill 48. This legislation allows the Department of General Services (DGS) to include veteran status on DGS-issued identification cards. SB 48 provides an option for veterans applying for a DGS-issued ID cards to be contacted by the Department of Veterans and Military Families. This level of cross-agency coordination can help more veterans access the state and federal benefits they've earned and deserve.

SB 48 is a good a bill. We urge the committee to provide a favorable report.

The following states that have collective bargaining for state employees, AK, CA, CT, DC, DE, HI, IL, ME, MN, NE, NJ, NM, NV, OH, OR, PA, MT, RI, WA have a terminal point for negotiations, either binding interest arbitration, the right to strike, or a legislative process. These processes create a level playing field for both parties.

This legislation would create a mutual incentive to compel parties to reach an agreement around collective bargaining negotiations by instilling a binding interest arbitration process, whereby if the two sides cannot come to agreement through negotiations by a specified deadline the proposals.

From the two sides would be presented to a professional, neutral third- party arbitrator – hearing from witnesses and experts, with data and evidence – for consideration of all the facts involved with the purpose of determining which proposal is most appropriate to implement. The choice by the arbitrator would then be considered a binding resolution to be implemented by the Governor and exclusive bargaining representative for whatever appropriations are necessary to implement and fund the memorandum of understanding. The budgetary powers of the Maryland General Assembly remain unaltered.

SB 188 is a strong and positive step toward enhancing fairness, balance, and efficiency, and resolution. It follows a model that is well-established in other states and among Maryland counties. We urge a favorable report.

SB48 Department of General Services – Identification Cards – Veteran Status Notification FAVORABLE Education, Energy, and the Environment Committee January 30, 2025

Good afternoon, Chair Feldman, Vice Chair Kagan, and members of the Education, Energy, and the Environment Committee. My name is Jim Campbell, President Emeritus for AARP Maryland, and a former Maryland State Delegate. AARP Maryland represents more than 850,000 members statewide and is the largest nonprofit, nonpartisan organization advocating for Marylanders aged 50 and older, as well as their families. representing 850,000 members. AARP Maryland supports SB48 and thanks Senator Simonaire for sponsoring this legislation.

SB48 authorizes the Department of General Services to include a notation on a security card issued to members of the Executive Branch of State Government indicating that the holder is a veteran. This is part of a package of bills designed to recognize military service by state employees and to help insure they have access to earned benefits.

Why is this important?

Veterans serve our country and people, putting their lives and livelihoods in jeopardy to protect and preserve our democracy and quality of life. As they transition to civilian life, many will be unable to work due to injuries sustained in the line of duty. In 2023, Maryland had approximately 348,459 veterans living in the state. Of those, 83,978 or 23.8% had a service-connected disability.

Broader Context – Service-Connected Disability Status

The Maryland Department of Veterans and Military Families 2022 Report states:

- According to the US Census, compared to civilian counterparts, veterans today are more likely to suffer from trauma-related injuries, substance abuse, and mental health disorders.
- Compared to veterans of other service eras, Post 9/11 veterans have a significantly higher chance (43%) of having a service-connected disability and to have a rating of 70% or higher (39%).
- Among all veterans, men are no more likely to have a disability than women, but women are more likely to have a rating of 70% or higher.
- According to the VA, in December 2022 Post 9/11 veteran claims made up 24% of the total inventory, Gulf War made up 36%, and combined Vietnam, peacetime, and other eras made up 44%.

In recognizing the sacrifices made by Veterans and their families for our country, AARP believes we must ensure that they receive the most efficient access to benefits of which they are entitled. SB48 will help achieve that goal and we urge a favorable report by the committee. SB 48 - State Card ID - Veteran Designation

I am Senator Bryan Simonaire presenting SB 48.

I worked with the Department of General Services and the military community on this consensus legislation. It basically allows a veteran to put a 'Veteran notation' on their State Identification Card.

First, let me say this is enabling legislation for the department, and setups the framework if the Department implements it.

I have worked with the Department and flexibility is key to success and this bill provides that flexibility.

This bill does two main things:

- 1) Enables the Department to issue state identification cards with the "Veteran" notation placed on it, and
- 2) If enabled, it establishes an outreach to the veteran if they want the Veteran notation and the applicant consents to being contacted by appropriate Executive Branch agencies regarding the applicant's eligibility for State or federal veterans' benefits.

This may sound familiar as this is what is done for the MVA driver licenses. Driver license applicants can have a veteran's notation placed on their driver license and be contacted by the Department of Veterans and Military Families regarding available veteran benefits.

The only difference is that this legislation is enabling.

The advantage to this approach is the Department knows when and how quickly to roll it out. They could even do a pilot on a subset of their ID cards. This bill gives the Department tremendous flexibility to achieve success.

While the MVA program has been hugely popular, Maryland has a long way to go to reach our veterans as less than 50% of our veteran population is taking advantage the MVA program.

That's why it is imperative we use as many methods as possible to reach out to our veterans. This legislation provides one more tool to reach out to veterans while also providing additional benefits to the veteran community.

Additionally, in Maryland, we are looking to do everything we can to help reduce veteran suicide. One of the key factors is avoiding isolation.

This legislation provides multiple benefits, including reducing isolation:

- 1. This will help with networking and reducing isolation as more people including other veterans will see these licensees are veterans and hopefully reach out more to them.
 - a. One of the many factors of veterans' suicide is isolation especially as it pertains to a veterans' own service and experiences. This will allow for public awareness of veterans through thanking them for their service, other veterans seeing it and talking with them and re-enforcing they are not alone.
- 2. It provides another tool to reach out to our veteran population with their consent through using their contact information to share eligible benefits with them,
- 3. It is another avenue for the public to show appreciation for their service, and
- 4. Lastly, it also provides potential financial benefits to our veteran as many customers are more likely to hire a veteran, repeat as a customer or just give a bigger tip for their service, where applicable.

If you think about it, you can't beat this is a low-cost investment with all its potential benefits.

For all these reasons, I ask for your favorable consideration.
