My name is Candy Warden. I am President of the Rosa Bonheur Society, Inc. (RBS), a volunteer, nonprofit group formed in 2007 to protect and preserve the Rosa Bonheur Memorial Park, a Maryland human and pet cemetery with thousands of burials. The people with loved ones resting at our cemetery span across all the counties of Maryland.

In having over 17 years of experience of cemetery work with both RBS and the Coalition to Protect Maryland Burial Sites I am very aware of the impact of the lack of a unified cemetery inventory on our State, counties, and communities abilities to effectively address a multitude of issues. At least 26 other states have recognized this intrinsic need and implemented unified statewide cemetery inventories. It is time for the State of Maryland to develop a much needed resource that will provide benefits for not only governmental purposes, but all constituents.

### The Problem

Maryland has thousands of cemeteries, but there is no unified, comprehensive inventory validating their existence. More importantly there is currently no workgroup dedicated to establishing such an inventory.

### Benefits of SB 0354

- Establishment of a workgroup to research requirements needed for formulating a unified, comprehensive cemetery inventory and the funding thereof.
- A unified cemetery registry readily available for statewide access by governmental departments, agencies, concerned groups, and individuals that would be a cost effective resource in eliminating duplication of effort and unnecessary research.
- The merging of existing cemetery inventories held by various departments, agencies, etc.
- Secure, consistent, improved documentation of cemeteries.
- Protection for cemeteries through validation and documentation.
- A resource for legislative, legal, historical, and genealogical research.
- A resource for disaster management and land development.

SB 0354 will provide all of these benefits for constituents across the State of Maryland.

I work with a large diverse group of cemetery advocates and am on boards of both the Anne Arundel Genealogical Society and the Coalition to Protect Maryland Burial Sites. I work closely with Anne Arundel County's Cultural Resources to assure that they have cemetery locations to protect them from future development. I helped re-inventory many of those cemeteries several years ago.

There is no standardization or sharing of information. Large central Maryland counties have databases but there is no central depository. The Office of Cemetery Oversight, Maryland Historical Trust, and the State Highway Administration each have their own databases. Many Maryland counties have limited information, sometimes only from well-known or easily accessible cemeteries but not from neglected cemeteries, churches, African American cemeteries, or cemeteries on federal lands.

Several years ago, the Baltimore County Genealogical Society created a database documenting their cemeteries. That concept could be used throughout Maryland. Some basic information is already available on the Coalition to Protect Maryland's Burial Sites' website. I helped develop much of this information from public sources. Documenting these sites would allow others (developers, historical researchers, genealogists, title researchers, and disaster planners) access to the records. Each county government could modify the database for their specific needs. This would prevent development where there is no record of a cemetery's existence. One issue which would need to be addressed would be how to document cemeteries on private property whose owners are resistant to information being available to the public. The workgroup would focus on such issues.

I live in a county with some of the earliest cemeteries in the country including the oldest known tombstones in Maryland. Sometimes cemeteries allow us to research the only record of founders of our communities. We need to preserve this heritage and make it easier for cemeteries to be protected. Community engagement, tourism promotion, and historical significance could all benefit from this legislature.

## Inventory - SB0354: Maryland Inventory of Cemeteries and Burial Sites Workgroup

I'm David Zinner, Coordinator for the Maryland Cemetery Legislative Advocates (MCLA). Our group has extensive experience with cemetery issues. I've been a member of the Maryland Advisory Council for Cemetery Oversight (ACCO) for 12 years though my testimony today is not as a representative of the Council.

SB0354 establishes the Maryland Inventory of Cemeteries and Burial Sites Workgroup. Currently there are three Maryland State agencies that record cemetery information - the Office of Cemetery Oversight, the Maryland Historical Trust and the State Highway Administration. We believe that none of these sites capture all Maryland cemeteries, nor do they always include critical information such as GPS location or cemetery condition.

SB0354 addresses the significant need to catalog and maintain an up-to-date inventory of cemeteries and burial sites across the state. Such an inventory is crucial for preserving our cultural heritage, ensuring respectful handling of burial sites, and supporting historical and genealogical research.

This bill will create a dedicated workgroup composed of representatives from various state and local entities, historical organizations, and community members with expertise and perspectives necessary to create a comprehensive and accurate inventory. The workgroup will identify and review existing definitions, documentation practices, and inventory systems from other states. This will help establish best practices and overcome challenges in designing and maintaining Maryland's cemetery inventory system. The workgroup will also recommend data collection and maintenance categories, including a public search function to ensure that the inventory will be easily accessible to researchers, historians, and the general public, fostering transparency and engagement.

SB0354 mandates the workgroup to determine the costs involved in designing, implementing, and maintaining a statewide inventory system and to identify potential funding sources to support these efforts, ensuring financial sustainability.

Cemeteries and burial sites are invaluable historical resources that provide insights into our communities' cultural and social history. Creating an inventory ensures that these sites are documented, protected, and maintained for future generations.

SB0354 represents a significant step towards preserving Maryland's cultural and historical heritage. We strongly support SB0354 and urge its passage.

### Create workgroup to study creation of MD database of all cemeteries

CPMBS is an all-volunteer nonprofit that since 1992 has advocated for improvement in distressful cemetery situations that occur across Maryland and for needed changes in state law. In 2021-2, I served on the committee that was charged by House & Senate Joint Chairmen to survey citizens and study historic African American Cemeteries and recommend strategies to improve their current situations. One of the major recommendations to come out of the 2022 report is to "support development of a publicly accessible, map-based data layer dedicated to historic cemeteries throughout Maryland..."

Some local inventories are available now, with varying types of information on each site and usually not up to date: Nabb Center in Salisbury (records on cemeteries in Wicomico, Somerset, and Worcester Counties), Anne Arundel and Baltimore County Geneaological Societies (collect data via death records, tombstone inscriptions, and public programs), Caroline, Allegany, Queen Anne, Talbot, and Garrett Counties (MD Tombstone Project), Find-a-Grave (posts photos and basic information). Our Southern MD counties include cemeteries as part of their Historic Preservation programs. A Frederick County energetic volunteer chronicled known sites. In Central Maryland, Howard, Prince George's, and Montgomery have dedicated planning staff who cover cemetery sites and issues.

My experience in having twice organized and directed volunteer projects to survey all known cemeteries in Montgomery Co confirms their value. The first produced one page with basic known information; the second is now the official Burial Sites Inventory kept by Montgomery County Planning Board on a modern database.

State agencies touch on this subject matter. Maryland Historical Trust's state-wide inventory sometimes notes cemeteries at historic sites. SHA once started a list of cemeteries along our roads. OCO is charged with keeping a list. However, each of these lists keeps unique data. It's time to share for the betterment of all concerned.

A Unified inventory of Maryland cemeteries is crucial to identifying all sites everywhere, documenting them with common data, and making the information accessible. With the passage of SB354, all parties can work together for a database that will be useful for all.

Good afternoon Chair, Vice Chair, and members of the Education, Energy, and the Environment Committee. Thank you for the opportunity to present Senate Bill 354. SB354 will establish a 15-person workgroup to study the creation of the Maryland Inventory of Cemeteries and Burial Sites. Maryland does not currently have a comprehensive inventory of cemeteries. We rely on several state agencies, such as the Office of Cemetery Oversight, the Maryland Historical Trust, and the State Highway Administration to maintain separate databases.

The eventual goal of SB354 is to create a more efficient system, that will make it easier for families, local governments, historians, and others to have access to cemeteries and cemetery records. A comprehensive inventory in a single place will provide consistency and make these records more accessible to all Marylanders who seek them. A unified database will also allow us to better document and preserve cemeteries for generations to come.

This newly established workgroup will be made up of key industry stakeholders, including, but not limited to, the Maryland Historical Trust, Office of Cemetery Oversight, local governments, genealogical groups, and descendant communities. This broad, inclusive participation will ensure that we can come to the most efficient and responsible solution to this issue. The workgroup will evaluate current cemetery documentation practices and existing cemetery inventories to determine the best methods for integrating existing information into a state cemetery inventory system. They will also identify and evaluate cemetery inventory systems implemented in other states to determine best practices for and challenges to designing, implementing, and maintaining a cemetery inventory system in Maryland.

Lastly, the workgroup will determine the cost of designing, implementing, and maintaining a state cemetery inventory system and recommend a source of funding beginning in fiscal year 2027.

Thank you for your consideration. I urge a favorable report on Senate Bill 354.

BILL: SB 354 Maryland Inventory of Cemeteries and Burial Sites Workgroup -

Establishment

Senate Bill 354 establishes a workgroup between the Office of Cemetery Oversight ("OCO") and the Maryland Historical Trust for the purpose of studying issues related to the creation and maintenance of a State cemetery inventory system. This workgroup will also explore various laws and regulations pertaining to cemeteries and burial sites and evaluate the feasibility and cost of establishing a grant program to provide financial assistance to governmental entities and nonprofit genealogical and historical organizations.

The OCO is a small self-funded unit. When fully staffed, the OCO consists of a total of three full-time employees and one part-time employee. Due to OCO's limited staffing, the OCO will have to increase staff to handle the new duties created by Senate Bill 354. Furthermore, since the OCO is a self-funded unit, it will be challenging for the OCO to absorb the additional staffing and legal expenses that will be necessary to fulfill the goals of this workgroup.
