The Office of the Attorney General (OAG) urges the Committee to give Senate Bill 733 a favorable report. The proposed constitutional amendment aims to implement gender-neutral language concerning constitutional officers in the Maryland Constitution. This amendment represents an important step towards inclusivity and equality within our state's governing documents.

The language we use matters; it shapes our perception of roles and individuals within our society. By adopting gender-neutral terminology, we acknowledge and respect the diverse identities of all Marylanders. This is not the first time that Maryland has adopted gender neutral language. The Maryland Gender Neutral Reference in the Maryland Constitution Amendment, also known as Question 1, was on the November 2, 1982 ballot in Maryland as a legislatively referred constitutional amendment, where it was approved by nearly ³/₄ of voters. The measure replaced gender specific reference in the Maryland Constitution with a gender neutral reference pertaining to imprisonment for debt.¹

Furthermore, this initiative aligns with similar efforts undertaken in various states, emphasizing the importance of language in legislative processes. Currently nine state

The Maryland Commission for Women strongly supports Senate Bill 733, which seeks to modernize the language of the Maryland Constitution by ensuring that references to our constitutional officers are gender-neutral. This simple yet significant change reflects the modern role of women and individuals of all gender identities in public service. By replacing outdated, masculine terminology with neutral language, Maryland takes an important step toward recognizing the contributions and leadership potential of all individuals, regardless of gender. This update is long overdue, not just to recognize the trailblazing women who have served in these roles, but also to inspire all the young people who may one day follow in their historic footsteps.

The Maryland Commission for Women recently published "2025 Status of Women in Maryland: A Report on Maryland Women in Elected Office." According to this report:

- Maryland currently has its first female Comptroller
- Maryland currently has its second female and first woman of color Lieutenant Governor.
- Maryland is one of only 20 states that has never had a woman as Attorney General.
- Maryland is one of only 18 states that has never had a woman as Governor.

Maryland's Secretary of State Susan Lee, while a trailblazer, is not the first woman in this role. That glass ceiling was shattered in 1949 by Vivian V. Simpson. According to her biography in the *Maryland Women's Hall of Fame* (a project of the Maryland Commission for Women hosted by the state archives), while a student at University of Maryland, College Park:

Simpson found the rules on campus unfair to women - rules that prohibited smoking for female students, but not for males, requirements that women in dormitories turn off their lights at 9:30 p.m., while no such restrictions were placed on the men on campus.

She deliberately violated the lights-out rule and vigorously defended women suspended for violating the no-smoking rule.

However, her involvement with a group of female students who provided secret affidavits to a Washington Post reporter alleging sexual exploitation of the co-eds by the faculty (including seductions and "spanking parties") led to the University's refusal to readmit her the following semester. The resulting scandal brought the resignation of the University President, according to A History of the University of Maryland by Professor George Callcott, and the denial of an education to Ms. Simpson.

She sued the University of Maryland for readmission and won the case, but it was overturned on appeal, with the justices noting that this "was a young woman not readily submissive to rules and regulations." However, her experience introduced her to the field of law and no doubt led to her decision to become an attorney at a time when it was almost unheard of for women to pursue such a profession.

While times have certainly changed since Secretary Simpson and so many other trailblazing women have shattered glass ceilings, our state's Constitution has not kept up. It is a fitting tribute to their leadership in the face of significant obstacles to make the effort to update our Constitution. It would be a reflection of our gratitude, and a gesture of commitment to continue their legacy of expanding opportunity for all.

The Commission thanks Senator King for introducing this legislation and respectfully urges the committee to issue a favorable report on Senate Bill 733 and move Maryland forward in its commitment to inclusivity and fairness for all individuals serving in public office. Position: Favorable

Common Cause Maryland is in favor of SB 773, which would move to alter terminology in the Maryland Constitution so that constitutional officers would be regarded to in gender-neutral language.

This bill proposes an important yet straightforward change: updating terminology in the Maryland Constitution to reflect gender-neutral language when referring to constitutional officers.

Language matters. The words we use in our foundational documents shape public perception and reinforce inclusivity. Maryland's Constitution, as it stands, contains gendered references to public officials, which, while historically commonplace, do not reflect the diversity of leadership we see today. By adopting gender-neutral language, this bill ensures that all individuals, regardless of gender identity, feel represented and acknowledged within our state's governing framework.

This is not merely a symbolic gesture; it is a necessary step toward making Maryland's laws more inclusive and reflective of modern society. Government documents should serve all people equitably, and maintaining gender-specific language in reference to constitutional officers implicitly reinforces outdated assumptions about leadership roles. By modernizing the language of the Constitution, Maryland joins other states that have taken similar steps to promote gender inclusivity in their legal texts. Some of these states include California, New York, Vermont, Utah and others as well as several other states who are in the process of pushing for the same changes.

Additionally, this change aligns with our state's broader commitments to equality, diversity, and representation. It affirms that positions such as Governor, Attorney General, Comptroller, and Treasurer are open to all qualified individuals, regardless of gender. This bill is particularly important for young people who aspire to public service; they should see a Constitution that reflects the reality that leadership is not confined to a single gender.

Moreover, this amendment comes with minimal practical disruption. It does not alter the function or responsibilities of constitutional officers but rather updates the language to ensure clarity and inclusiveness. Given that this bill is contingent on a referendum, it also provides Maryland voters with the opportunity to weigh in on this important matter.

In the state of Maryland, when an officer is not directly referenced with their title or position, they are referenced as "he, him, himself, or his." Currently, of the seven constitutional officers in Maryland – the Governor, Lieutenant Governor, Secretary of State, Attorney General, Comptroller, Treasurer, and Adjutant General – four of these roles are currently held by women.

It is time to update this outdated language in our Constitution – language that was written before women even had suffrage. Many other states have already adopted the use of gender-neutral pronouns when addressing an individual or office holder in their constitutions, such as California, Delaware, Hawaii, Maine, New York, North Carolina, Rhode Island, Utah, and Vermont. Maryland must be the next.

The Office of the Secretary of State, and the Secretary of State Susan Lee, are in strong support of SB733, which seeks to alter terminology in the Maryland Constitution to use gender-neutral language when referring to executive branch constitutional officers. This proposed Constitutional Amendment is past-due, but timely to bring up now in a sense because most of our constitutional officers are now women.

The current Lieutenant Governor Miller, Maryland Speaker of the House Jones, the Comptroller Lierman, the Adjutant General Birckhead, and I are all female Constitutional Officers. Five of the current nine Constitutional Officers are women, yet the Constitution refers to us all as "he", "him", "his", and, "himself". This bill only applies to the seven executive branch constitutional officers including the Governor, the Lieutenant Governor, the Secretary of State, the Attorney General, the Adjutant General, the Comptroller, and the Treasurer. But again, women make up the majority here as well, with women holding four out of seven of those positions.

The current gender-specific language in the Maryland Constitution can inadvertently maintain outdated notions of leadership and governance being inherently male. Adopting gender-neutral language will send a powerful message that leadership is inclusive and accessible to all, regardless of gender.

At least ten states have already adopted gender-neutral language in their constitution to recognize the importance of inclusivity in representation. It is time for Maryland to follow suit and acknowledge that its Constitution should reflect and encourage all who want to participate in public service. These amendments will foster a more inclusive representation of our political body as well as provide a more accurate depiction of our current and future leaders.

In conclusion, I urge a favorable report for SB733. This is a key step to ensure that our Constitution reflects the diversity and values of our great state. Of course, the legislation will be sent to the voters for ratification as a ballot question in 2026, and we believe this change will be considered significant as well as wildly popular amongst the public.

My name is Ronnie L. Taylor, and I serve as the Advocacy, Policy, & Partnerships Director at FreeState Justice, a nonprofit organization dedicated to addressing legal and systemic inequities affecting Maryland's LGBTQIA+ community. I am here to testify in strong support of **Senate Bill 733**, which seeks to amend the Maryland Constitution to use gender-neutral language when referring to constitutional officers.

SB0733 addresses the critical need for inclusive language in our state's foundational document. Currently, the Maryland Constitution employs gender-specific terms such as "he" when referring to constitutional officers, implicitly excluding individuals who do not identify as male. This language not only fails to represent the diversity of our state's populace but also perpetuates systemic biases against women and non-binary individuals.

The significance of this issue is underscored by the increasing representation of women in state leadership roles. As of February 2025, a record 13 women are serving as governors across the United States. However, many state constitutions, including Maryland's, continue to presume officeholders will be male, as highlighted by recent analyses. Mister Chairman and Members of the Education, Energy and the Environment Committee:

The Maryland Constitution cites seven Constitutional Officers. Those officers include: The Governor, Lieutenant Governor, Secretary of State, Attorney General, Comptroller, Treasurer and Adjutant General.

In 1982 the first woman was appointed to a Constitutional Officer position. In the 43 years since then, there has only been 14 months when there was not a female Constitutional Officer, and currently four of the seven Constitutional Officers are women.

Masculine pronouns have long been understood to encompass all people and its usage in the state constitution reflects the drafting convention at the time, but times have changed, and it is time for our constitution to reflect the roles of all people in our government. Senate Bill 733 will remove masculine pronouns as they relate to Constitutional Officers and replace those pronouns with the officer's title or gender neutral language. For example, Article II – Executive Department Section 1 currently reads: *"The executive power of the State shall be vested in a Governor, whose term of office shall commence on the third Wednesday of January next ensuing HIS election, and continue for four years until HIS successor shall have qualified..." Under Senate Bill 733, that passage will read: <i>"The executive power of the State shall be vested in a Governor, whose term of office shall commence on the third Wednesday of January next ensuing HIS election, and continue for four years until HIS successor shall have qualified..." Under Senate Bill 733, that passage will read: <i>"The executive power of the State shall be vested in a Governor, whose term of office shall commence on the third Wednesday of January next ensuing THE GOVERNOR'S election, and continue for four years until THE GOVERNOR'S successor shall have qualified..."*

Senate Bill 733 will not change current meanings in our constitution, but it will affirm the rights and equality of all people. It is time to change the outdated use of masculine pronouns to define our Constitutional Officers and so I respectfully request a favorable report on Senate Bill 733.
