The Maryland Network Against Domestic Violence (MNADV) is the state domestic violence coalition that brings together victim service providers, allied professionals and concerned individuals for the common purpose of reducing intimate partner and family violence and its harmful effects on our citizens. **MNADV urges the COMMITTEE to favorably report on HB 1547.**

House Bill 1547 would support domestic violence victims and survivors by integrating domestic violence awareness training into the licensure requirements for barbers and cosmetologists. Under HB 1547 beginning October 1, 2025, applicants and licensees must complete a one-hour training program developed by the Maryland Department of Labor. This training will cover:

- Recognizing signs of domestic violence
- Strategies for discussing concerns with clients
- Effective communication and listening techniques
- Connecting clients to appropriate resources and support groups

By educating professionals who often have close relationships with clients, the bill seeks to create additional support networks for individuals affected by domestic violence. When victims are isolated from friends and family often a person such as a hairdresser may be the only person the victim has contact with and to whom they may disclose information.

For the above stated reasons, the Maryland Network Against Domestic Violence urges a favorable report on HB 1547.

AMENDMENTS TO HB 1547 (Third Reader Bill)

AMENDMENT NO. 1:

On page 1, line 7, strike "develop and administer certain" and substitute "approve".

On page 1, in line 8, after "training", insert "programs"; in the same line, strike "includes" and substitute "address"; and in the same line, strike "guidance" and substitute "topics".

AMENDMENT NO. 2:

On page 4, strike beginning with "develop" in line 11 down through "awareness" in line 12, and substitute "APPROVE TRAINING PROGRAMS THAT AN INDIVIDUAL MAY COMPLETE TO SATISFY THE DOMESTIC VIOLENCE AWARENESS TRAINING REQUIREMENTS OF THIS TITLE".

On page 4, line 13, strike "DEVELOPED" and substitute "APPROVED".

On page 4, line 15, strike "AND" and substitute "OR".

On page 4, strike beginning with "BE" in line 24 down through "CHARGE" in line 25 and substitute "HAVE A DURATION OF AT LEAST ONE HOUR".

AMENDMENT NO. 3:

On page 8, strike beginning with "develop" in line 2 down through "awareness" in line 3, and substitute "approve training programs that an individual may complete to satisfy the domestic violence awareness training requirements of this title".

On page 8, line 4, strike "DEVELOPED" and substitute "APPROVED".

On page 8, line 6, strike "AND" and substitute "OR".

On page 8, strike beginning with "BE" in line 15 down through "CHARGE" in line 16 and substitute "HAVE A DURATION OF AT LEAST ONE HOUR".

AMENDMENT NO. 4:

On page 8, line 29, strike "October 1, 2025" and substitute "January 1, 2026".
