The Arc Maryland is the largest statewide advocacy organization dedicated to protecting and advancing the rights and quality of life of people with intellectual and developmental disabilities. We were started in the 1950s by parents who sought a better life for their children with developmental disabilities, and since that time, our network in Maryland has grown to several chapters of The Arc who provide direct services and supports to over 8,000 people with IDD and thousands more individuals who do not access our network's provider–supported services, but rely on The Arc for free information and referral services, advice, guidance, and advocacy support and training. Our connections, supports to families and people with IDD, and representations span both models of service delivery, and we advocate for the viability of all, with a lens on quality, efficiency, informed choice, modernization, and sustainability.

We support ensuring DDA's existing Waiver Advisory Council (WAC) has a **broader representation of community advocacy organizations**, like The Arc Maryland, and the responsibility to collaborate with the DDA to conduct important work with and for people with intellectual and developmental disabilities.

While the bill intentions were clear in drafting, there were necessary amendments made and approved in the House to **add The Arc Maryland and The Maryland Association of Community Services** as named statewide organizational members.

This bill is important because it **codifies and expands** the existing DDA Waiver Advisory Council to provide advice and make recommendations to DDA about system design, service delivery, and quality enhancement strategies for the

Medicaid waivers operated by the department. Additionally, it ensures the DD WAC includes representatives from the statewide organizations who have supported the DDA, have extensive experience with our state systems of support, and advocate for individuals with IDD statewide, while still maintaining the everimportant balance of people with lived experience and facilitating their active involvement in the decisions that will impact their lives.

HB 1244 outlines that the purpose of the WAC is to foster meaningful engagement and establish a feedback loop with enhanced communication for all stakeholders. It will ensure the WAC adheres to person-centered thinking, diversity, equity, and inclusion principles, and evidence-based and data-driven discussion and problem solving.

Current and future beneficiaries of the Developmental Disabilities Administration's vital community supports rely on services and supports that enable them to live, work, and thrive in their communities, regardless of the service model through which they choose to receive their supports.

Finally, it is important to note that the Fiscal Note is in need of revision now, since the bill was amended to correct a technical placement error in the House. The original fiscal note contains an inaccurate statement under additional comments, and does not include consideration of that adopted corrective amendment:

Original: Additional Comments: DDA advises that the membership of the council under the bill does not mirror the current council. DDA will have to recruit the following additional members: one additional person with lived experience participating in a DDA program and two additional family members (one with experience with self-directed services and one with traditional services). DDA will also have to remove one current coordination of community services provider and at least one current provider member to make an open seat for a representative from The Arc of Maryland. To meet the bill's requirement that the licensed or certified providers on the council include representatives from each DDA region, additional changes to current provider membership may be required.

With the House-amended language in this bill, that moves The Arc Maryland to the intended category of membership (under "statewide advocacy organization", NOT "licensed and certified provider organizational member" portion of the membership), The Arc's inclusion in the WAC will NOT be a cause for removal of a CCS and current provider member and shall not be cause to upset current WAC membership in any way.

Thank you for your consideration. We urge a favorable report on HB1244 as passed in the House.

The MCC strongly supports initiatives that enhance the quality of life, equity, and independence of individuals with disabilities, and we believe this measure is a crucial step toward achieving those goals.

The Maryland Association of Community Services (MACS) is a nonprofit association of over 125 agencies across Maryland serving people with intellectual and developmental disabilities (IDD). MACS members provide residential, day and supported employment services to thousands of Marylanders, so that they can live, work and fully participate in their communities.

MACS is in support, with an amendment, of HB 1244, which seeks to codify the Maryland Developmental Disabilities Administration Waiver Advisory Council and expand its membership. We commend Delegates Guyton and Bagnall for their initiative to formalize the council's role in advising on critical aspects of DDA waiver programs, including system design, service delivery, and quality enhancement strategies.

We are pleased to note that the bill aims to address our concerns by proposing the inclusion of MACS as a member of this council. This is a crucial step, as recent data from the Maryland Department of Health indicates that over 82% of people using DDA-funded supports choose the community provider model, with MACS members receiving over 80% of the funding allocated to community providers. Clearly, MACS represents the largest constituency of providers and beneficiaries of DDA-funded supports.

Key Points

- Inclusion of MACS: The bill's proposal to include MACS on the council
 ensures that the voices of community providers are heard. This inclusion is
 essential for balanced representation and comprehensive policymaking.
- Balanced Policymaking: The council's role in shaping Medicaid waiver
 policies is crucial. MACS's participation is essential to ensure that all
 perspectives within the IDD service delivery landscape are adequately
 represented, preventing an imbalance that favors one model over another.
- Commitment to Collaboration: We are eager to bring our extensive experience and insights to the table and work collaboratively with the Developmental Disabilities Administration and all stakeholders to enhance the quality and accessibility of services for people with developmental disabilities.

We support ensuring that the existing Waiver Advisory Council has broader representation of key stakeholder organizations. To achieve this, we propose the following amendments:

- Add The Arc Maryland and Maryland Association of Community Services (MACS) explicitly as members in section 7-12B-03.
- Enhance section 7-12B-05(A)(2) to ensure the Waiver Advisory Council provides advice and makes recommendations to DDA about service delivery and access to services, including strategies for cost efficiency, flexibility, and system modernization.
- Clarify that voting members appointed under certain sections are appointed for 2-year terms and eligible for 2 consecutive terms.

eligible for 2 consecutive terms.
In conclusion, we urge the committee to adopt these proposed amendments to strengthen the language that would include MACS as a member of the council. This will ensure that every facet of service provision is represented.

Dear Chair, Vice-Chair and Members of the Committee:

On behalf of Spectrum Support, a non-profit providing support services for people with disabilities, I am writing to express our support for SB 1027/HB 1244, which proposes the establishment of the Maryland Developmental Disabilities Administration Waiver Advisory Council. I believe that this bill represents an important step forward in ensuring that the voices of individuals with lived experience, their families, and service providers are central to shaping Medicaid waiver programs in our state.

Spectrum had a resident who has lived in one of our homes for over 20 years and is dually diagnosed, which means periodically he returns to the state institutions for a few months to get a "reset". He went to that facility in April 2024 and became eligible for release from the hospital late summer and was expected to be home in October. However, because of continuous delays with his waiver reapplication, he was given a potential discharge date of January 16th. After additional paperwork delays, he was finally released to go home on January 29, 2025.

These delays were unnecessary and burdensome and led to additional concerns, including depression and confusion. Said individual would contact Spectrum staff daily to find out when he would get out and did not understand what was keeping him or why the process was not completed sooner. Unfortunately, Spectrum did not have any answers. While this delay occurred, the State of Maryland was paying higher rates for his hospital stay, Spectrum had a vacant room in an apartment and his hospital bed could have been used for someone else.

By creating a dedicated advisory council, the bill will foster a system that is more responsive and accountable to the needs of Maryland's diverse community. The inclusion of a wide range of stakeholders—from representatives of advocacy groups and licensed providers to family members with firsthand experience—will enable the Developmental Disabilities Administration to design and deliver services that are truly person-centered. This approach not only enhances service delivery but also promotes transparency and public trust through regular, publicly accessible meetings and a structured feedback process.

For these reasons, we respectfully request your favorable vote.

Please accept the following as the written testimony of Service Coordination, Inc. regarding HB 1244 *Maryland Developmental Disabilities Administration Waiver Advisory Council Establishment*.

Introduction:

SCI is a leading non-profit organization providing award-winning case management services and advocacy for more than 16,000 individuals with disabilities and medically complex needs across Maryland through our Coordination of Community Services and Supports Planning Programs. SCI's mission is to help people with intellectual and developmental disabilities understand their choices and create pathways to community resources that respect their dignity and rights. SCI employs over 1,000 team members across the state of Maryland, a majority of whom are Coordinators of Community Services (CCS) and Supports Planning Services (SPS) professionals.

SCI provides services to 12,000 of the approximately 19,000 people in the state of Maryland who currently receive case management services through funding from the Developmental Disabilities Administration (DDA). We are the largest nonprofit case management organization in the state, and we organize and chair a Coordination of Community Services (CCS) Community of Practice (CCS CoP) comprised of a majority of CCS providers across the state.

As mandated by COMAR 10.09.48, SCI provides core services to individuals with intellectual and developmental disabilities to include comprehensive assessments, development of person-centered plans, referral and related activities, as well as monitoring and follow up. This is accomplished through case management, person-centered planning, and the coordination of comprehensive services related to housing, employment, relationships, financial management, health monitoring, and recreation. Case managers often serve as the initial contact for people seeking services, providing crucial guidance throughout the complex application and eligibility determination and redetermination processes. Case managers assist people in understanding the criteria and requirements, help them gather the necessary documentation and submit the eligibility recommendation. Case managers engage with people and their families to explore their unique wants and needs, facilitating the development of a person-centered plan that reflects the person's preferences and goals. They play a pivotal role in connecting people to essential supports and services,

addressing various aspects of the person's life and promoting overall well-being. After services are initiated, case managers continue to monitor the delivery of those services to ensure they align with the person-centered plan. They advocate for the person's preferences and needs, addressing any issues that arise.

SCI's Recommendations to Strengthen the Waiver Advisory Council:

Waiver Advisory Council members advise and provide recommendations to the Developmental Disabilities Administration (DDA) on system design, service delivery, and quality enhancement strategies for the Medicaid waiver programs. SCI agrees that improved collaboration among ID/DD providers and the Maryland Department of Health is critical and especially, given the proposed DDA budget cuts and coordination that will be required for effective implementation of associated cost containment measures.

Please accept the following as the written testimony of Service Coordination, Inc. regarding HB 1244 *Maryland Developmental Disabilities Administration Waiver Advisory Council Establishment*.

Introduction:

SCI is a leading non-profit organization providing award-winning case management services and advocacy for more than 16,000 individuals with disabilities and medically complex needs across Maryland through our Coordination of Community Services and Supports Planning Programs. SCI's mission is to help people with intellectual and developmental disabilities understand their choices and create pathways to community resources that respect their dignity and rights. SCI employs over 1,000 team members across the state of Maryland, a majority of whom are Coordinators of Community Services (CCS) and Supports Planning Services (SPS) professionals.

SCI provides services to 12,000 of the approximately 19,000 people in the state of Maryland who currently receive case management services through funding from the Developmental Disabilities Administration (DDA). We are the largest nonprofit case management organization in the state, and we organize and chair a Coordination of Community Services (CCS) Community of Practice (CCS CoP) comprised of a majority of CCS providers across the state.

As mandated by COMAR 10.09.48, SCI provides core services to individuals with intellectual and developmental disabilities to include comprehensive assessments, development of person-centered plans, referral and related activities, as well as monitoring and follow up. This is accomplished through case management, person-centered planning, and the coordination of comprehensive services related to housing, employment, relationships, financial management, health monitoring, and recreation. Case managers often serve as the initial contact for people seeking services, providing crucial guidance throughout the complex application and eligibility determination and redetermination processes. Case managers assist people in understanding the criteria and requirements, help them gather the necessary documentation and submit the eligibility recommendation. Case managers engage with people and their families to explore their unique wants and needs, facilitating the development of a person-centered plan that reflects the person's preferences and goals. They play a pivotal role in connecting people to essential supports and services,

Dear Chair Beidle and Committee Members:

The Maryland Department of Health (MDH) respectfully submits this letter of information for House Bill (HB) 1244 - Maryland Developmental Disabilities Administration Waiver Advisory Council - Establishment. HB 1244 would partially codify the existing Waiver Advisory Council within the MDH Developmental Disabilities Administration (DDA).¹

The DDA established its Waiver Advisory Council in October 2024 with the goal of creating a forum where individuals with lived experiences—primarily individuals receiving Medicaid waiver services operated by the DDA—could provide direct input for the design and implementation of Medicaid waiver services. To this end, the DDA's Waiver Advisory Council is designed to feature a majority of members with lived experiences. Additionally, the DDA sought to design its Waiver Advisory Council to mirror the composition and values underlying the future Medicaid Advisory Council and Beneficiary Advisory Council, which are required to be established under the new federal Ensuring Access to Medicaid Services Final Rule (Access Rule).²

Further, the DDA sought to align the practices and focus of the DDA's Waiver Advisory Council (previously as the Quality Advisory Council) with existing Waiver Advisory Councils that support other Medicaid waiver programs in Maryland. No other Waiver Advisory Council in the state is presently codified in state law, as the Department seeks to operate all of its Waiver Advisory Councils in alignment with federal requirements and assurances.

Finally, the DDA sought to emphasize input from organizations and individuals who do not have

existing pathways to advocacy within the state. In particular, the current Council includes two seats for member organizations of the Maryland Association of Community Services but does not require that the persons holding these seats directly represent the broader association. Additionally, the current Council does not reserve a seat for The Arc Maryland, giving all provider organizations within the state equal consideration.

While HB 1244 bears numerous similarities to the current Waiver Advisory Council Charter,³ MDH wishes to note that the proposed changes in the Council's membership would result in several current members being removed from the Council. First, the number of seats for Coordination of Community Services providers is reduced from two to one, requiring that either Teresa Michelle Titus-Howard of The Coordinating Center or Caitlin Bishop of Worcester County Health Department is removed from the Council. Second, at least one provider member would be removed to open a seat for The Arc of Maryland, requiring that Karen Lee of SEEC or Matthew Ramsey of Target be removed from the Council. Finally, either Rob Baynard of Opportunities, Inc. or Najla Wortham of Rock Creek Foundation would be required to dually represent both the Maryland Association of Community Services and their own provider organization.
